MINUTES OF THE FIFTY-SIXTH ANNUAL MEETING of the CONVOCATION OF THE MISSIONARY DISTRICT OF HONOLULU

Monday, February 10, 1958

The 56th Annual Convocation of the Missionary District of Honolulu opened with the Administration of the Holy Communion at 3:00 a.m. in Parke Chapel (St. Andrew's), Honolulu, Monday, February 10, 1958, with the Bishop of the District, the Right Reverend Harry Sherbourne Kennedy, D.D., as celebrant, assisted by the Very Rev. James S. Cox, the Ven. Norman R. Alter, the Rev. Messrs: George Hayashi and John J. Morrett. Breakfast followed at St. Peter's Parish Hall.

The business meeting of Convocation met in Tenney Memorial Hall. The Bishop presided as President, delivered the Invocation, and called the Convocation to order at 9:30 a.m.

The Rev. Canon Wai On Shim was appointed Secretary Pro Tempore, and read the Roll Call of clergy canonically resident in the Missionary District. Roll Call of the Lay Delegates was read by the Rev. E. Lani Hanchett.

The President declared a quorum present; the rolls revealed that every mission and parish had delegates present.

The Ven. Norman R. Alter moved that the Rev. Canon Wai On Shim be nominated as Secretary of the 56th Annual Convocation of the Missionary District of Honolulu, and that a white ballot be cast in his favor. Motion was seconded and passed.

The Rev. Mr. Baker brought special greetings from Guam. Guam is situated 3,300 miles from Honolulu; it is the largest of the Mariana Islands. It has a growing population of 70,000, half of which are natives, the rest are Philippine nationals, military and civil employees. The military includes Air Force and Navy.

The Roman Catholic Church is the strongest religious organization among the natives, and Guam has a situation quite similar to that experienced in Central and South America.

The Episcopal Church now owns a 7 1/2-acre area located on a cliff, a very scenic setting.

The Rev. Mr. Baker is the first resident missionary priest of the Church. Before his arrival, services were conducted by the Bishop on his visitations to the far Pacific and Episcopal Chaplains.

On four different occasions the Church has endeavored to secure land and become established. Early in January this fact (or feat) was accomplished.

St. John the Divine Mission was admitted with a burst of applause and a standing welcome.

The Rev. Burton Linscott, Chairman of the Committee of Necrology, offered the following:

Mr. Arthur G. Smith, Chancellor and member of the Committee on Legislation, presented twelve resolutions. Before these were read, Dean Cox read the Statutes and By-Laws of St. Andrew's Cathedral Chapter. Mr. Smith directed attention to the broad powers of the Church, the duties and powers of the presiding officers, the Board of Directors, and the appointed officers. He also called attention to the rules governing the transfer of property. Following the reading, it was moved by Mr. Smith, seconded by Dr. Pekelo, and passed that the Charter, Statutes and By-Laws be approved. Dean Cox stated that all matters had been discussed by both congregations, and that the adoption of these instruments brings the two congregations under single administration.

The Rev. Dr. Nishi suggested that the word "ritual", line 4, Section 1, Article V of the Statutes, be changed to "ceremonial". This change was accepted.

Mr. Samuel Lee proposed a change be made in Article II of the Statutes; that in line 4 the sentence be changed to read "The Treasurer may be an individual, a corporation, or partnership." This change was regarded as an improvement, and accepted. (See attached copies)

With the inclusion of the foregoing changes, it was again moved by Mr. Smith, seconded by Dr. Pekelo, that the Statutes and By-Laws be accepted. Motion carried without exceptions.

It was moved by the Rev. Mr. Jones that an expression of appreciation be given Dean Cox and Canon Van Culin for their great work in the preparation of the instruments. Motion was seconded and approved.

Mr. Smith then explained that it would be necessary to repeal existing statutes for the Cathedral Church of St. Andrewin order for the new laws to take effect, and so moved. Motion was seconded and carried.

The President expressed appreciation for the foregoing work, and Convocation delegates concurred with a round of applause.

Report of the Committee on Nominations and Elections was given by The Rev. John J. Morrett, Chairman, as follows:

After some discussion, it was moved by the Reverend Mr. Grosh, seconded by Mr. Henry Hughes, that the existing board be nominated for the year 1958, and that invitation for further nominations from the floor be made by the presiding officer of the Convocation. Motion was carried.

The Rev. Mr. Grosh moved, seconded by Mr. Henry Hughes, that the Chancellor, Mr. Arthur Smith, be nominated as our Lay Delegate to General Convention, and that the Rev. Canon Paul R. Savanack be nominated as our Clerical Delegate. The Very Rev. James Cox and Mr. James Kau were also included in the motion as alternate delegates. Motion was carried.

It was felt that due to the expense of travel, and the limited budget of the Diocese, that the Bishop could economize and select a clerical or lay delegate, who would be on the mainland during a furlough or on business, for the Annual Synod Meeting. This is the Committee's recommendation.

There being no further business, the meeting was adjourned at 3:30 p.m.

It was moved by the Rev. Mr. Grosh, seconded by Mr. Hughes, and passed that nominations for the Board of Directors be approved.

It was moved by Canon Van Culin, nominations for delegates to General Convention be approved. Motion was seconded and passed.

It was moved by the Rev. Mr. Morrett that the Bishop be authorized to appoint delegates to the Synod of the Province of the Pacific, May 6-8, at Reno, Nevada. Motion was seconded by the Rev. Paul Wheeler, and motion carried.

The next item of business concerned fixing a date for next Convocation. The business meeting for this will be held February 8, 1959.

Dean Cox asked for the floor; then followed a surprise presentation. A check in the amount of \$3,000 from every mission and parish in his jurisdiction, including Airaku-en, Okinawa, was presented to Bishop Kennedy to help pay his expenses to the Lambeth Conference in England this summer. The Dean echoed the sentiment of all delegates when he said this was a small token of affection and devotion -- this was given in order that the Bishop could arrive at the Conference on time and in good condition.

The Bishop expressed great appreciation for this gift, and this was followed by a ten-minute recess and coffee break.

Business resumed at 11:00 a.m. with the report by the Treasurer, Mr. Henry F. Budd. Mr. Budd said that operational changes had been made in the handling of trust endowments with the Hawaiian Trust Company acting as custodian. Change was made on recommendation of the Investment Committee, Mr. Herman Von Holt, Chairman. Trust endowments netted an increase of \$72,000. Lands and buildings total approximately \$3,000,000. Expenditures from National Council totalled \$114,465.30, a decrease of \$4,000 compared to 1956. Local missions paid \$38,000 for salaries in 1957. Combined assessments totalled \$35,715. It was moved, seconded and passed that the Treasurer's report be received with appreciation and approved as read.

The Treasurer moved that the pledge of \$8,000 to the General Church Program be accepted. Motion was seconded and approved. Mention was made that the Missionary District is 85 per cent self-supporting. The Bishop expressed appreciation for this support.

Sister Evelyn Ancilla, C. T., Sister Superior of St. Andrew's Priory, reported on that institution. In addition to the narrative report, a financial report was included. Attention was directed to the increased enrollment. There is a waiting list for every grade. The Priory has waited some sixteen or seventeen years to realize an adequate science building, and with this addition now has facilities second to none on the Island for secondary schools. Sister Evelyn stressed the importance of securing and keeping capable teachers. Budget-wise it might seem that no little Christian philosophy is necessary in order to meet increasing costs.

Mr. James Taylor, Headmaster of the Hawaii Preparatory Academy, Kamuela, was the next speaker. As his written report revealed, purchase of a beautiful tract of land for the school has been made. With regard to new buildings, it is hoped the first increment will be ready by fall. Enrollment for next year will not exceed the present enrollment, or, until more space is available. New boys will, naturally, be enrolled, but numbers will be decided during the spring and summer months. The present ratio of 12 to 15 per class will prevail. Teachers' salaries will be the heaviest part of the budget. Mr. Taylor spoke of the trend against adjustment courses, and of mass conformity.

With the change of name, the Academy is still an Episcopal school -- there are daily chapel services.

Mrs. Spencer, who has attended twenty-eight Convocations, was introduced to members of Convocation.

Inasmuch as Canon McDonald was not in the city, only the printed report on Iolani School was furnished.

Mr. Herman V. Von Holt, Secretary of the Board of Directors, gave the report for the Board. (See page 51)

Mr. Von Holt stated that he wished to add a supplementary word on the Treasurer's report concerning the Investment Committee.

Mr. Von Holt has been handling trust endowments and trust investments since 1932, and felt these matters should be put on a more permanent basis. The Hawaiian Trust Company was appointed Custodian. Mr. Von Holt said he was very satisfied with this arrangement, and happy it has taken place -- now we have the assistance of experts of the Trust Company, and he is sure they will handle matters so that progress in investments can continue from year to year.

Earnings on investments this past year amount to 7.93 per cent.

Mr. Von Holt received a rising vote of thanks for his work.

The report of the Laymen's League was given by Mr. K. L. Ching, Secretary. (See page 47)

The President thanked Mr. Ching for his report and stated that the Laymen's League had taken on new life under his direction.

The Rev. Richard A. Kirchhoffer spoke about the Lenten Project. This centers in the Forward Day-By-Day booklets and in daily Bible reading. Educationally, it is believed this plan will be interesting; criticism is solicited. Churches are asked to notify the Diocesan Office of their needs. Mr. Kirchhoffer stated that nothing can make a greater difference in the lives of Church families than planned Bible study and prayer. Several thousand copies of the booklets are available.

Noon Day prayers were offered by the Rev. Mr. Kirchhoffer.

The Bishop gave the benediction, and meeting adjourned at 12:20 p.m.

Immediately following, delegates to Convocation and friends gathered on the Cathedral grounds for the Laying of the Cornerstone of St. Andrew's Cathedral Extension.

56th CONVOCATION

Brethren of the Clergy and Laity of the Episcopal Church in Hawaii:

As we stand, I bid your prayers for those of the Church Militant who have been gathered unto our fathers since our last Convocation.

Particularly I commend into the hands of our Merciful Savior the souls of his servants, the Bishops of the Church, a Priest, and a Lay Worker of this Diocese who have departed this life. At the close of this service we shall remember the faith-ful departed from our parishes and missions.

I hope that each of you will carry away in your experiences at this Convocation such inspiration that you will be moved to take back to your respective congregations information concerning the life and work of our Church in Hawaii, and an understanding of the problems, the hopes and the aspirations of our Church.

Their interest in our work, and their willingness to assist where needed, know no bounds. We have been greatly blessed to have them in our midst, and thank them for coming to us. I also wish to welcome the Rt. Rev. Theodore R. Ludlow, Retired Suffragan Bishop of Newark, and Padre W. V. Scott, of the Royal Air Force on Christmas Island.

During the year we transferred to other jurisdictions the Rev. Samuel McCain to New Hampshire; The Rev. Gerald G. Gifford to Southern Ohio. We have added to our list of non-parochial clergy, the Rev. Mellick Belshaw in New York, the Rev. Harvey Buxton in England, the Rev. Chester G. Minton in Indianapolis.

Deaconess Sarah Swinburne is serving faithfully at St. Matthew's Mission, Waimanalo.

We have nine men preparing for the ministry in our seminaries, and three looking forward to entering seminary in the near future. This is the largest number of postulants and candidates for Holy Orders in the history of our Diocese.

We are ever grateful to our seventy lay readers throughout our Islands. Many serve faithfully every Sunday and others stand by ready to take services when there are vacancies, or when our clergy are ill. I wish to express my thanks to these unsung heroes of our Churches' life.

This year I commend to every congregation a program of special Missionary Endeavor. The Bishop will prepare a list of missionary needs, opportunities, and appeals from our work in Hawaii, the Pacific and the world.

Every congregation, large or small, strong or weak in numbers or finances, will be expected to participate. The plan may be support of an individual missionary, it may be a great need in some mission; it may cost something, it may cost nothing. But if each congregation will adopt a missionary or a mission, even if it only means corresponding with them to let them know we are interested and concerned about their work, we will be getting interests outside of ourselves. We have a weakness to become ingrown. Our own needs loom so large that we cannot see beyond our own boundaries. An ingrown, self-centered congregation soon sickens and dies. Let us all share in a 1958 Adoption Plan, for the good of our own souls, and for the Glory of God.

FINANCES

I congratulate all our parishes and missions since all have paid in full their assessments for 1957.

We received from National Council \$114,000 to pay missionary salaries and to help with the operating expenses of our Diocese.

Special gifts from National Council for building purposes amounted to \$61,000, and loans granted amounted to \$60,000.

During the past year \$98,686.51 was paid on building debts. The total building indebtedness is \$316,908.

Lack of any Diocesan funds for advance work hampers our progress. Through assessments we receive barely enough to meet our current operating expenses.

We should all be grateful to our Diocesan Treasurer, Mr. Henry Budd, for the efficient and accurate handling of our accounts.

Building Fund Campaigns were held in five of our congregations: St. Andrew's Cathedral, \$415,000; Holy Nativity, \$130,000; Calvary, \$21,000; St. Elizabeth's, \$61,500; St. Peter's, \$68,000; or a total of close to \$700,000.

There is one debt the Diocese will never be able to pay, and it keeps increasing rather than decreasing. It is a debt of gratitude to our Chancellor, Mr. Arthur G. Smith. If he should ever send us a bill for services rendered, the Diocese would have to go into bankruptcy. The hours of devoted service to the Church in Hawaii, his wise counsel in all legal matters, and his encouraging support of the Bishop and the Missionary Program of our Diocese, have been of such inestimable value that we all would join in a hearty prayer of thanksgiving for his life of service to his Church.

GIFTS AND BEQUESTS

It is well for us to remember that we hold things only for a brief passing time, and the things we hold came from God, their source, and return to Him. We are never owners of our possessions in a final sense, for whether we like it or not, things pass through our fingers. We can't take it with us, but we might see it working for God in this world now if we are willing to invest it in His Church. Consecrated Christians will consecrate their wealth, whether it be large in amount or a simple widow's mite. They do not consider that they "give" but only that they "return" to God all they can, in worldly goods, in love and in service.

During the past year the Diocese received several gifts through bequests of those who have remembered the Church in death. These gifts have helped new missions, aided young men preparing for the ministry and helped advance our work in Hawaii. Every one of us should remember our Church in our wills. The amount is not important, it may be small or large. The fact that we are helping God's Kingdom advance even after we are gone is important.

We hope that others from time to time would make similar gifts while still living, for the Church urgently needs such gifts if we are to keep our Church strong in a world where our enemies are sowing seeds of hate and destruction.

Our Diocese has no source of income to aid new work, to help small missions, to buy land, to build chapels, to equip our buildings, and to aid our clergy. Only the gifts of our people make these things possible.

STATISTICS

Reading statistics is a necessary evil in all annual reports. It is required by Canon, so it must be done tonight. In our Diocese the 1957 reports reveal the following facts:

Number of Baptized Persons -- 16, 733

Number of Communicants -- 10,717

Number of Clergy -- 36 active in Hawaii, 10 in Okinawa, Taiwan and Guam, 4 retired, 10 non-parochial, and 4 licensed

Number of vehicles -- 42

Number of Church School Children -- 6532

Number of Lay Readers -- 70

Number of Ordinations -- 4

There were 899 Baptisms and 792 Confirmations in Hawaii.

In Okinawa we had 95 Confirmations; Formosa, 110; Guam, 7; Korea and Japan, 16.

BUILDING

The largest Diocesan building project ever undertaken in the history of our Church in Hawaii is the completion of St. Andrew's Cathedral at a cost of over \$400,000. We are all indebted to Dean Cox, Canon Van Culin, Mrs. Mark Robinson, Mr. Harold Dahlquist and Mr. Geofrey Davies, who planned and worked so diligently to make this campaign a success. The construction should be completed by June 1.

- St. Andrew's Priory dedicated a new classroom and laboratory building built at the cost of approximately \$100,000.
- St. Christopher's has enlarged its Church and erected a beautiful Educational Building at a cost of \$89,000.
 - St. Philip's, Maile, erected a temporary Chapel at a cost of \$10,000.
 - St. Peter's has purchased a new pipe organ at a cost of \$23,500.
 - St. Elizabeth's is completing a new rectory and Educational Building.

Further details on gifts, memorials, and equipment will be presented in the report of the Committee on Missions and Church Extension.

LAYMEN'S LEAGUE

There has been a revival of enthusiasm in the laymen's work in the Diocese under the leadership of Mr. K. L. Ching. Through the laymen's offering for Mokuleia Conference Center, and gifts from trusts and friends, \$8,235 was raised in 1957 to help liquidate the building debt. The balance of the debt is \$6,500. I commend the Washington's Birthday Offering to all our men, and urge the clergy in each congregation to support this endeavor with an interest that will enable their key men to reach every man in their congregation. It can only be successful if clergy and key men work together.

The Washington's Birthday Corporate Communion for Laymen has become an annual endeavor in Hawaii, as it has been throughout the whole Church for many years. Each island should plan the observance of having this Laymen's Service.

WOMAN'S AUXILIARY

The Diocese is always grateful for the program of our Woman's Auxiliary and we thank our Diocesan President, Mrs. Barbara Goss, her executive board, and each branch president for the leadership they have given our women's work. I am, however, often distressed that more women are not active in the Woman's Auxiliary program at the grassroots of our Church life. A small handful of faithful attendants at monthly meetings is an indication that something is lacking in our appeal. I read in the newspapers of many Episcopalian women, active in community and social affairs, who are not participating in any Church activities. We should reach out and bring them in with a Church program that challenges any secular program.

Unfortunately, some of our women, and not too infrequently the clergy, look upon the Woman's Auxiliary as an organization to raise money to pay bills. Let us take a "New Look" at our 1958 Woman's Auxiliary program in every congregation, both large and small.

YOUTH

Work with youth has its ups and downs. The numbers seem to change periodically as different groups come and go. With the new organization and program, there is every indication that new enthusiasm will manifest itself this year. A congregation without a Church School and Youth Organization is coasting on thin ice, since they are not building for the future life of the Church.

Our Church Schools must have the best material and the ablest teachers available. The home, unfortunately, has ceased to be a place where children receive Christian instruction, and public schools are not permitted to teach religion. We must make the best of the brief time we have our children in Church to give them the foundation on which they must build their lives.

CLUETT HOUSE AND ARMED FORCES CENTER

Cluett House and our Armed Forces Center continue to fill a need in our Church's life. We are grateful to Mrs. Kastenbein and Mrs. Aaron for their unselfish service in the administration of these Diocesan institutions.

CLERGY

I am ever grateful to the Clergy of our Diocese. A Bishop must count on the loyalty of his workers. They have supported all our programs in the Diocese and the General Church, and have carried on their own parochial work diligently, even though under some circumstances it has been difficult and often discouraging. The

whole Diocese should rejoice with me in the quality of our clergy and their example of devotion to Christ and His Church.

STEP FORWARD

One of the most historic and significant steps taken in the life of the Episcopal Church in Hawaii is the merger of the two congregations of St. Andrew's Cathedral. At this Convocation we will be given an opportunity to approve the new statutes creating a Cathedral Chapter composed of representatives of both congregations. This will make for one administration, cutting down expenses and consolidating our strength in one Chapter, instead of two vestries. Services will be conducted as in the past.

We pray that the Holy Spirit will guide us all as this step of reorganization is taken and that God will abundantly bless our undertaking, that in all things we may do His will.

NEW MISSIONS

We will receive petitions from three new congregations, at this Convocation, to become organized Missions of our Diocese. They are St. Barnabas, Ewa Beach, Oahu, under leadership of the Rev. Arthur Ward; St. John the Divine on Guam, with the Rev. Richard Baker in charge; and St. Alban's Chapel, Iolani School, under the ministration of the Rev. Dr. Shunji F. Nishi. We rejoice and welcome them with thanks to Almighty God for letting us share in these new works established in His name.

We have need to purchase land and build in Waialae-Kahala, Portlock, Ewa Beach and Waikiki.

Funds must be made available to build more missionary residences in Emma Square, to erect buildings at Mokuleia, Camp Pecusa, and Canterbury House. Extensive repairs are needed in the Diocesan House and Diocesan offices.

SCHOOLS

Iolani School has a record enrollment of 930. A campaign for funds to build a cafeteria and student union building has been successful. Building plans are under way for construction to start this year.

St. Andrew's Priory dedicated a new classroom and laboratory building. The enrollment reached 533, the largest in the history of the school. Lack of facilities prevents even greater growth.

Hawaii Episcopal Academy incorporated and changed the name of the school to Hawaii Preparatory Academy. The purpose of this change was to enable trusts and others to make contributions to the school which they were unable to do otherwise.

The Academy purchased 55 acres in Kamuela from the Territory, and raised \$131,190 in gifts for their Building Fund, and have accepted all indebtedness on the school. Plans for the building of the new school are in the hands of the architect. It is hoped that the first units will be ready by September. Present enrollment is 84 students.

Day schools and kindergartens are sponsored by St. Andrew's Cathedral, St. Christopher's, Epiphany, St. Elizabeth's, Holy Trinity, St. Clement's, St. Mark's, Holy Nativity, and Good Samaritan. These schools make a great contribution to the Church in Hawaii by ministering to our children, and as Bishop, I wish to thank the

clergy, vestries and Bishop's Committees who keep these schools functioning in the name of our Church.

Great stress is being made by our government on training scientists. This may be necessary in a world like ours of great scientific progress. However, we must also train the hearts and souls of our people to learn to use the great forces given into our hands by science for the well-being of all people. Church Schools are more and more important in the training of our youth, where religion is taught as a part of their everyday living.

OBJECTIVES - 1958

- l. Reinvigorate the Woman's work by enlisting more women in the Auxiliary Program and providing for more active participation in all fields of service.
- 2. Adoption plan for missions. Every congregation to accept some missionary or some missionary field or missionary project outside its own program. Getting acquainted with the needs and problems of missions and missionaries throughout the world.
- 3. Diocesan goal to attain 1,000 confirmations for the year 1958. This means a 25 per cent increase of confirmations in all congregations.
- 4. Begin a four-year program in all missions, working toward their self-support in 1961.
- 5. Stimulate the spiritual life of our people during the Lenten Season, special emphasis upon every clergyman, every individual and every family using the Lenten Forward Day-by-Day booklet and the suggested plan for its use.

I close upon the note of gratitude to God that He has called me to live and work among you. It is impossible for me to express adequately my gratitude to so many of you as I would like to do, for the warm friendship and fellowship in the Gospel that you are giving. May God bless and strengthen us all in the fellowship of faith that we have in Him through Jesus Christ our Lord.

GRADUATES - 1957

On June 4, 1957, the Priory graduated 41 girls. Of these, 36 are furthering their education in college, nurses' training or business school. Two are employed locally, one has married, and we have no information about the remaining two.

It is the policy of the Priory to try to develop in its students a strong sense of community and community obligation. To this end the girls are encouraged to take part in a variety of Church, Community and School service projects. The following are some of the activities in which the students participated.

Through the courtesy of Mr. Manuel Kwan, principal, both the May Day and Christmas programs were held at Central Intermediate School for the students of both the schools. The assistance rendered by the faculty and boys of "Central" greatly lightened the work for the Priory and a very good relationship has been established between the two schools.

Priory facilities continued to be used for some of the Cathedral Sunday School classes.

Four girls from the University of Hawaii Teachers' College have done their Observation-Participation work in our elementary grades.

RELIGIOUS EDUCATION DEPARTMENT

At the Priory a consistent effort is made to present the entire curriculum within a Christian context, but it is in the Religious Education Department that the vital teachings of the faith are given to the students at their varying age levels. Both Mrs. Kenneth H. Day and Sister Hilda Havens of the Church Army who joined the faculty in October are assisting the Sisters and the Chaplain in this department.

Of the entire enrollment, 62 per cent have been baptized and 32 per cent confirmed. This percentage varies little over the years, and it may be that it is all that can be expected. However, we continue to feel that there is a great area of missionary work still to be tackled in our school when we are graduating a class in which ten or eleven in a class of fifty-three are still uncommitted to any religious faith.

GUIDANCE DEPARTMENT

This department has become a very important part of the whole school, supplementing the religious education, the classroom teaching, and coordinating the extracurricular activities. The student body has great confidence in the Guidance Office, and both parents and teachers are beginning to make greater use of it. It is our plan to add to the services it already gives by providing the opportunity for individual psychological testing.

IMPROVEMENTS

Our new classroom and science building was dedicated on September 5, and given the name ASCENSION HALL to commemorate the founding of the school on Ascension Day, 1867. The four classrooms on the second floor were ready for occupancy at that time but the completion of the two laboratories and lecture room was postponed until the latter part of the year. These will be ready for use for the second semester of this current school year.

During the fall we increased our indebtedness to the Diocese for this new unit from \$36, 450 as noted in our financial report to \$51, 450. By December 31 this had been reduced to \$33, 781.67. In addition to this we still owe another \$5,000 on work done on the interior of the laboratories as well as \$3,000 for equipment.

Our Parent-Teacher Fellowship undertook the entire expense of covering the library floor with cork tile, adding to the appearance of that area as well as promoting the quiet atmosphere a school library should have.

BENEFACTORS

This year our benefactors are too numerous to mention by name. To the 225 families of the school, the groups and individuals who contributed to the building and equipment funds, to the Parent-Teacher Fellowship, and the Associates of the Transfiguration, we express our appreciation and gratitude. Our benefactors are continually remembered in both the school prayer and in the Sisters' devotions.

CURRENT NEEDS

Obviously our most pressing need is to pay off the debt incurred for our new building. The chief method of doing this is by the increase in tuition effective in this current school year.

Our present salary scale is too far below the level current in the Territory, and we cannot postpone an increase any longer without serious detriment to the teaching standards of the school. Therefore it will be necessary to raise the tuition again for the school year 1958-59.

To meet the persistent demand that we open a pre-school department, we are planning to start a kindergarten in the coming school year. Suitable equipment for this will be an immediate necessity.

ACKNOWLEDGMENTS

To the Bishop, Diocesan office workers, Cathedral clergy and office staff, and those who share in our life of work and service at the Priory, we express our deep appreciation for all their assistance and encouragement, and our gratitude that along with them our "lot has fallen to us in a fair ground".

REPORT OF THE HAWAII PREPARATORY ACADEMY

GENERAL STATEMENT

As most of the Convocation will have read in the papers during the past few months, the Academy is moving rapidly forward in its plans for a new physical plant on a new site. The land has been purchased by our new non-profit corporation, detailed studies have been made and are being made, and Mr. Vladimir Ossipoff, the architect, is hard at work, having only recently returned to Honolulu from a two-day visit at the school. It is the hope of the corporation to be building by late winter or early spring with September as our aim for the first increment of buildings. In the meantime, a splendid year has been in progress, and serious and rewarding interest continues in what we are doing at the Academy.

ENROLLMENT AND ADMISSIONS

Our total student enrollment this year is eighty-five, with seventy boarding students and fifteen day students. We had to add cubbyholes here and there to our dormitory in order to take on the extra ten boys to increase our boarding capacity from sixty to seventy. During the coming school year we plan to keep the enrollment at the same numbers as we cannot tell at this time whether we can be ready without question for additional numbers by the beginning of the school year. Rather than find ourselves embarrassed by having taken on more than we can handle, we prefer to retain the status quo even though it means turning down a number of boys whom we would like to have. We shall add new boys, of course, but only up to our present capacity.

WOMAN'S AUXILIARIES

Miss Dorothy Stabler of the National Council has been of tremendous help in contacting various auxiliaries around the country. We have received most generous gifts toward our housekeeping supply problem from these groups and are as grateful as can be.

SCHOLASTIC AIMS

Amid all the worry and talkabout a proper education in our times, the Academy continues to believe in hard, demanding subjects and in challenging its students. Our minimum requirement has been and continues to be of a sort to insure each student's having taken all courses required by the most demanding colleges. Every student must have a minimum of three years of high school level mathematics and may have more if he wishes. He must have at least one of the major sciences, and most of our boys take all three. In languages, history, and English, too, each boy receives his full, demanding quota.

CONCLUSION

Our thanks again to all of our wonderful friends and to the tremendous help of the Church and clergy! In that connection, we continue to be an Episcopal school, whatever the technicalities of corporation. I might add that our chapel services and religious education classes are in most capable hands. The Reverend George Hayashi is doing a fine job.

RECTOR'S REPORT - IOLANI SCHOOL

Almost twenty-five years ago our School was first visited by a Presiding Bishop of the Episcopal Church. When The Most Reverend James DeWolfe Perry went to the Nuuanu Campus on March 2, 1933, the following definition of Iolani School was given him by the Headmaster, The Reverend Albert H. Stone. "Iolani School is a Church School for boys founded and operated by the Episcopal Church for the purpose of ministering in the fullest measure to the spiritual, intellectual and physical life of its pupils, and of developing in them to the highest possible degree the religious and moral aspects of life to the end that they may sense the highest aims of the Church and of society." This is a good appraisal of our mission, and one which in 1957-58 we are still attempting to achieve.

1956-57: This past year is certainly the best year the School has had on its Ala Wai campus. The faculty was very much strengthened. The standards for scholastic achievement were raised. The posture of the school in behavior and citizenship was very much improved. New resources for helping students of normal intelligence, but with teen-age bewilderments, have been uncovered and used. The School achieved well in the Interscholastic League program, holding the spot immediately below the champions in football, baseball, and rowing. The attractive new kindergarten-first grade unit has been added to our permanent building plan. The plants around the campus rise in size and begin to disclose the appealing beauty which should mark our grounds with the arrival of 1962, when we observe our 100th anniversary.

BUILDING PROGRAM

A year ago we set a drive for \$296,000 to erect our Primary Building, the new Student Center, and to wipe out our indebtedness. A little better than \$205,000 has been secured in cash and pledges. We must particularly commend Mr. George W. Sumner, Mr. Ben Dillingham of the Board of Governors, and Mr. Jen Fui Moo, devoted parent, who led in this effort for which a great number should be complimented. We have included the new "Pre-fab" home of The Reverend Arthur B. Ward family in this drive. Father Ward's congregation in Wisconsin contributed one-half of the house cost out of affection for a clerical family they had valued so much. We have now about \$130,000 for the Student Center in cash and pledges, but need an additional \$45,000 before we can begin. I am encouraged by the zeal shown by Mr. James Nishiki in trying to secure this amount. A carnival set for this year should be a further support for this fund. Mr. Ralph Rogers is the Carnival chairman.

The Student Center is desperately needed. With our enlarged enrollment the decrepit cafeteria building has become almost intolerable. Mrs. William Eng, cafeteria manager, fights a brave battle to get all who desire lunch processed in the brief lunch period, and maintain the standards required by the Board of Health. When freed, we can use the old building as a study hall, and for a small sum, convert the study hall into three badly needed classrooms.

OUR MISSION

Although we are the largest of the boys' schools belonging to the Episcopal Church in the United States, numbers cannot be the measure of our success. I think of a last year's graduate, described as having the keenest and most original mind in his class, who now, in one of the finest colleges in the country, is giving serious thought to the ministry. I think of able boys at Harvard, Johns Hopkins, California, Kenyon, and other schools (78 of our 82 seniors have been accepted in other institutions by June of this year) and I realize that we have prepared them for their next step where in wholesome conditions they may continue their growth in education and responsible citizenship. I think of fine boys who have asked for baptism and confirmation that their citizenship in His Kingdom may be sure. Iolani School is witnessing to its role as described in the statement at the opening of this report, but only imperfectly. Determination to improve the academic and extra-curricular life of boys in the school must be steady and unrelenting. That grace may more plainly mark our Christian fellowship and witness must be the constant prayer.

DIOCESAN HOUSE - ARMY-NAVY SERVICE CENTER

Another year has rolled around in the Diocesan House, and the Service Center is still flourishing. In fact, I believe more young men have stayed here than in the previous years. The Center has been full every weekend, and we have had more men coming in during the week, and on 10- and 15-day leaves. Approximately 1,400 men stayed here during the year, from one night to one month. At Christmas, the young men staying at The Center cooked most of their meals, including Christmas dinner, which seemed to give them great pleasure.

A good many cards and letters were received from men now out of the service, saying how much the Diocesan House meant to them and what an influence it had had on their service in Honolulu. It was very rewarding.

A new roof was put on the Diocesan House which was sorely needed, and a beautiful new floor replaced the one in the living room. We need new floors in the hall, dining room and lanai to replace the termite-ridden boards. The contribution of a rug, davenport and pictures helped to make this room more attractive.

The Hostess and about eight of the servicemen went on a painting spree, and painted the downstairs halls, dining room, lanai, and up the stairs to the second floor.

The Altar Guild, Couples' Club, Evening Guild, Diocesan Auxiliary and other organizations continue to use the House. The Seabury Fellowship, formed this past year, meets here twice a month. In other words, it is a busy, happy House.

CLUETT HOUSE REPORT

Priory students (we have room for only three Priory girls) and university students go home during summer vacations. This year we used those spaces for summer students, one teacher (visiting and teaching during the summer) and one Korean woman doctor, here studying (visiting hospitals and clinics) who was anxious to live where she would have daily practice in using English.

Both Dr. Lee and the visiting teacher have written that they enjoyed their stay in Cluett House.

In February and March we had four bedrooms and three large porches repaired and painted. They are cheerful rooms and the new Canec ceilings and freshly painted walls improved them immensely. The occupants were so pleased that they painted the furniture to complete the renovation.

The children of the neighborhood were cutting across the corner of our yard, thus hampering Mr. Gaza's efforts to beautify it. However, after we put up a nice woven wire fence given us by the Bishop, our yard program progressed more rapidly. We all take pride in the yard and are grateful to Mr. Gaza for his untiring efforts.

We received a gift of money from the Woman's Auxiliary of the Diocese of South Dakota, for which we are grateful. We will add it to our fund for spring repairs.

Several magazine subscriptions are sent us each year by various Church Periodical Clubs and individuals, all are well read and enjoyed as are the other magazines and books sent us during the year by other friends.

We extend a cordial invitation to the ladies of the Woman's Auxiliary to visit Cluett House. We will be glad to show you through the house and yard, so you will know a little more about Cluett House and its functions.

We extend our grateful appreciation to Bishop Kennedy and the Reverend Canon Savanack and the Reverend Canon Ault for spiritual and material help and guidance, also to our Treasurer, Mr. Henry Budd, whose wonderful patience and work keep our books on the straight and narrow-path balanced.

REPORT OF CANTERBURY HOUSE EPISCOPAL STUDENT CENTER UNIVERSITY OF HAWAII

We have an active group at Canterbury House this year; fewer in number than last year, but greater in quality. They are a fine group, with a splendid spirit of cooperation and fellowship. This year, as last, we have a FOURFOLD program of "WORSHIP - SERVICE - FELLOWSHIP - STUDY".

WORSHIP for the students during each week of school is from 12:30 to 1:00 p.m. every Tuesday and Friday. We have the Holy Communion Service on the first Tuesday and Friday of each month. On the other Tuesdays and Fridays of each month we have Morning Prayer Services.

In our SERVICE program we stress the fact that by helping others one helps himself. We had many service projects this year. Some of them are as follows: On March 26, 1957, Prince Kuhio Day, a group went out to Camp Mokuleia and painted the entire roof of the main building there. In April 1957, there was a Senbei Sale, with a net profit of \$250. In the same month Canterbury House entered the Pan-Pacific Exposition at the University of Hawaii, and came away with first prize for the flower arrangement and honorable mention for the booth, and a net profit of \$100. The money which the students realized from all these projects pays for the upkeep of the Canterbury House for electricity, gas, telephone, and water. Our students, individually and as a group, participate in all areas of campus life.

The FELLOWSHIP program is one to which everyone looks forward. A great deal of good fellowship is felt at "C" House, as members call it. For some of the larger group gatherings, Mokuleia Youth Center is used. We conducted our Semester Break Camp there from January 31 to February 2. The main speakers were the Reverend Richard Aiken and the Reverend Paul Moore Wheeler. The theme of the Camp was "Can We Be Christians on the Campus?". On February 22, 1957, about 20 young people went on a hike to Aiea Heights. On May 11 we held our Annual Banquet at the Princess Kaiulani Hotel with some 50 members and friends attending this enjoyable affair. On October 12, St. Mark's Parish Hall resounded to a Playnight for the group. On November 30 a large group went out to Hale Kipa Camp at Kokokahi for our Thanksgiving Camp. Bishop Kennedy showed some slides and spoke on parts of the Orient. December 20 and 21 the Canterbury Carolers went to eight different homes and institutions for their Christmas caroling. Our Carol Group was given the honor of representing the Episcopal Churches of this Missionary District on the radio, singing at the Palace Grounds Band Shell on the evening of December 21, 1957.

In our STUDY program, talks on "The Church", "The Scriptures" and "Christian Life" are given, and we conduct a question and answer program as well. The Chaplain gives at least two sermonettes a month at the Holy Communion Service. Study sessions are conducted at every Camp for one to two hours, each followed by question and answer periods.

This year we have torn down the old unsightly "lean-to" which made it possible to enlarge the pavilion at the rear of our property. This doubled our working space, and added to the appearance and use of Canterbury House.

We wish to thank all who have given so unstintingly of their time, encouraging us with their interest and efforts. We ask your continued support of Canterbury House, at the University of Hawaii.

REPORT OF THE DEPARTMENT OF CHRISTIAN EDUCATION

The Chairman, who assumed his duties this past September, and several of the Division Chairmen who are new to the Department, wish to thank the Rev. Gerald G. Gifford, II, and former members of the Department for their past work and help in compiling this report.

We submit the following report by Divisions:

ADULT DIVISION
The Rev. Richard A. Kirchhoffer, Jr.

A library of adult study courses and discussion materials published by our National Department of Christian Education has been assembled for reference and is available in the Diocesan Office.

The Chairman of this Division is most anxious to work with the Woman's Auxiliary, the Laymen's League, clergy, and others for an exchange of information and techniques in Adult Education.

PROJECTS DIVISION The Rev. Charles T. Crane

The main responsibilities of the Projects Division are the supervision of the Lenten Mite Box Project and the Birthday Thank Offering. The highlight of the year was the Diocesan Missionary Rally in connection with Children's Missionary Offering (Mite Box) Project. Members of all Sunday Schools on Oahu gathered at St. Andrew's Cathedral for a movie and a service.

Cards with Scripture references and prayers were provided to all churches for our annual Diocesan Lenten Family Worship program.

The Birthday Thank Offering was given less support than the Mite Box Project. B.T.O. materials were ordered and are still available in the Diocesan Office. Next year, we hope to have a significant Birthday Offering for the support of work among Navajo Indians in New Mexico.

LEADERSHIP TRAINING Mrs. Mary Lou Turner

The Rev. Paul M. Wheeler, past Chairman of this Division, conducted a conference on the Dynamics of Group Leadership for the Woman's Auxiliary last spring at Mokuleia at which 40 women were present. Similar material was also presented to the Annual Meeting of the Woman's Auxiliary at Convocation.

The Rev. Claude F. Du Teil conducted a Parish Life Conference for members of St. Clement's and St. Peter's Parishes at Mokuleia in the fall.

Correspondence with Dr. David Hunter, Chairman of our National Department of Christian Education, has been initiated, looking forward to conferences here on various phases of Christian Education for children and adults.

The present Chairman of this Division is also engaged in correspondence to procure additional and future help with Leadership Training.

Various items of information and materials concerning Christian Education have been sent to the Clergy.

CURRICULUM DIVISION Sister Evelyn Ancilla, C. T.

The Curriculum Division has decided that its chief area of service is in acting as a consultant on curriculum materials. The file of materials in the Diocesan business office has not proved to be of the value we had hoped. The place is not suitable for the quiet perusal of the material for one thing; on the other hand although every effort is made to keep up to date, some of the courses are no longer available. The Hawaiian Board Book Rooms at 2103 Nuuanu Avenue keep a fairly complete selection of available curriculum material for both Church schools and Vacation schools including the Seabury Series, and the personnel are very helpful and cooperative. The bookrooms are also more conducive to the quiet looking-over of the materials. It would be as easy for anyone coming into the city to go there as to come down to the Diocesan office, with the added security that the samples seen are of material presently available.

VISUAL AID DIVISION Sister Lois Mary, C. T.

The new additions to the film library are Heartbeat of Haiti, a movie; Martin Luther, filmstrip with lp record based on the movie; Church Symbols, a set of six filmstrips and lp record, and the filmstrips on Haiti, Haiti, High Land of Hope and Light for Learning.

These are listed in the new Diocesan Visual Aids Catalogue which was distributed to all clergy in the fall.

PAROCHIAL AND PREPARATORY SCHOOLS DIVISION The Rev. Burton L. Linscott

In connection with Convocation 1957, the First Annual Teachers' Institute for Episcopal Schools in the Hawaiian Islands was conducted. Thirteen schools were represented by 117 teachers. At the 1-day session addresses by Bishop Kennedy, The Rt. Rev. William Fisher Lewis, S. T. D. Bishop of Nevada, and Dr. Shunji Nishi were heard. The morning program was devoted to the presentation of the prob-

lems "Relating the parochial school to parish life," and "Why choose to teach in a Christian school?" The afternoon period afforded an opportunity for workshop discussion groups on the teaching levels.

A file of catalogues from our many mainland Episcopal schools is available for interested parents.

The Chairman wishes to thank the Division Chairmen and the many other persons who have contributed to the Christian Education work of the Diocese. We welcome any information and suggestions that will help our work, and we stand ready to give any extra help that may be needed.

REPORT OF THE DEPARTMENT OF SOCIAL SERVICE

The Christian Social Service work went along as usual in 1957. It is interesting to note that various organizations within the Churches are actively engaged in the good work, including the children in the Sunday schools.

- l. The Sunday Schools. Many churches reported that their Sunday schools took part in the collection and distribution of foodstuffs to the needy families at Thanksgiving and Christmas time. One Sunday school gave canned goods to the Army and Navy Center and Christmas White Gifts for the underprivileged children in the Children's Hospital. Another Sunday school gave money to the Church World Service.
- 2. The Young People. One church reported that its young people collected old clothes for the Korean Relief and another reported that its young people helped with the mailing of letters for the Red Cross Organization and still another reported that its young people shared in giving a Christmas party to a Hospital ward.
- 3. The Woman's Auxiliary. One church reported that its Woman's Auxiliary gave a "Christmas Tree Decorating Party" to one of the wards at the Territorial Hospital and did sewing for another ward. Another Woman's Guild "adopted" a ward at Kaneohe Hospital and gave a used piano and visited the ward at least once a month.
- 4. The Churchmen and Women. The laymen and women of the churches are individually and actively engaged in community services such as leading the Boy Scouts, Girl Scouts, Cub Scouts, etc. Some have acted as hosts and hostesses at the Armed Services Y. M. C. A. and still others have served in the Community Crime Council, etc.
- 5. The Clergy. Our clergy are, of course, busily engaged in various social service work. One ministers to the Kalaupapa Leper Settlement, another makes a daily call at the hospital in his community as do the clergy on Oahu who are assigned to the hospitals on the Island. One clergyman serves on the Hawaii Committee on Alcoholism and another is a trustee of the Maluhia Hospital Auxiliary for Volunteer Service which he helped to organize. The clergy's work of social service is never ended as he tries to meet the deep needs of the individuals as they come to him.
- 6. The Parishes and Missions. As parishes and missions, following have been reported: One church has started a Sunday school class for the mentally retarded children with 8 in the class; another gave money to the Hungarian Relief and the Presiding Bishop's Fund for World Relief; one church distributed tract literature to the

home for the aged; another mission contributed money to the patients in another home for the aged; another mission started to sponsor Cub Scout Unit and sponsored three Scout Units; and others have collected magazines for the Sailor's Institute, hospitals, etc.

The hope of the Department for 1958 is that the churches will work together and try to meet the greater needs that are being felt in distant lands as well as communities near at home.

REPORT OF THE DEPARTMENT OF PROMOTION AND PUBLICITY

The Department of Promotion continues to be fortunate in having a fine relationship with the local newspapers--as well as with national church magazines. We are fortunate, also, to have Miss Katherine Morton continue the fine work she does with the Hawaiian Church Chronicle. The December issue of that magazine, with a beautiful cover in color, is a fine example of her efforts. The Chronicle is the only direct means of contact between the many churches of the Diocese.

Parish bulletins show signs of constant improvement--both in appearance and in content. Frequently the mailed parish bulletin is the only means of disseminating news of parish activities. It can be, also, a good means of 'getting through' to those who are irregular in church attendance. We hope, by next year, to have developed some method of giving recognition to especially good parish papers.

One of the high spots of the year was the visit of Mr. John Reinhardt, Director of the Department of Promotion of the National Council. Mr. Reinhardt stopped in Honolulu on his way to Australia. While here he spoke at a dinner meeting of clergy and laymen on the work of the Department of Promotion.

Perhaps no one subject is more often in the minds of newspaper people--and of publicity chairmen--than that of 'newsworthiness'. It cannot be overemphasized that information sent to the newspapers, or to the publicity department of the church--MUST be sent in time to permit publication. A story even one day old has lost all news interest usually. It may be saved as a 'filler' but will not otherwise be used. It is a good policy to call, even weeks or months ahead, when you first know of some important or interesting event-to-come. Then another call several days before the occasion will ordinarily ensure publication. We need more news, but it must be news.

Our public relations remains good, relatively speaking. We hope that all of those responsible for getting the news out will make use of the Promotion Department when we may be of service.

REPORT OF THE COMMITTEE ON STEWARDSHIP

Bishop Kennedy's 5th objective of his 1957 Convocation address was the task of Stewardship during 1957. His request was to develop a program to bring the unbaptized and unconfirmed to an awareness of the teaching of the Episcopal Church. To implement this we evolved for the use of all churches in October and November, the Diocesan Christian Witness Endeavor.

The Endeavor asked us each to do four things:

- 1. To pray daily, using the special prayer which has been given to me.
- To attend at least one Church service every Sunday and as many weekday services as possible.
- 3. To endeavor to bring with me to each service attended on Wednesday nights at least one non-Church-goer.
- 4. To try to bring someone to Baptism or Confirmation or both.

We owe a debt of gratitude to Mrs. William Male of the firm of Host and Male, who gave unselfishly of her time and the talents and time of her staff in preparing the excellent material used in the Witness Endeavor of the Diocese.

Our Diocesan Christian Witness Endeavor met with a varied response. Where clergy and people wholeheartedly used the plan and material, we have received reports of satisfactory response and success in bringing others to hear the Episcopal Church in her witness. This was especially true of the islands of Hawaii, Molokai, Maui, and Kauai.

The response on Oahu was varied by the conflicts of churches either having preaching missions, building campaigns, no enthusiasm for the plan or outright opposition. The churches that did participate report satisfaction with the results.

It is of interest that several mainland dioceses, hearing of our material, have asked for sample sets.

In closing, may I remind the convocation that the task of the Stewardship Committee was to implement Bishop Kennedy's 5th objective so that our church in the islands would bring people to baptism and confirmation. The fulfillment rested upon you.

REPORT OF THE PRESIDING BISHOP'S COMMITTEE ON LAYMEN'S WORK THE LAYMEN'S LEAGUE IN HAWAII

In 1957 the laymen of our churches on Oahu contributed more than 1,200 man hours to the Mokuleia Conference Center. The major work done included the complete painting of the exterior of the chapel, the main building, the staff house, the clergy cottage, the conference leader quarters, and the storehouse, the enlargement of the kitchen and the dining room of the main building, installation of full window screens on all buildings, erection of a life guard tower near the beach, installation of a new baseball backstop, the relocation of 2 electric line poles from playground

area, and the erection of a fence at the dormitory. This work was completed in time for the opening of the summer camp sessions.

The Annual Laymen's Training Course was held at Mokuleia Conference Center on October 12 & 13, under the direction of Titus Fong and K. L. Ching, who attended the Eight Province Training Conference held in May at Lake Tahoe, Nevada. The Reverend Paul Wheeler, rector of St. Clement's Church, did an outstanding job, serving as our chaplain. We had 30 delegates from our churches at this conference and the course was received with much enthusiasm. The theme of the course was "How Can the Laymen Help the Members of our Parishes to Become Truly the People of God".

At the Special Corporate Communion Service on Washington's Birthday, held at St. Andrew's Cathedral, our laymen gathered for worship and fellowship. A special offering of \$5 from each layman to reduce the Mokuleia Dormitory Debt was presented at the altar. The attendance was gratifying but it could stand some improvement. From this special offering we received \$2,900. With the help of Bishop Kennedy, we were able to get \$5,000 from outside sources, for which we are indeed very grateful. Our present balance of the Dormitory Debt is \$6,500.

We are planning to continue this Laymen's Corporate Communion Service in 1958 and we hope our laymen will make every effort to take part in this Christian fellowship as we gather once a year to rededicate ourselves to God and to present our means for His work.

In closing, I would like to express my gratitude and sincere thanks to the Bishop, the members of the clergy, and the parish keymen for their counsel and assistance during the year.

REPORT OF THE DEPARTMENT OF YOUTH

The Youth work of the Diocese was completely re-organized to conform with the National Churches Organization. The Territorial House of Young Churchmen Council of Episcopal Young People composed of the Convocation-elected officers of four and two delegates from each island, became the over-all planning body with their chief responsibility being the Summer Conference and the Convocation, Each island organized an Episcopal Young Churchmen's Council composed of elected delegates from each parish and mission. These councils met regularly to plan activities on their respective island.

The Conference Center at Mokuleia was used more in 1957 by the Youth Department than ever before. The department conducted three High School Conferences and four camp sessions for boys and girls between the ages of 8 and 14 years. As in former years we were indebted to the Diocese of Los Angeles for their counselors sent to us for leadership.

Camp Pecusa on Maui held three camping sessions in 1957. The young people of Hawaii held two conferences. Children from Kauai came to the camps at Mokuleia.

The Acolytes Festival Service on Oahu was revived this year under the leadership of Canon Norman Ault and Mr. Norman Westly. Two Youth Services were held.

The young people participated in the Diocesan Christian Witness Endeavor through their own churches and Y. P. F. groups.

The outstanding event of the year was the 1957 Convocation banquet at the Reef Hotel followed by a dance. Four hundred young people attended to hear the Rt. Rev. William Lewis, Bishop of Nevada, who said it was the largest Youth Banquet he had ever attended.

REPORT OF THE DEPARTMENT OF MISSIONS AND CHURCH EXTENSION

The Department takes pleasure in reporting the acquisition of new properties and many improvements in older properties throughout the Islands.

St. Luke's Church, having liquidated debts of several years standing, was consecrated on October 27th.

St. Philip's Church, Maile, was dedicated on November 3rd, and Ascension Hall, St. Andrew's Priory, a beautiful new classroom building, was dedicated on September 5th.

Outstanding is the St. Andrew's Cathedral expansion program, which was made possible by a fund-raising campaign to raise \$400,000, which is to replace the roof, install a new organ, new facade, and for the stained glass window on the entrance of the new structure.

St. Christopher's Church, Kailua, completed a building program of \$97,778.16, which included the extension of the Church, construction of the Church School building, refurbishing the Thrift Shop and the purchase of furniture for the Church School building.

Ground-breaking services were held for the \$90,000 building program for St. Elizabeth's Church for a new rectory and Education Building and Parish Hall.

A duplex apartment in Queen Emma Square for church workers was completed in September.

The Hawaii Episcopal Academy at Kamuela, Hawaii, became incorporated as of September 1st, taking the name of the Hawaii Preparatory Academy. Future plans for the Academy call for a building program of \$800,000 to \$1,000,000 on the new 55-acre site recently purchased at a cost of \$25,000.

In Okinawa a new kindergarten was completed at a cost of \$27,000.

Ordinations for three native men were held this year - to the Diaconate for Mark Ma, Taiwan, and Paul Nakamura, Okinawa. Richard Yoh, Taiwan, was ordained to the priesthood.

All Souls' Church, for the American Congregation on Okinawa is under construction, and a new mission, Grace Church, has been started at Tainan, Taiwan. The first resident Clergyman, Paul Nakamura, is on the Island of Izena Shima, Okinawa, at the Holy Spirit Church.

The Rev. Richard H. Baker is our first resident priest on Guam. Under his able leadership a live work has been started and the mission has taken the name of St. John the Divine.

On the Island of Oahu two new missions have been established, St. Barnabas, at Ewa Beach, and St. Alban's, at Iolani School.

St. Clement's Church, Honolulu, has made a great contribution in starting a Sunday School for retarded children.

REPORT OF THE HONOLULU BRANCH OF THE WOMAN'S AUXILIARY

The Executive Board of the Woman's Auxiliary of the Missionary District of Honolulu continued to meet on the second Wednesday of the month -- nine months out of the year. It is particularly gratifying to look back and remember the devotions and prayers that set the tone for the meetings and to recall the inspirational messages brought by our Bishop and members of the clergy.

Changes on the Board are inevitable, but again we were blessed with capable and devoted women to fill the vacancies occurring during 1957. To these women go our gratitude.

A deepening sense of the importance of Devotional Life is shown by the reported number of quiet days, prayer groups and bible study groups in many of the branches. Meditations and subjects for intercession, prepared by members of the Devotional Committee, were available for women who took part in the "Chain of Prayer" each Friday during Lent.

Programs presented by the clergy and members of the Executive Board during 1957 included: United Thank Offering, Haiti, Sunday School Material, Leadership and the Missionary Work of the Women. A study of the Navajo Indians and the National Council film, "Window in the Sky" were presented during the Lenten sewing sessions.

The District Altar Guild completed 80 articles ranging in size from purificators to Fair Linen cloths and Eucharistic vestments. A handful of women gathered together every Tuesday to help furnish the needs of the missions and to give assistance to parishes and missions who wished to make their own altar linens. The District Altar Guild's main source of income is through the All Saint's Day offering.

The devoted and diligent cooperation of the women of all islands made it possible to send close to 1000 articles of clothing to the Mission of the Good Shepherd, Fort Defiance, Arizona - our 1957 supply assignment from National Council. The assignment included new infant wear and used clothing for children up to the age of two.

Through the Church Periodical Club, gift subscriptions were sent to institutions and missionary clergymen. A portion of money sent to the National Book Fund was allocated to St. Margaret's House Library, the Church Divinity School of the Pacific and to seminary students from Hawaii. Several of the branches have distributed magazines and used books to hospitals, institutions, convalescent homes and the Seamen's Institute.

The women cooperated with the work of the Armed Forces Y. M. C. A. in being responsible for the Hospitality Hour or Fellowship Dessert Supper on the third Sunday of the month. We also were happy to take part in a special Thanksgiving dinner for servicemen at the "Y". The women have participated in the program of the United Church Women. Our Board representatives have kept us informed of all their projects.

The Youth work of the Diocese has been supported by women serving as nurses, counselors and cooks during summer camp sessions and at Youth Conferences. Those that had the opportunity to serve in this capacity, more than likely, enjoyed the camp experience as much, if not more, than the children themselves.

The Woman's Auxiliary "Specials" for 1957 included: The Bishop's Discretionary Fund, Seminary Student Fund, Hawaii Preparatory Academy and Camp Pecusa. Branch and individual contributions amounted to a total of \$5,385.25. Mothers' Memorial Fund, and fund supported through the Mothers Day offering, continued to give monthly assistance to two retired women workers. Articles of clothing were given to one of the women as a birthday gift. Voluntary branch contributions were sent to the Canon Heffner Christmas Fund.

There has been a general increase in the United Thank Offering over the years, but this year we appear to be backsliding slightly. Our goal is still a Blue Box for every woman. May the coming year bring us closer to our goal.

In closing, I again express my appreciation for the faithful and devoted assistance received from all the officers of the Board, the various committee chairmen and especially for the inspiration we have all received from our beloved Katharine Kennedy.

Gentlemen:

We have examined the balance sheet of The Protestant Episcopal Church in the Hawaiian Islands, as of December 31, 1957. Our examination was made in accordance with generally accepted auditing standards, and accordingly included such tests of the accounting records and such other auditing prodecures as we considered necessary in the circumstances.

The accounts and records of the Church do not reflect the financial position and results of operations of parishes, missions, and institutions which conduct the activities of the Protestant Episcopal Church throughout the Territory of Hawaii. However, certain trusts of these departments are held by the Church, and accordingly have been taken into account in the accompanying financial statements.

Inasmuch as title to all real property, except the real property of Iolani School and St. Clement's Church, is vested in The Protestant Episcopal Church in the Hawaiian Islands, this property is accounted for in the records of the Church. However, the carrying value of the real property is not infrequently an estimated amount, not readily subject to accurate determination, intended to represent expenditures made not only by the Church but also by missions, parishes, and other persons.

In our opinion, the accompanying financial statements have been prepared in accordance with established accounting practices of The Protestant Episcopal Church in the Hawaiian Islands on a basis consistent with that of the preceding year.
