#### JOURNAL OF PROCEEDINGS

#### Friday, October 28, 2005

<u>WELCOME AND CALL TO ORDER</u>: Bishop Chang welcomed the clergy, delegates, and guests. The Annual Meeting was called to order at 12:00 noon in the Prince Ballroom of the Maui Prince Hotel, Makena, Hawai`i.

The Bishop directed those in attendance to check their table assignments for the Bible sharing on Saturday. The table number is printed on the nametags. The Bishop also asked that all cell phones, pagers and other electronic devices be turned off.

**QUORUM REPORT FROM THE CREDENTIALS COMMITTEE:** Bishop Chang, President, called on the Chair of the Credentials Committee, Ms. Jan Horimoto, for a quorum report. Ms. Horimoto reported that 27 of the 80 canonically resident and domiciled clergy constitute a quorum in the clerical order, and that 82 of the 162 lay delegates constitutes a quorum in the lay order. There being 44 clergy and 130 lay delegates registered, a quorum is established and present for the transaction of business.

Bishop Chang declared the Convention duly constituted and open and ready for business.

Report from the Credentials Committee Regarding Congregations that had not paid their assessments in full by January 15, 2005. Ms. Horimoto presented the following motion, and moved its adoption:

BE IT RESOLVED, as recommended by the Diocesan Council, that the members of the lay delegations from Christ Memorial and Calvary be admitted to seats and votes in this Annual Meeting of the Convention.

The motion, having been made on behalf of the Committee and requiring no second, carried by voice vote.

Ms. Horimoto reported that, with the addition of Christ Memorial and Calvary, now duly seated, the revised lay quorum is 86 of the 171 lay delegates, with 140 lay delegates present.

Bishop Chang explained that Peter Pereira, Treasurer, is currently on bereavement leave and is not present at the Annual Meeting. (Refer to Attachment C)

**THANKSGIVING FOR COMPANION DIOCESE RELATIONSHIP - RESOLUTION #2:** The President called on Ms. Jane Ibara, Chair of the Companion Diocese Commission, who presented a plaque to Bishop Tani and the representatives of the Diocese of Okinawa in thanksgiving for the Companion Diocese Relationship between Hawai`i and Okinawa, 2000-2005. Ms. Ibara also thanked Bishop and Mrs. Tani and the Okinawan delegation for participating in the Annual Meeting of the Convention of the Diocese of Hawai`i.

Bishop Tani received the plaque on behalf of the Diocese of Okinawa and reviewed the years of the Companion Diocese Relationship and the history of the relationship between our dioceses over the past 50 years. Bishop Tani stated that although the Companion Diocese Relationship will end, the relationship between the two dioceses will not end. Bishop Tani presented gifts of calligraphy to Bishop Chang and gifts of calligraphy bookmarks for each person registered for the Annual Meeting. (Refer to Attachment D)

In the last part of his address, Bishop Chang announced his intention to retire after reaching his  $65^{th}$  birthday in November of 2006 and called for the election of the  $5^{th}$  Bishop of the Diocese of Hawai'i. Ms. Cynthia Salley, President of the Standing Committee, moved to honor Bishop Chang's request to call for the election of the 5<sup>th</sup> Bishop of the Diocese of Hawai'i. The motion duly seconded, was adopted. Ms. Salley offered prayers for the election process that was developed with the assistance the Rt. Rev. Clay Matthews of the Office of Pastoral Development of the Office of the Presiding Bishop. Ms. Salley described the process to be followed for the search and election and explained the time line that begins immediately and culminates with the installation of the 5<sup>th</sup> Bishop of Hawai'i on March 10, 2007. A handout entitled "A Process for the Search and Election of the 5<sup>th</sup> Bishop of the Diocese of Hawai'i" was provided to all members and observers. (Refer to Attachment F)

**<u>RECESS</u>**: Bishop Chang declared the Convention in recess until 8:00 a.m. Saturday, October 29, 2005.

EPISCOPAL RELIEF AND DEVELOPMENT FUND - SPECIAL ORDER OF BUSINESS #2:

The President called on Ms. Susan Thornett, Chair of the diocesan Episcopal Relief and Development Fund Commission, who introduced Mr. Brian Sellers-Peterson of the ERD staff. Mr. Sellers-Peterson provided an update on the ministry of ERD and thanked Bishop Chang and the Diocese of Hawai`i for support of the fund. Mr. Sellers-Peterson also brought greetings from the Rev. David and Mrs. Sarah Moore, formerly of the Diocese of Hawai`i.

**<u>REPORT ON THE FIRST BALLOT</u>**: The President called on Ms Lani Kaaihue, Chair of the Elections Committee, to report the results of the first ballot. The results were as follows:

Peter Champion, Chair of the Resolutions Committee, for a supplemental report. The Rev. Champion, on behalf of the Resolutions Committee, moved that Resolution # 6, amendment of the Constitution that will permit the Search and Election Process to continue, be approved for consideration by the Annual Meeting. The having been made on behalf of the Committee and requiring no second, carried. Resolution #6 was referred to the Task Force on Constitution and Canons.

**<u>CONFIRMATION OF ASSISTANT SECRETARY OF THE CONVENTION</u></u>: Ms. Nancy Rowe announced the appointment of the Rev. Morley Frech as Assistant Secretary. The appointment was confirmed by the Convention.** 

**2006 CLERGY COMPENSATION AND BENEFITS POLICY OF THE EPISCOPAL CHURCH IN HAWAΓI - RESOLUTION #3:** The President called on Ms. Dot Shigemura, Chair of the Diocesan Compensation Review Committee to present Resolution #3. Ms. Shigemura moved adoption of the Resolution as presented. The motion, having been made on behalf of the Committee, required no second.

The Rev. Donor Macneice moved postponement of Special Order of Business # 4, Report from St. Nicholas Church, in order to continue discussion of Resolution #3. The motion duly seconded, carried. Special Order of Business #4 was postponed.

Resolution #3 was adopted as presented. (Refer to Attachment H)

#### SECOND BALLOT FOR ELECTIVE POSITIONS-STANDING COMMITTEE. LAY ORDER:

The Convention expressed its appreciation to Ms. Dot Shigemura for her presentation of the 2006 Clergy Compensation and Benefits Policy of the Episcopal Church in Hawai`i.

**<u>REPORT ON YOUTH EVENT - SPECIAL ORDER OF BUSINESS #5</u>:** The President called on Ms. Carrie Allport who reported on Hawai`i youth participation in the Episcopal Youth Event in Berea, Kentucky.

**<u>REPORT OF THE HISTORIOGRAPHER</u>**: Courtesy of the floor was granted to Mr. Stuart Ching, diocesan historiographer. Mr. Ching reported on changes to and relocation of the archives. Space has been renovated in the Memorial Building at the Cathedral to house the church document collection. All of the archival materials collected were sterilized at Bishop Museum, at no cost to the church, to remove any pests prior to relocation. Set up is now complete. Mr. Ching requested that congregations and individuals donate church records and important memorabilia. Some letters written by our previous Bishops have been purchased from owners who have auctioned them on e-bay.

**PRESENTATION OF THE 2006 DIOCESAN BUDGET:** The President called on the Rev. Alison Dingley, Chair of the Resource Development Department, who moved adoption of the budget as presented. The Bishop also recognized additional resources persons available for discussion of the budget:

The Rev. Litwinski stated that the 10% increase in the bishop's salary and benefits is consistent with Resolution #3 and will also serve to attract qualified candidates during the search and election process.

The motion was duly seconded. The budget was adopted as amended. (Refer to Attachment L)

**THREE YEAR BUDGET PROCESS – RESOLUTION #1:** The President called on the Rev. Peter Champion, Chair of the Resolutions Committee, who reported that the committee recommended adoption of the resolution as presented. The motion, having been made on behalf of the Committee and requiring no second, carried. (Refer to Attachment M)

**THE AMENDMENT OF SECTION 1 OF ARTICLE XI OF THE CONSTITUTION OF THE DIOCESE OF HAWAII – RESOLUTION #6:** The President called on Mr. Wayne Yoshigai, Chair of the Task Force on Constitution and Canons who moved that the resolution be adopted as presented. The motion, having been made on behalf of the Committee, required no second. A revision to the Constitution requires a majority vote by orders and the concurrence of the Bishop. The motion carried in both orders. The Bishop concurred. Resolution #6 passes first reading. The second reading will take place at the 38<sup>th</sup> Annual Meeting of the Convention. SUBJECT: ANNUAL REPORT OF THE TREASURER

The Balance sheet of The Episcopal Church in Hawai'i on December 31, 2004 showed assets of \$36,871,573, liabilities of \$17,482,155 and net assets of \$19,389,418. The total operating income of the diocese exceeded operating expenses in 2004 by \$163,788. It should be noted that all congregations have paid their 2004 assigned assessments, except for two congregations.

Price Waterhouse Coopers, CPAs, audited our financial statements. If you would like to receive a copy, please call me.

Our audit shows that we have an adequate system of internal control. Appropriate parties must properly authorize all disbursements, and two authorized officers must sign all checks.

#### 2005

- 1. In your Convention Packet, there will be the current Budget versus Actual Operating Report as of September 30, 2005. The report is summarized to cut printing costs. If you want a detail report, please call me.
- In your Convention Packet, there will also be a report on our Theological Education Offering for 2004. You will note that we contributed \$40,418 that which amounted to 58% of our 1% goal. Now is the time to be checking on the performance of your Parish or Mission this year so that we can meet our 1% goal in 2005.

Our Investment performance numbers are as follows: Year to date @9/30/05 = 8%; trailing 12 months = 15%; 3 Year trailing = 13%; 10 Year trailing = 9%

- 3. During the year the Resource Development Department met with our investment monitor and managers to review the performance of our investment portfolio and also to review our Investment Policy. We replaced one investment manager. We have a long-term view towards our portfolio management with the understanding that the stock market will experience fluctuations from time to time. We have a total return investment policy and spending policy. Our policies are implemented to ensure that there will be a steady stream of earnings annually, while at the same time ensuring that the fund assets will be there for the future. Our spending policy is set at a payout rate of 5 percent (5%) of the average market value of the Investment Fund over 3 years. The spending policy (which we will continue to review), together with sound investment performance, ensures that, over time, the fund will retain its ability to produce earnings.
- 4. The setting up of the Shared Travel Expense Fund for the 2005 diocesan convention has been accomplished.
- 5. The rate of assessment for 2006 is 21% (2005 was 22%).
- 6. The Compensation Review Committee (CRC) is submitting a compensation schedule reflecting a 10% increase over the current year. Please refer to the CRC report and the 2006 Clergy Compensation and Benefits policy for details.
- 7. During the year, I worked with treasurers advising and training them on various matters, namely taxes, accounting and audit, investments, insurance, parochial reports, employment, insurance and property issues. I also worked with them on refinancing loans from the bank at competitive rates for various renovation projects.
- 8. During the year, I coordinated with the auditors and treasurers to audit their church. Thanks to the church treasurers for doing the audit work papers for the audit.

I am working with HMSA and the Church Medical Trust to inform our eligible active and retired clergy on the changes to Medicare namely Medicare Part D.

- 9. We are working with our insurance agent to renew our property and liability insurance renewal for the year 2006. The insurance market has been tight and coverage and limits have been difficult and costly. We will continue to maintain a reserve fund to cover the deductible for our hurricane policy.
- 10. I worked with the Lay Pension Plan Administrator to inform and update employees and employer representatives about the plan and the investment vehicles available.
- 11. We continue to hold training workshops for Safeguarding Gods Children and Preventing Sexual Misconduct (adult). Please check out the web site for training that will be held in 2006.
- 12. The Diocesan Council adopted a Personnel Policy for the Office of the Bishop. This policy is to be used by each congregation as a guideline to draft its own policy. Mr. Wayne Yoshigai (Deputy Vice Chancellor) will be available to assist congregations with their Personnel Policy.
- 13. Please use our website, episcopalhawaii.org. We are working to add more content to the web site. It has helped us cut down our copying and mailing costs.
- 14. I continue to serve on the Non Profit Committee for the Hawaii Society of Certified Public Accountants. We organized a workshop for non-profits this year and I also attended various continuing education workshops to keep current with laws and regulations.
- 15. We continue to monitor the financial condition of Camp Mokuleia.
- 16. I worked with the Church Pension Fund to coordinate the Planning for Tomorrow (Financial & Retirement Planning) workshop for active clergy and the medical/ medicare update for retired clergy which will be held on November 11 & 12, 2005.
- 17. I and a couple of volunteers are available for consultation on planned giving. Please call me if you need any assistance.

Nancy Minuth and I would like to thank the treasurers, wardens and clergy whose work, cooperation and goodwill have helped us in our work. Many thanks also to the members of Diocesan Council, Resource Development Department and all its sub Committees, Diocesan Compensation Review Committee, Chancellor and Vice Chancellors and Office of the Bishop staff. Thank you all for your support and the gifts you share with us.

## Bishop's Address to the 37th Annual Meeting of the Convention The Episcopal Diocese of Hawai'i October 28, 2005

It was the spring of 1990. It was 6:45 a.m. on a Friday morning. As was my routine, I was standing on the corner of Grove Street and Haddon Place in Montclair, New Jersey, waiting for DeCamp Bus #44 to New York City. A grey Chevy sedan with two men stopped at the curbside. The individual on the passenger side put down his window and asked, "Do you want a ride? We need another person to qualify for the High Occupancy Vehicle lane and the discounted toll for the Lincoln Tunnel."

I got into the car with these two well-dressed strangers! They drove in the HOV lane. They paid the \$2.00 toll as we entered the Lincoln Tunnel. They dropped me off on the corner of 42nd Street and 9th Avenue as Decamp Bus #44 was pulling into the Port Authority Bus Terminal across the street.

Did I know either of the two men? No. Did I ask them who they were? No. Did the other person standing with me at the bus stop get into the car? No.

Did they really need another person in the car to drive in the HOV lane and get the discounted toll at the Lincoln Tunnel? Yes. Did I get to New York that morning? Yes. Did I make a decision that put me at great risk? Yes.

For the next six years, whenever Dr. Robert Campion, Chief of Psychiatry at St. Vincent's Hospital in New York City, and his hospital colleague needed a third person in their car, they would stop and pick me up at that bus stop on the corner of Grove Street and Haddon Place. Sometimes they would pick me up even when they did not need a third person. When one of the doctors would go on vacation, the driver would always pick me up and any other person standing with me at the bus stop.

When I told colleagues at the Church Center, they were in total disbelief that Dick Chang would be so stupid to risk his life for \$4.50, the cost of a one-way bus ticket from Montclair, New Jersey, to New York City. To this day, I cannot tell you why I got into the car on that day. I had never done anything like that before, and have never done anything like that since. I took a life-and-death risk. I did not think about the danger until I was walking across midtown Manhattan on 42nd Street to the Episcopal Church Center. Luckily for me, my action did not end in tragedy for my family, but for the next six years I received free 45-minute therapy sessions while riding into New York.

In preparation for this Annual Meeting, I reread the proceedings from the 36th Annual Meeting of the Convention of The Episcopal Diocese of Hawai'i, and reviewed reports from commissions and congregations. It is evident that numerous members of the Convention made their decisions regarding the Strategic Plan for our Diocese without full appreciation of the risks, challenges, and opportunities it embodied. They acted as I did when I got into the car with total strangers without thinking of the consequences of my action. With adoption of the Strategic Plan, the transformation of the Diocese of Hawai'i was begun. The Diocese has begun that move from the onramp of maintenance onto the highway for mission. With adoption of our Strategic Plan, we said that we were ready as a Diocese to move forward with a new commitment to mission. We were ready to risk for the mission of the Church. The journey has begun.

But we have only just begun. There is the risk that this 37th Annual Meeting will be reluctant to continue the initiatives begun last year. There is the risk that we will fall into regressive behavior and try to return to maintenance. We may not want to face new challenges. We may want to return to our comfortable pews. But that is not possible. When a caterpillar is transformed in the cocoon, it emerges as a butterfly. Its new life is one of risk and opportunity. There is no returning back into the cocoon. The butterfly cannot regress back to being a caterpillar. The butterfly must embark into the future with a faith that flight will dry its wings enabling it to fly with ease and new purpose in life.

This Diocese must not turn back. This Diocese cannot turn back. We have a purpose in life: We are followers of Jesus Christ. We are a people with a mission. Moving forward as the Spirit-filled people of God is challenging and risky. It is made possible because of the love of God in Jesus Christ for each of us. We are not now and never will be separated from that embracing powerful love of God in Christ Jesus. God working in us and our communities will sustain us as we walk our path of faithful discipleship. Ours is the faith of the apostles and martyrs. Ours is a community rooted in the resurrection of Jesus Christ. Ours is a life redeemed by a loving God. And so, there is only moving forward. We are not the same church or diocese that gathered a year ago — we are certainly not the fear-racked, angry, and resentful Diocese I first addressed nine years ago. We have been transformed by the power of the Spirit of God. We can now live into the mission to which we have been called by our baptism. The power of Pentecost in each of our lives enables us to become a church united in mission and rejoicing in God's blessings of diversity.

The response of congregations and individuals to Mission Fund 2005 was outstanding. We nearly doubled the amount contributed to Mission Fund 2004 which enabled the building of a village water system in the Northern Philippines. We have received letters of gratitude from the agencies to which we made grants, so that they could continue to feed the hungry of our State. Mission Fund 2005 made the wider community aware that the Episcopal Diocese of Hawai'i was a caring and mission-oriented church concerned for the hungry of our community.

Likewise, your generous response to the victims of Hurricane Katrina and Rita has been just as phenomenal. In addition to raising funds for Episcopal Relief

and Development, we have sent people to Louisiana and Mississippi to help the hurricane victims and relief workers. Jan Rudinoff went to Baton Rouge, Louisiana, as part of a national church disaster chaplains team. Members of Grace Church, Moloka'i, went to Mississippi as their contribution to disaster relief. You have willing to assist in the resettlement of evacuees here in the State of Hawai'i. All this was done in a spirit of mission by people of compassion.

Lest we lose our vision for international mission, I recommend that this Diocese designate Mission Fund 2006 for relief and redevelopment in the Diocese of Guatemala which has just suffered the horrific devastation of landslides caused by torrential rains. More than 500 persons have been killed. Several communities have been buried by landslides. Seventy-eight percent of their road system has been damaged, and crops have largely been damaged. Normally, Mission Fund 2006 would have supported a project within our own Diocese, as we did in 2003 when we supported youth ministry at St. Nicholas Church, our new church plant in Kapolei. We have another opportunity to be missionary partners with Episcopal Relief and Development in helping the people of Guatemala through Mission Fund 2006.

But the transformation for mission has not been without difficulty and obstacles. For the majority of our Diocese, our Strategic Plan is still an unknown. Regrettably, there are those among us this afternoon who have never read our Strategic Plan, or even know how to get a copy. Many congregations and Diocesan Commissions have not used the four goals of our Plan in developing, implementing, and evaluating their vision and ministry. Many are unaware of the real impact of the actions taken by the 36th Annual Meeting last year. We embarked upon a new pathway of mission as a Diocese, and too many have remained in the dark and "clueless." For a few, the Strategic Plan has provoked the old responses of fear, anger, and resentment — but only for a few. For this I have grieved and have had to ask myself the question, "Where is our faith in Jesus Christ?" Then I am reminded of others who have boldly embraced mission. I am reminded of the new programs and ministries of our congregations. I am reminded of emerging partnerships for ministry. And I thank God — the journey on the road of mission has begun.

The Report of the Compensation Review Commission to this Annual Meeting is a very, very concrete example of how we have begun to move towards implementation of the goals of the Plan. It is a bold attempt to look at our new reality. The reports of the several Task Forces created by resolution at the 36th Annual Meeting are more clear examples of the opportunities and risks before us as we strive forward in a spirit of mission. Read these reports and the recommendations. Transformation of systems is never easy. It is painful for everyone: those who resist the transformation and those who advocate it. During the time we spend together at this Annual Meeting, let us fully engage the issues of mission with a spirit of generosity and respect, and not scapegoat those who differ from us. Focus on the issues with the spirit of mission. It is God's mission

that we do. Mission serves others. Mission that is self-serving is maintenance! Like the Holy Spirit, the winds of Hurricane Katrina blew away the divisions of diversity, exposed the injustices of our society, and called us to a common mission of service to those in need.

Like it or not, the actions taken by the 36th Annual Meeting began the transformation of our Diocese. The people of God in the Diocese of Hawai'i have been called to become a new Church — a Spirit-filled church dedicated to a mission of reconciliation with God and with each other.

Like it or not, the proverbial "rubber has hit the road," and we are on our way. It will not be neat and tidy. We will smell the rubber burning. We cannot keep our feet on the brakes of mission out of fear, anger, and resentment. There is no turning back, no turning back! In the oft-quoted words of Edmond Browning, "the train is leaving station, so get on board!" We have gotten into the car that leads into a future that demanded personal and communal transformation — Transformation in the love of Jesus Christ!

Your Diocesan Council has caught the spirit of mission and transformation, as evidenced by their development of the 2006 Budget and their presentations at the pre-Convention budget meetings, by their proposal that we embark upon a three-year budget process, and by their willingness to be leaders committed to mission.

The re-visioning of familiar programs, such as Christian Formation, Summer Camp, and young adult ministry, has been undertaken with this new understanding of mission and ministry shaped by the faith of their community and the goals of our Strategic Plan. The work of the Commission on Ministry in the implementation of the ministry canons within this Diocese has reminded us that ministry is for all the baptized, not to the few who are ordained and their closest friends!

I began this address with the story of my stepping into a car with total strangers. I conclude my address to this 37th Annual Meeting of the Convention of the Diocese of Hawai'i with the challenge to the Diocese to step into your future with renewed boldness and an eager faith in Jesus Christ. Such a challenge demands that we must each evaluate our role in the mission of the Diocese and our calling now that we have committed to the risks of the journey.

Therefore, after much prayer, I call for the election of the next Bishop Diocesan for the Diocese of Hawai'i, and that the Diocese begin the election process. It is my intention to retire sometime after my 65th birthday (November 30, 2006). I have informed the Standing Committee of my intention to call for an episcopal election. They met in September with the Rt. Rev. F. Clayton Matthews, Director of the Office for Pastoral Development for the House of Bishops, to discuss the process for the election and consecration of the Fifth Bishop of Hawai'i. Ms.

Cynnie Salley, President of the Standing Committee, will report on behalf of the Standing Committee to this Annual Meeting at the conclusion of my address.

Let me make it very clear that I will not resign my jurisdiction of the Diocese of Hawai'i as the Fourth Bishop of Hawai'i until the Fifth Bishop of Hawai'i has been elected and consecrated. I will announce a specific date when the election process has been adopted and initiated by the Standing Committee. I intend for our Diocese to have an orderly transition between episcopates. Ecclesiastical authority will be passed directly from me to my successor, not to or through the Standing Committee. You may not realize it, but God willing, I will be the first Bishop of Hawai'i to resign for the purpose of retirement, or in the words of the Constitution and Canons of the Episcopal Church, "for reasons of advanced age." Bishop Hanchett died in office. Bishop Browning resigned to become Presiding Bishop. Bishop Hart resigned for reasons of missionary strategy.

It was not an easy decision for me. Ordained ministry has been my life for the last 39 years. Let me assure each of you that this decision was not made lightly. My decision was reached after prayerful discernment and many hours of reflection with my prayer partner in the House of Bishops.

Next year, 2006, will mark the tenth year of my episcopate and the fortieth anniversary of my ordination. I believe that I have served the Church faithfully for these years. I believe that I leave the Diocese of Hawai'i in a healthier place than when I began my Episcopal ministry in 1996. I believe that the time is right for the Diocese to move into your future with new Episcopal leadership. More importantly, I believe that the time is right for me and my family.

Dee and I have not as yet made any definite plans for our retirement. We still have much time with you, so don't you listen for the "quacks" of a lame duck. Together we have much to do as the Episcopal Diocese of Hawai'i as we live into our Baptismal Covenant and continue the implementation of the Diocesan Strategic Plan. We are not done. As one who believes in the communion of saints, our work of sharing Christ's love and praising the living God will never be done. That is the mission to which God has called each of us in this place called Hawai'i. That is the mission which you have graciously shared with me.

You will hear these words in the lesson from the Letter to the Ephesians at this evening's Eucharist: "We have been transformed by the power of new life in Jesus Christ through his resurrection. Glory to God whose power, working in us, can do infinitely more than we can ask or imagine; Glory to God from generation to generation in the Church, and in Christ Jesus for ever and ever. Amen."

Thank you for honoring me and allowing me to be among you as your bishop. God bless you all.

## A Prayer for the Search of the Fifth Bishop of the Diocese of Hawaii

Gracious and loving God, we come to you for guidance and strength as we search for a new bishop for the Diocese of Hawaii. Help us to discern your desire for your people and to call a shepherd who can guide us in your path. Help us to be open to the movement of your Spirit as we call a bishop who will show us the wonders and excitement of more fully becoming your disciples. Help us to elect a bishop who will walk the difficult roads with us and take us closer to the Kingdom that you desire for us. Keep our search committee committed to one another in their task, give them the strength and perseverance to listen to the people of this diocese and to your guidance, and help them remember to delight in one another even as they move through this most serious of responsibilities. We ask all of this in the name of your Son, our loving Savior and ever-present Shepherd, Jesus Christ. Amen.

## Process Protocols for the Election of the Fifth Bishop of Hawaii

- 1. There will be two Committees: a Search Committee and a Transition Committee.
- 2. The Search Committee will consist of 1 clergy and 1 lay from each county, except there will be 2 of each order for Oahu. The Standing Committee will also appoint 5 members-at-large and will select the chair. Nomination Form attached.
- 3. The Transition Committee will consist of 1 clergy or 1 lay from each county, except that there will be 2 (clergy or lay, any mix) from Oahu. The Standing Committee will appoint 4 members-at-large and will select the chair. Nomination Form attached.
- 4. The elections to the Committees will be by county and will occur at County Meetings chaired by members of the Standing Committee, on Sunday, November 13, 2005. (See Appendix A for meeting constituency.)
- 5. The Search Committee will be tasked with presenting 3-5 nominees to the Standing Committee at its August, 2006 meeting. Persons serving on the Search Committee should have the qualifications outlined in Appendix B.
- 6. The Transition Committee will be responsible for the details of the Episcopal transition. Persons serving on the Transition Committee should have the qualifications outlined in Appendix B.
- 7. The Standing Committee has appointed a Chaplain to the Search and Transition Committees, the Rev. Liz Zivanov, and a Consultant, Canon Betsy Greenman, to assist both Committees in carrying out their responsibilities.
- 8. The Standing Committee will sponsor a mandatory overnight retreat on December 9 and 10, 2005 at Camp Mokule'ia for all members of the Search and Transition Committees with the Standing Committee, Chaplain and Consultant. This will begin at 5 p.m. on December 9th and conclude by 4 p.m. on December 10th.
- 9. It will be the responsibility of the Diocesan Council to create a budget for the election process, as well as establish the salary and benefits package for the new bishop.
- 10. In lieu of "nominations from the floor" during the electing convention, please refer to Appendix C, Nominations by Other Than the Search Committee.

An amendment to Canon XI: Office of the Bishop has been prepared for its first reading and consideration by this 37th Annual Meeting of the Convention to assist this Search/Election Process. (See Appendix D.)

- 11. Background checks will be completed for all nominees, those nominated by the Search Committee and those nominated by Petition.
- 12. The Search Committee will conduct a "walk-about" of all nominees in each county from October 10 through 15, 2006.
- 13. Election of the 5th Bishop of the Diocese of Hawaii will take place during the 38th Annual Meeting of the Convention of the Diocese of Hawaii, October 20–21, 2006 in Honolulu.
- 14. Bishop Chang and the bishop-elect will begin the transition process on January 2, 2007.
- 15. The 5th Bishop of the Diocese of Hawaii will be ordained and instituted at St. Andrew, s Cathedral, Honolulu on Saturday, March 10, 2007.

Nominations for persons to sit on the Search and Transition Committees must be received by the Standing Committee **<u>no later than November 8th!</u>** 

Nomination Forms can be downloaded from the Diocesan Website www.episcopalhawaii.org and should be sent to The Rev. Liz Zivanov c/o 1515 Wilder Avenue, Honolulu, Hawaii 96822.

Nominees must be members in good standing according to national and diocesan canons, and must commit to the duties, expectations, and timeline outlined in *Appendix B* and *Appendix E*.

Profiles of each nominee will be sent to the wardens and canonically resident clergy by November 11, 2005 via email.

## **ELECTING MEMBERS FOR COUNTY MEETINGS:**

The electing members for the various county meetings to be held on Sunday, November 13, 2005, shall be the wardens of each congregation within the county, along with all canonically resident clergy of the county. If either or both wardens are unable to attend the county meeting, a substitute is to be appointed from the Vestry/Bishop's Committee, by the wardens and the rector/vicar.

#### **VOTING AT COUNTY MEETINGS:**

The wardens of the Counties of Hawaii, Kauai and Maui will elect respectively, one (1) lay member to serve on the Search Committee. The wardens of the City and County of Honolulu will elect two (2) lay members to serve on the Search Committee.

The canonically resident clergy of the Counties of Hawaii, Kauai and Maui will elect respectively one (1) clergy member to serve on the Search Committee. The canonically resident clergy of the City and County of Honolulu will elect two (2) clergy members to serve on the Search Committee.

Elections for the Transition Committee members will be done jointly by the wardens and clergy of each county with one (1) person (either lay or clergy) respectively from the Counties of Hawaii, Kauai and Maui, and two (2) persons (either lay or clergy) from the City and County of Honolulu.

In each election, the elected person must receive at least 51% of the vote.

Display leadership ability and be able to work with a team, as well as on your own

Be able to listen to the opinion of others as well as articulate your own position in an inclusive and loving manner

\* Due to the time commitment involved, youth participation in this Search Process will be intentionally sought through group meetings, surveys and other means of input.

## Nominations by Other Than the Search Committee

In the Canons of the Diocese of Hawaii, nominations from the floor are permitted for most positions. However, the necessity for background checks has, from a practical point of view, made this problematic. Therefore, in order to preserve the spirit of the nomination from the floor process, the Standing Committee has established the following procedure for "Nomination by Petition," should it occur.

This procedure allows the nominee(s) by petition and the members of the diocese the same chance to meet each other, and will allow the Standing Committee the time to perform the necessary background checks.

The timeline for the election of the 5th Bishop of the Diocese of Hawaii calls for 3-5 nominees from the Search Committee to be presented to the Standing Committee in August, 2006.

- O Any Nomination by Petition must be received by the Standing Committee **no later than September 1, 2006**.
- O Petitions must have at least six (6) signatures: three (3) clergy and three (3) lay, and represent no fewer than two (2) different congregations from no fewer than two (2) counties.
- O Background checks will be required and will be the responsibility of the Standing Committee.
- O Delegates and the diocese will have access to the same information about this nominee as they have about the nominees resulting from the Search Process.
- O Nominees by Petition will participate in the "Walk-About" from October 10-15, 2006.
- O It will be made clear to the electorate that the nominee(s) came through petition, not through the Search Process.

## **RATIONALE/EXPLANATION**

The 2006 Clergy Compensation Schedule salary ranges represent a 10% increase over 2005's schedule, along with a \$600 increase to the automobile allowance. (*The automobile allowance has not been adjusted in 4 years, and the 2005 AAA allowance is \$7,142. The Committee thus is phasing in the catchup of half this year, and will be recommending the remainder at next year's convention*). In addition, this year's recommendation allows for vestries/bishop's committees and clergy to mutually determine whether a flat automobile allowance or a mileage system will be implemented at each congregation.

The Compensation Review Committee discussed this recommendation in its presentations made around the state in August and September to clergy, lay convention delegates, wardens and treasurers. It is hoped that the concept mentioned in that presentation of continued 10% increases for the three subsequent years following 2006 will be given serious consideration in those subsequent years.

## I. <u>Salaries</u>

- **a.** The compensation categories and ranges are intended to be used as a framework within which the Vestry/Bishop's Committee and the clergy negotiate a mutually acceptable compensation. The compensation ranges are based on years of service to provide a guide for compensation increases as years of service increase. This compensation schedule sets the minimum for churches in the Diocese of Hawaii. Years of service means the number of years of status as a clergy person in good standing in ECUSA In Parishes, Compensation is negotiated between the Clergy person and the vestry. For Missions, compensation is negotiated between Clergy and the Bishop's Committee with the approval of the Bishop. Credit for prior years of service as an ordained person in-good-standing in another denomination is negotiated between the clergy and the Vestry/Bishop's Committee with the approval of the Bishop. With respect to clergy newly called or appointed to a congregation, the Vestry/Bishop's Committee is required to notify the Treasurer of the Diocese as to the number of years of service at which they enter the Compensation Schedule approved by Diocesan Convention. In order to maintain accurate records, a schedule will be attached to the Parochial Report reporting the clergy compensation and the number of years of service as it increases each year.
- **b.** Clergy must be paid at least the minimum of the applicable category with salary reviews at least annually. Congregations and clergy are strongly encouraged to set up a bi-annual Mutual Ministry review, complete with clear goals and objectives, mutual accountabilities and shared expectations by both the laity and the clergy.
- **c.** These categories are minimums and should be used as a starting point for salary negotiations. Vestries/Bishop's Committees should be seriously considering appropriate compensation.
- **d.** For easier administration, all compensation figures will be rounded up into amounts divisible by 12.

- e. Each Vestry or Bishop's Committee, working in consultation with their clergy, shall approve a resolution determining the housing allowances for the following year. This IRS requirement shall be completed by December 31<sup>st</sup> of the year preceding the commencement of the allowance.
- **f.** For clergy who are paid a cash housing allowance, the amount of the housing allowance shall be determined by negotiation between clergy and Vestry/Bishop's Committee.
- **g.** The 2006 Housing Allowance Guideline is \$15,611 and is included in the compensation amounts stated above. Any congregation that furnishes housing for the Fair Market Value that is less than the \$15,611 is encouraged to pay the difference in cash to the clergy. The value of housing that is decided shall be added to the cash salary in order to compute the total compensation for Church Pension Fund purposes.
- **h.** Congregations with assisting clergy are encouraged to classify the assistant's position into a category appropriate to the scope of the position.

## II. <u>Part Salaried Positions</u>

**a.** Part salaried clergy in charge of congregations will be paid according to the applicable range above, times the % as agreed for the position.

## III. <u>Benefits</u>

- **a.** A car allowance of \$6,600 will be provided, unless the clergy and Vestry/Bishop's Committee mutually determine by December 31 of the year preceding the commencement of the allowance that a mileage plan (using the current Internal Revenue Service cents per mile) will be provided for the year instead. Clergy are encouraged to consider use of pre-tax dollars by setting up a reimbursable expense account plan or have the congregation provide an automobile;
- **b.** The congregation will pay the mandatory Church Pension Fund Assessment on salary, housing, social security reimbursement and on utilities <u>(if</u> applicable).
- **c.** \$50,000 Group Life Insurance as provided by the Church Pension Fund at no cost to the congregation.
- **d.** The congregation must provide the Diocesan HMO Plan for clergy. For exceptions, please apply to the Office of the Treasurer. Clergy will receive full family medical coverage according to the terms of the Diocesan HMO Plan, paid for by the congregation. (Clergy hired prior to 1/1/95 may continue with the Preferred Provider Plan.)
- e. The congregation will pay the cost of Worker's Compensation coverage.
- **f.** The Temporary Disability Insurance Plan for clergy is provided by the Church Pension Fund at no cost to the congregation.
- **g.** Congregations will pay the clergy social security costs at 7.65% of salary and housing.
- **h.** Full Salaried clergy are entitled to one month (30 calendar days) of annual vacation with full stipend and allowances. This vacation time cannot be more than 45 calendar days in any one year, except by the agreement of the

Vestry/Bishop's Committee with the consent of the Bishop in Aided Parishes and Missions. (In other words, no more than 15 days can be carried over to the following year.) Congregations should encourage clergy to take vacation.

## IV. Part Salaried Clergy Benefits

- **a.** The congregation must provide the Diocesan HMO plan for Part Salaried clergy who are 50% or more Salaried. Part Salaried clergy who are less than 50% Salaried will receive the dollar value of the percentage of the value of a full coverage HMO plan. (Prior to the adoption of this policy, all Part Salaried clergy who are currently serving in a congregation, will be grandfathered into the type of medical coverage they now enjoy.)
- **b.** If qualified, Part Salaried clergy will receive the designated Group Life Insurance benefit as provided by the Church Pension Fund.
- **c.** The congregation will pay the mandatory Church Pension Fund assessment on salary, housing, social security reimbursement and on utilities (if applicable).
- **d.** Part Salaried clergy will receive the Federal guideline reimbursement of business mileage instead of a car allowance.
- e. The Temporary Disability Insurance Plan for Part Salaried clergy is provided by the church Pension Fund.
- f. Part salaried clergy are entitled to one month (30 calendar days) of annual vacation with agreed stipend and allowances. This vacation time cannot be more than 45 calendar days in any one year except by the agreement of the Vestry/Bishop's Committee with the consent of the Bishop in Aided Parishes and Missions. (In other words, no more than 15 days can be carried over to the following year.)

## V. <u>Other</u>

- **a.** Moving Expenses: Clergy will receive an allowance for moving expenses from the US Mainland, typically in the range of \$10,000 to \$15,000, depending on location.
- **b.** Sabbatical: Clergy are eligible for sabbatical leave at the ratio of one month per year of service in the congregation, to be available after the third year, and cumulative through the fourth year. The maximum amount of leave is limited to 4 months. The vestry/Bishop's committee shall annually budget funds to accumulate to provide pastoral and sacramental supply during the clergy person's sabbatical leave. Sabbatical leaves are provided for the benefit of both the congregation and clergy. Thus, before a sabbatical leave is granted, clergy agrees to serve the congregation for at least one year upon returning from the sabbatical. In addition, the request for sabbatical must be accompanied by a full and detailed description of the activities to be undertaken during the leave and, if granted, clergy shall submit to the Bishop and the Vestry at the end of the leave, a report on the accomplishments of the leave. Accrued but not taken sabbatical leave can be carried over to following years in the same parish/mission. Accrued but not taken sabbatical leave is not paid out at retirement.

c. Continuing education: Clergy are required by Canon and Diocesan policy to continue their education. The congregation should provide funds in its annual budget for this continuing education. The minimum recommended amount is \$600/year. This amount should accumulate if unused and can carry over to the next year. This fund should also be available for sabbatical expenses.

## VI. Supply Clergy Compensation

**a.** The minimum compensation for supply clergy shall be as follows:

One Service: \$135.00 Two Services: \$185.00 Each additional Service: \$85.00

Clergy will be reimbursed for travel (mileage or airfare) and housing (if applicable).

## ADDENDUM TO CLERGY COMPENSATION SCHEDULE

## Examples:

- 1. Clergy with 5 years service is called to serve in a Category E Parish/Mission. His minimum compensation should be \$54,828. These categories are minimums and should be used as a starting point in the negotiation; Vestries/Bishop's Committees should seriously consider appropriate compensation.
- 2. Clergy with 20 years of service is called to serve in a Category C Parish. Her minimum compensation should be \$79,560. These categories are minimums and should be used as a starting point in the negotiation; Vestries/Bishop's Committees should seriously consider appropriate compensation.
- 3. Clergy with 25 years of service is called to serve as a part salary vicar in a Category E Mission. The position is for 50% of salary. His minimum compensation should be \$32,886 (\$65,772 divided by 2 = \$32,886). These categories are minimums and should be used as a starting point in the negotiation; Vestries/Bishop's Committees should seriously consider appropriate compensation.
- 4. Clergy with 2 years of service is called to serve in a Category D church. His minimum compensation should be \$53,580. However, due to the parameters of the search and the scarcity of applicants, the congregation ended up paying the clergy \$70,000.

## Response to the Bishop's Address The 37th Annual Meeting of the Convention The Episcopal Diocese of Hawai'i October 29, 2005

There is an elephant in our Diocesan living room, and we all want to talk about it. As much as we want to discuss Bishop Chang's retirement, as much as his announcement deserves a response, perhaps the best response that we can give him will come from all of us as we support Bishop Chang, Dee his wife, and their family as they transition from one chapter of their life into the next.

Dear Bishop Chang,

We are deeply grateful to you for being the spiritual head of this Diocese, mentor to many, and chief risk taker. You honor us with your words, your challenge, and your transparency. Indeed, it was a risk on your part to ask us as a team to respond to your address and perhaps an even bigger risk on your part to ask me to be the chair once again, given the track record we have when I am at the microphone and you are in the audience. Nevertheless, I hope we have not failed you in this task.

Bishop, your story of getting in the car with two men whom you did not know was a personal story of risk and perhaps foolishness in the eyes of a casual observer. God did indeed protect you and perhaps even guide you to accept their invitation to share a ride, save some bus fare, and enjoy the free therapy sessions with Dr. Robert Campion. We give God the glory and praise that your tale did not end in tragedy, for you would not be here with us today.

But we as a committee wondered: maybe he figured out that over the course of 6 years at 5 days per week, and say 20 weeks per year, ... well maybe, just maybe, the scenario looks more like the recent MasterCard commercials:

"Riding with total strangers one day instead of taking the bus: \$4.50 (saved!).

"45-minute therapy session @ \$200/hour with Dr. Campion: \$150 (saved!).

"Doing this almost every day for 6 years: \$11,700 (saved).

"Arriving safely at the National Church Office ("815"): ...priceless!"

"There are some things money can buy, but for everything else, there's faith in Jesus. Accepted by people in many countries, but still many more people to tell. Use your faith in Jesus today and tell somebody what He's done for you."

God does provide for those who work in "815" and are obedient to his call!

When God calls us to mission undertakings, we often will not have all the answers before we embark upon that first step. Yet He bids us to come, believe, trust, and see. "Follow me!" he said to Philip, not "I have a wonderful plan laid out for you in my new self-help book entitled 'Your secret to happiness in just 3 short years!' and

for just 3 easy payments of \$29.95 it can be yours. Call now! Operators are standing by!" No, He says: come just as you are. Trust me. And as you point out, Bishop, our predecessors at the 36th Annual Meeting of the Convention (or AMOC!) decided to take the plunge, to trust, to make the decision to adopt the Diocesan strategic plan, without a full appreciation of the risks, challenges, and opportunities connected to that decision.

You have called us, and God has called us, not to turn back, not even to look back as we put out hand to the plow as Jesus says in Luke 9:62. We come just as we are: broken, tired, cheerful, tearful, willing and able to fulfill the call to mission. Not as we once were, but as we are now, people filled with God's Holy Spirit and empowered for ministry.

We accept your gentle coaching that we can and will respond to God's call in new and vibrant ways. Whether it was Mission Fund 2005 or Hurricane Katrina relief, you have pointed out to us that we can accomplish so much when we rally around a cause. We take up your challenge to designate Mission Fund 2006 to the Diocese of Guatemala, and we await the joyous reports from our brothers and sisters there. Have we been too bold? Who are we, this Bishop's Address Response committee, to commit us to such action as a Diocese? Yet bold action is what you call for, Bishop, and I pray we will be firm in our efforts to be bold for the Gospel.

A major finding of the task force on the Strategic Plan is that "The Plan" is nonvisible, or in plain language, "INvisible." Who has read this thing? Why is it so long (18 pages)? What does it mean? Will I have to give something up? Why do we have to change? Or as our ancestors put it: What do you mean we have to leave Egypt, Moses? Why can't we go back to the meat pots we enjoyed? Where's the water? We're thirsty! We're hungry! Manna again? Truly we will never be satisfied as we sit here pining away for the past. It reminds me of a story I heard recently from an article called "Don't stuff the dog."

"...actor Alan Alda, most famously of the TV show M\*A\*S\*H and more recently of The West Wing, recently wrote a book entitled, Never Have Your Dog Stuffed: And Other Things I've Learned. In it, Alda talks about how he had a beloved pet dog when he was eight years old. When the dog died, Alda was so sad about burying it that his father decided to have the dog stuffed instead.

"'We kept it on the porch and delivery men were afraid to make deliveries,' Alda recalled in an interview with Newsweek. He then continued, 'There are a lot of ways we stuff the dog, trying to avoid change, hanging on to a moment that's passed.'

"Churches seem to have a special proclivity toward 'stuffing the dog,' maintaining programs, buildings, and even members in an attempt to forestall necessary change. In the short term, it's sometimes much easier to stuff a church's pets than to acknowledge their death, grieve their loss, and give them an appropriate burial.

"These pets may take the form of programs that are tied more to history than to current effectiveness; they may be personal favorites, the 'pet projects' and ministries of influential leaders who don't want to let go of them; or they may just be familiar mutts that everyone agrees have passed their prime, but are more familiar (or maybe just cheaper!) than a new animal.

"But, like Alda's dog..., stuffed animals might bring temporary comfort to those inside the organization, but they may actually turn off or even frighten newcomers who aren't familiar with the history and meaning behind them. Whether it's a particular worship style, a ritual, an outdated program, or even a powerful clique within the church, visitors will usually be quick to notice that something's not quite right. They may not stick around to find out what, or why.

"...a potential danger is to bury the...dog without telling anyone that it died, or worse, without even acknowledging that it existed. Burying a dead dog does not diminish its significance to the church family. On the contrary, a proper burial should include celebration of the metaphorical pet's impact, as well as acknowledgment that some people will need to grieve the loss over a period of time. Even when everyone agrees that an animal is dead, a wise leader will allow time to process the loss, instead of just bringing home a new pet." (Quoted from "Don't stuff the dog," Angie Ward, Copyright © 2005 reprinted from *Leadership Journal*. On the web at www.forwardleadership.net.)

My brothers and sisters, what beloved "pet programs" do we need to bury? Are we celebrating their life-giving impact upon our lives and giving them a proper sendoff? And what new animal (or strategic plans) are we welcoming into our midst? Will we be able to love it, embrace it, forgive it when it makes "mistakes" on our church carpets? And ultimately, can we properly bury it when God calls us to?

Bishop Chang, you call us to be good pet owners, and more than that, good stewards of those gifts God has given us. It is time for us all to use the gifts God has given us to further His Kingdom here on earth. You call us to go forward in faith and with the strength that can only come from above. Following the examples of Jesus' disciples throughout the ages, let us not turn back, let us not shrink from the task ahead: to respond to the needs of the church and the world as faithful ministers of Jesus' love. Let's not be "clueless" about the Diocesan Strategic Plan: let us all commit to going home this week and reading, rereading, and committing to this plan and committing to action because of this plan, personally and corporately.

If we have been transformed, if we have been changed by the power of His Holy Spirit, then let us live it out loud in the world today, unashamed of our faith, unafraid of the unknown, and assured that God can and will do for us infinitely more than we can ask or imagine.

Diocese of Hawai'i: Imua! Forward!

Bishop, please sound the whistle for this train! This train is leaving the station.

All aboard!

#### Investment Income

Income from the Portfolio (Unrestricted), Von Holt and the Ing Fund represent a 5% total return distribution. Income from the Portfolio (Restricted) is primarily from the Episcopate Endowment Fund. The distribution is limited to the expenses related to the Office of the Bishop, (which includes his executive assistant. The distribution from the Harry & Katharine Kennedy Memorial Fund is to subsidize the planting of St, Nicholas mission. The diocese is the beneficiary of the investment income from the Catton Fund, Parke Trust, Prisanlee Fund and Valvon Fund. We do not have investment management oversight of these funds. The Catton Fund income is restricted by the donor for retired church workers. All investment income is net of investment fees (management and custodial fees).

#### Rentals: Apartments

This is the rental income from the Diocesan-owned apartments at Queen Emma Square.

#### Rentals: Parking

This income is from the Priory's rental of parking spaces in the parking lot behind the Diocesan offices.

#### <u>Interest</u>

This represents the interest on Diocesan cash accounts.

#### **Chronicle Donations**

This represents income to support the publication of the CHRONICLE.

#### **Miscellaneous**

This represents miscellaneous gifts and other income.

## CONGREGATIONAL SUPPORT

#### Individual Congregation Line Items

These line items financially support congregations (missions and parishes) to meet the necessities of congregational life. The requests are reviewed with the parochial reports and investment portfolios of the applying congregations. The Congregational Health & Growth Commission's recommendations regarding funding are based upon the congregation's ministries, evidence of movement toward self -sufficiency through stewardship, evangelism efforts, and proposals to undertake innovative ministries based on the awareness of Diocesan Strategic Plan and local priorities.

#### **Emergencies & Opportunities**

This line item provides funds to develop new opportunities for ministry or to cope with emergencies. It is available to congregations coping with operational needs while calling new clergy whose salary packages are difficult to project. It is also intended to help congregations that have had unpredictable changes in finances and leadership.

## **OTHER COMMISSIONS & MINISTRIES**

#### Christian Formation

The Christian Formation Commission (CFC) seeks to facilitate a network of people of all ages willing to share their stories, to provide resources for congregations and other diocesan groups, to identify, publicize and provide leadership training events, and to communicate and work with ministry groups beyond the Diocese. The funds will be used for training for such programs as Alpha, Catechesis of the Good Shepherd, Disciples of Christ in Community, and Education for Ministry; for scholarship for each congregation to attend the Hawaiian Island Ministries conference; for training events/conferences on the regional, diocesan, provincial or national levels; and for congregational resource materials and various administrative costs.

#### Church Leaders Conference

This line item provides the funding for annual training for vestry/bishop's committee members and other congregational leaders.

#### Commission on Native Hawaiian Ministries

This line item funds the Commission created in 1990 to train leaders of native Hawaiian ancestry and to be a focus for opportunities to minister to communities of Hawaiians in all congregations. CONHM works to bridge the gap between the native Hawaiian language and culture and the dominant Western language and culture to facilitate the acceptance, understanding, and proper implementation of the former. In addition, through meetings, conferences, shared ministries and other exchanges with the Anglican Indigenous Network (AIN), the Episcopal Council on Indigenous Ministries (ECIM), and the Indigenous Theological Training Institute (ITTI), this Commission maintains close contact with other indigenous peoples and their faith communities throughout the United States and other parts of the world. CONHM also offers various opportunities for education and mission.

## **OTHER COMMISSIONS & MINISTRIES**

#### Congregational Health & Growth Commission

This line item funds diocesan support for churches by means such as expert consultation and local and national training events. The Commission hopes to help build healthy multicultural congregations. Its support would include, but not be limited to, promotion of five year planning cycles for congregations, attendance at conferences, Start Up Start Over follow up, and church development education. The Commission encourages ministries to ethnic groups that have been underrepresented and hopes to help the diocese become more multicultural and deliberately inclusive of new groups. The commission also helps equip individuals and congregations to live their baptismal covenant through spreading the Good News of Jesus Christ. The Commission oversees the training events and ministries that help individuals and congregations invite the unchurched to join the fellowship of Christ.

#### Continuing Education Commission

This commission is responsible for encouraging clergy, lay leaders, and lay professionals to seek religious, professional, and personal growth continuing education opportunities, as well as provide an annual continuing education event and provide oversight for this program. Funding for this commission is provided through a diocesan endowment fund

#### Ministry Development

This line item funds clergy and clergy spouse conferences, seminarian financial support, deacons' gatherings, the needs of the Commission on Ministry, and the background checks for candidates for positions in mission congregations or on the Bishop's staff. These funds are administered by the Bishop's staff and by committees/task forces specially appointed by the Bishop for a particular activity or ministry.

#### Planned Giving

Priorities for 2005 include visiting congregations to increase awareness of planned giving and gift planning, develop a network of lay and ordained persons throughout the diocese and prepare a comprehensive plan for planned gifts, donor identification and grant writing.

#### Stewardship Commission

This line item funds the work of the Commission that equips congregations and individual Christians to be responsible stewards of our time, talent and treasure to support the spread of the Good News, the seeking of Christ in all persons. This Commission oversees the training events and ministries that help congregations develop effective local stewardship programs.

#### **Diversity Commission**

This Commission seeks to create on-going dialogue on racism, facilitate respect for diversity and promote healing, reconciliation and transformation in the members and institutions of the Diocese. This line item funds a clergy and lay workshop, training/facilitator recertification and needed resources for congregations and individuals.

#### Ecumenical/Inter Faith Relationships

This line items funds ecumenical and interfaith activities in Hawaii.

#### Environmental Action Commission

This line item funds the commission to create spiritual awareness, educate, and commit to work in partnership with other groups and environmental issues.

#### Episcopal Relief and Development Fund

This line item funds the work of the Diocesan Coordinator of the Episcopal Relief and Development Fund and the materials needed to support that ministry

## **JUSTICE, PEACE & PARTNERSHIP**

#### Millennium Development Goals Fund

In furtherance of Resolution #10 adopted at the 36<sup>th</sup> Annual Meeting of Convention in October 2004, and pursuant to General Convention Resolution D006, the Episcopal Diocese of Hawai'i commits 0.7% of its annual budget to fund international development programs which further the United Nations' Millennium Development Goals (MDG's) to:

- 1. Eradicate extreme poverty and hunger.
- 2. Achieve universal primary education.
- 3. Promote gender equality and empower women.
- 4. Reduce child mortality.
- 5. Improve maternal health.
- 6. Combat HIV/AIDS, malaria and other diseases.
- 7. Ensure environmental stability.
- 8. Develop a global partnership for development.

This line item represents 0.7% of the 2006 annual budget. Funds are sent to ERD to carry out the MDG's.

**Mission Fund Commission** 

This line item funds the costs of annual Mission Fund.

#### Provincial Synod Delegate Support

This allocation supports the expenses for our two delegates to attend the annual Synod meeting. Synod delegates and alternates are appointed by the Bishop from our General Convention Deputies and confirmed by the Diocesan Council.

<u>Sexual Misconduct Prevention/Response</u> This line item funds training and travel costs of those who attend the identification and prevention classes, as well as the costs incurred by the trainers. This training is required by national canons.

Hawaii Program for Formation of Spiritual Directors No funding in 2006. This program was completed in 2004.

#### Travel & Continuing Education

This includes inter-island travel (parish visitations, deanery & clericus meetings, search & vestry consultations, & other meetings), mainland travel (House of Bishops' meetings), spousal travel, continuing education and other unanticipated travel.

#### OTHER

This budget represents three areas of communications: Print media, the *Hawaiian Church Chronicle* diocesan newspaper, public relations/brochures, flyers etc., and information technology, which includes all electronic media.

#### Hawaiian Church Chronicle

Print includes production and delivery of the *Hawaiian Church Chronicle* in partnership with *Episcopal Life*. This partnership includes data entry, subscriber list maintenance, customer service, set-up, production, printing, postage and mailing by *Episcopal Life* staff and AFL Printing. Production includes editing and layout of 10, 8-page issues/year, full color front and back, and occasionally center spread. It also includes stipend for layout and graphic design and contingency for production of flyers, brochures and advertising/special interest materials.

#### Information Technology

The Web/Electronic media budget includes development of web, e-mail, and electronic communications strategies. Ongoing website design (with West Coast Technologies) and Internet host server (tierranet.org –contracted through West Coast Technologies). It also includes projected software programs, and cost of the Oceanic cable contract.

#### Strategic Plan Expenses

With the adoption of the Strategic Plan at the 2004 Convention, the work of implementation is now the responsibility of existing canonical bodies.

#### Travel

This amount includes cost for conference/educational/networking opportunities and delivery of services for neighbor Island and travel for Communications and MIS committees.

### NATION & WORLD

#### General Convention Deputy Support

Funds are accumulated over three years annually and held in reserve to support the eight deputies and two alternates from our Diocese to attend the General Convention. The 2006 General Convention will be held in Columbus, Ohio.

#### National Church Quota

This is the assessment we pay to the national church to contribute toward its work and ministry. It is based on Diocesan income, which includes parochial giving, unrestricted operating investment income and restricted investment income used to pay operating expenses for the respective years. The National Church asking is computed at a flat rate of 21% of the Diocesan income less a \$100,000 exemption. The 2005 assessment is based on 2003 diocesan income. The 2006 assessment is based on 2004 diocesan income.

#### Provincial Quota

Hawaii is part of Province VIII of the Episcopal Church, and this is the assessment we pay to help with Provincial programs and administration. The quota is based on an asking from our Province.

#### RETIREES

#### Medigap Program

The Diocese subsidizes a portion of the Medigap insurance benefits to eligible retired clergy and their spouses.

#### Pension Supplements

This portion of the budget subsidizes the pensions and benefits received by certain retired persons because the pensions they receive are based on compensation earned when Hawaii was a Missionary District and salaries were quite low.

The 2006 budget reflects a 4.5% increase as recommended by the Compensation Review Committee. No new retirees will be added to this supplemental plan because current retirement programs provide adequately for retirees.

## DIOCESAN SUPPORT EXPENSES

#### Audit Expenses

Each year, as required by the Canons, a certified public accounting firm audits the diocesan financial records and prepares a report. The 2004 actual does not include funding of mission congregation audits. The 2006 budget provides funding for the treasurers office to enable missions and aided parishes to comply with the canonical requirements for an annual audit.

#### Cathedral Maintenance

The Diocese pays a portion of the Cathedral's maintenance budget because of the presence of Diocesan offices in their facilities and the Diocesan use of the buildings for meetings. In this way, the Diocese as a whole helps support the Cathedral of our Diocese. The Diocesan Bishop is the "Rector" of the Cathedral.

#### Chancellor's Expenses

The Chancellor of the diocese uses this allocation for participation in the Western Chancellors' Conference, a computer research service and certain publications for the legal assistance given to the Diocese and its congregations and institutions.

(Continued)

#### Diocesan Convention

This covers the unreimbursed cost of holding the annual Diocesan Convention including area meeting costs, convention meeting costs, supplies, materials, postage, and Makule e Akamai award expenses (included under Formation Department in prior years). This cost is net of registration fees/meals and shared travel cost.

#### **Directors & Officers Insurance**

This is liability insurance to insure The Episcopal Church in Hawaii, its directors and officers. The increase in premium is due defending claims throughout the diocese in 2003, 2004 and 2005.

#### Legal & Related Expenses

This represents legal and related costs incurred by the diocese.

#### Meeting Costs: Other

These funds are for incidental costs for groups that meet for an entire day.

#### Meeting Costs: Travel

This represents travel costs for the neighbor island members, of Commissions and Committees.

#### Miscellaneous

This 2004 actual amount represents the travel and meeting costs for the Presiding Bishop's visit to Hawaii in 2004

#### Office Expenses

This amount includes telephone, copying costs, equipment maintenance, computer help, subscriptions, postage, equipment purchase, supplies, etc. The budget also includes the cost of software and computer upgrades and staff training.

#### Property Maintenance

This represents the maintenance of the apartments owned by the Diocese and includes utilities and repairs of apartments (Duplex and Cluett), the McCray Center and Office of the Bishop, Insurance (property, liability, & auto) and General Excise Tax.

#### Property Taxes

The Diocese pays the property taxes on the rental income from parking and apartments.

#### Staff Travel and Related Expenses

As part of their ministries, members of the Bishop's staff, travel to other islands and to the mainland for meetings, consultations and church related programs.

#### Treasurers' Consultations

This represents travel costs for the new treasurers from all our congregations to meet with the Diocesan Treasurer on matters relating to their duties and responsibilities.

With the permission of the family, we used \$1 million to pay down the EHH debt and allocated \$300,000 to restore the St. Barnabas' building fund. #### YOUNG ADULTS AND YOUTH

#### Camps and Conference Commission

The Camps and Conference Commission looks to develop programs that will introduce individuals to Christ as well as take those already in the Body to new levels of service as together we live out our Baptismal Covenant. The commission is responsible for providing summer camping programs including reinvigorating a residential summer camp program. Funds will be used to support summer programs, camper scholarships and conference costs, such as ECW Retreat.

#### **Emerging Generations Commission**

The Emerging Generations Commission seeks to "Encourage, empower, equip all the emerging generations to know and share the love of God through Jesus Christ by the power of the Holy Spirit."

This Commission strives to model a Christian community to be extended within the Diocese as it assists congregations in the formation of Youth and Youth Leaders. Annual activities include: Jr and Sr. High Retreat, New Beginnings, Happening, Provincial Youth Events, Episcopal Youth Event and Peer Ministry.

This Commission seeks to develop a network of Young Adults on all islands while supporting congregations in their development of Young Adult Ministries and provide programs at the Diocesan level that focus primarily on Young Adult spirituality. The Commission sponsor Vocare and island-wide Young Adult events.

This Commission seeks to reinvigorate Higher Education Ministry. We seek to build relationships and community among students, faculty and staff with in institutions of higher learning. This will start with the staffing of the MacCray Center at the University of Hawaii-Manoa, continue with student gatherings, worship services, spiritual development and involvement in Provincial and National Gatherings. Once established we propose to support development of comparable programs on the neighbor islands.

The Commission will assist interested congregations in the development of new worship experiences aimed at the Emerging Generations. We envision Emerging Worship as a cooperative effort. The Commission will contribute to the development of this joint ministry.

#### Episcopal Schools Commission

Their focus for the coming year is to work with school leadership to develop values and character education as they relate to the Episcopal identity

**BE IT RESOLVED**, that commencing with the proposed budget for the fiscal year 2007 (to be presented to the annual meeting of the Convention in 2006), the Diocesan Council prepare and present the proposed budget to the Convention at its annual meeting on a rolling, three-year cycle — i.e. a budget for the following fiscal year and the two subsequent fiscal years. The proposed budget presented to the Convention at subsequent annual meetings shall incorporate and modify (if and as necessary) the content of the budget adopted at the prior year's annual meeting.

## **RATIONALE/EXPLANATION**

1. The strategic plan, adopted at the 2004 Annual Meeting of the Convention, states "that the diocesan budget of the year following the adoption of the strategic plan be structured to reflect the objectives of the strategic plan." Many of the plan's objectives require multi-year planning. A three-year rolling budget process would facilitate such a planning process.

2. The commitment of resources in the current-year budget often implies a commitment of those resources for subsequent years (e.g., support given to aided parishes). Requiring the Council, its Departments, and the commissions to budget on a three-year rolling cycle identifies such multi-year commitments more clearly.

3. A three-year budget cycle for the Diocese will encourage (and at times may require) congregations and other entities of the Diocese to undertake similar budget planning. Such forward planning should increase the strategic focus of the Diocese and all of its component entities.

#### 37<sup>th</sup> Annual Meeting of the Convention of the Diocese of Hawai`i

#### **RESOLUTION #6**

Submitted by: the Standing Committee.

Be it resolved, that Section 1 of Article XI of the Constitution of the Diocese of Hawai`i be amended as follows (material to be deleted is struck-through; additional material is underlined):

#### ARTICLE XI

#### OFFICE OF THE BISHOP

Section 1. The election of the Diocesan Bishop, a Bishop Coadjutor or Suffragan Bishop, shall take place at the annual meeting of the Convention, when notice of such intention to elect has been given by the Standing Committee at least thirty (30) days prior to the meeting, or at a special meeting of the Convention which has been duly called by the Standing Committee for that specific purpose. The first ballot cast in the election shall be cast jointly and shall be the nominating ballot. Thereafter bBalloting shall be by orders with a majority of each order on the same ballot required to elect.

<u>Section 2.</u> The Bishop is the Chief Pastor of this Diocese and may officiate in the liturgical offices of the Church throughout the Diocese.

<u>Section 3.</u> Whenever the Bishop shall issue a pastoral letter, it shall be the duty of every minister in charge of a congregation on the Sunday succeeding its receipt to read said letter to the congregation at all services.

<u>Section 4.</u> All controversies between Rectors of two or more Parishes or between a Vestry and its Rector or between persons adversely claiming to be members of the Vestry of a Parish shall be referred to the Bishop for determination.

<u>Section 5.</u> In all matters affecting the Diocese or any congregation, where no procedure is specifically provided by the General Constitution and Canons or this Constitution and the Canons of the Diocese, the Bishop shall have the power to act for and on behalf of the Diocese or such congregation.

Rationale:

The experience of some of the other dioceses within The Episcopal Church has demonstrated that it is prudent for any individual under consideration as a nominee for the office of Bishop to have undergone a background check prior to being nominated for that office. It is not possible for background checks to be conducted for individuals nominated from the floor at the meeting of the Convention at which the election is to be held. Accordingly, it is necessary to delete the method of nomination that is presently set forth in Section 1 of Article XI of our Constitution. The amendment should be passed on its first reading at this annual meeting and should be considered at the next annual meeting of the Convention to be adopted on its second reading prior to the election of our next Diocesan Bishop.

The procedure for nominating individuals who are not brought forth in the search process will be developed in detail by the Standing Committee. Members of the Convention will have the opportunity to propose other nominees after the names of the individuals who are being brought forth by the Search Committee have been made public. Any such nominees will then undergo the same background check as those who were considered in the search process. The overall process, whether it is embodied in a special order of business or a canonical provision or a combination of the two, will ultimately be subject to the approval of the Convention.

**BE IT RESOLVED,** that "Canon 13. The Diocesan Council" be amended as follows:

## Canon 13. The Diocesan Council

Sec. 13.1 There shall be a Diocesan Council (hereinafter referred to as the "Council") which shall be composed of the Bishop Diocesan, the Bishop Coadjutor and the Bishop Suffragan, if there be such, six (6) clerical members, twelve (12) lay members-at-large elected by the Convention and one (1) each from the Counties of Hawaii, Kauai, and Maui (hereinafter referred to as a "County Council member"), who may be either clerical or lay, elected by the Convention. Prior to the election, the members of the Convention from the County whose County Council member is up for election shall hold a caucus at which at least one (1) nominee shall be selected. Such nominee(s) shall be the only nominee(s) upon which the Convention shall vote in electing such County Council member. Members shall be divided into three classes so that the terms of two clerical members, four (4) lay members-at-large and one (1) County Council member shall expire each year. Each lay member shall be, at the time of election, at least eighteen (18) years of age and a communicant and each clerical member shall be canonically resident in the Diocese of Hawai'i. The Council shall have power to fill vacancies occurring through any cause in its membership-at-large elected by the Convention, for the

remainder of such term. A vacancy in a County Council membership shall be filled by a person from the County from which such vacancy exists until the next annual meeting of the Convention, when such vacancy shall be filled by election for the unexpired term in the manner set forth above. A permanent vacancy shall be declared to exist upon the majority vote of the entire membership of the Diocesan Council when a member shall have been absent, without cause, for three (3) successive regular Diocesan Council meetings or for a period of three (3) successive months, if more than three (3) regular meetings have been held within such period. A majority of the members shall constitute a quorum; provided, however, that the quorum shall contain a minimum of two (2) clerical members. No member, who has served a full three-year term, shall be eligible for re-election until the annual meeting of the Convention next following the annual meeting at which said term expires. The terms of the members shall be three (3) years; however, they shall remain in office until their respective successors have been elected. No member shall serve concurrently on the Standing Committee.

## **Commission on Ministry**

In 2005, the COM continued the work begun following the 2003 General Convention to respond to the changes in the Canons on ministry (Title III).

#### Lay Ministry:

We defined the requirements and guidelines for several licensed (lay ministries), specifically, those for Eucharistic Ministers (EMs), Eucharistic Visitors (EVs), and Catechists.

#### Ministry in the Diocese of Hawai'i

Guidelines for Discernment of Ministry in the Diocese of Hawai'i was recently completed and covers:

\*Ministry in the Episcopal Church
\*Discernment
\*Preliminary Steps in the Ordination Process
\*Checklist for the Ordination Process for both Diaconate and Priesthood
\*Frequently Asked Questions
\*Formation Grids

The COM has overseen the ordination process for several people in the process, including meeting with the parish discernment committees who work with those discerning a possible call to ordained ministry, interviewing persons for Postulancy or Candidacy, interviewing and reviewing the General Ordination Exams (GOEs) of an individual who completed seminary and was applying for ordination.

The COM commissioned a task force of laity, deacons, and priests in 2004 to study and recommend a program for the vocational diaconate and its role in the Diocese of Hawai'i. The goal is a program for the formation of a well-functioning, spirit-filled diaconate in 2006.

The COM proposes to sponsor a program called "Context for Ministry" in 2006, whose purpose is formation in the understanding of lay ministry and ordained ministry and discernment of each person's call to ministry, whether lay or ordained.

The work of the Commission on Ministry is done through our monthly meeting. The members of the Commission on Ministry for 2005 are:

## **Companion Diocese Relationship with Okinawa Commission**

The formal Companion Diocese Relationship with Okinawa began in 2000 and was extended for another three years at the 2002 convention. The suggestion of a companion diocese relationship was first introduced at the 1995 convention by the former HEPAM, (Hawai'i Episcopal Pacific Asiamerica Ministry). It was encouraged because of historical ties beginning with Bishop Harry Kennedy who was the overseer of the ministry there after WWII. In 1967, Okinawa was made the Missionary Diocese of the Episcopal Church and our former bishop, Edmond Browning, became the first bishop. In 1972, Okinawa was turned over to the Nippon Sei Ko Kai, which is the Anglican Church in Japan. The English-speaking congregation at All Souls' Church has had the Rev. Norio Sasaki and the Rev. Bob Walden of Hawai'i as priests serving the congregation.

In partnership with the Hawai'i Episcopal Youth, the commission sent eight high school teens and two adult leaders from Hawai'i to Okinawa in 2001 for a joint mission with the Okinawa young people. Later in 2003, eight students, a youth leader and two adults from Okinawa visited Hawai`i, and with Hawai'i's nine students and adult leaders, participated in a program called "Alive in Christ." Meaningful spiritual and cultural sharing was experienced.

Other activities included producing a simple cookbook with recipes of local foods shared by several churches. It was translated into Japanese and sent to each congregation in Okinawa. Local members also hosted and helped several visitors and students from Okinawa throughout the years. In 2001 the Rev. David Kennedy and Sue Ann Wargo represented our Diocese at the 50<sup>th</sup> anniversary celebration of the Diocese of Okinawa. On going is the prayer calendar done by congregations in both dioceses. In May of 2005, Mr. Andrew Tomimoto, the Secretary of the Okinawa Diocese and also the chair of Companion Relationship Committee, and the Rev. John Tanahara visited Hawai'i and met with commission members to evaluate and discuss the future of the relationship. It was agreed that the official relationship, which expires this year, not be renewed. However, it was encouraged that the close relationship and ties with members and congregations continue, and that other programs especially the youth groups consider programs with Okinawa. It was also agreed that we continue to pray for each other.

In October, Bishop and Mrs. David Tani and other members of the Okinawa Diocese will attend the 37<sup>th</sup> annual meeting where a resolution addressing the relationship will be introduced.

The commission is grateful to the clergy, laity and programs for the support and encouragement given to the partnership with Okinawa.

## **Compensation Review Committee**

With thanks to and on behalf of the Committee comprised of the Rev. Bill Allport, the Rev. Patton Boyle (who relocated midway through the year), the Rev. Paul Kennedy, Austin Nakoa, and the Rev. Hollis Wright (Resource Department representative) the following report is submitted:

- 1. After much analysis and discussion, the CRC is submitting a compensation schedule reflecting a 10% increase over the current year. The rationale behind this recommendation was presented in meetings held throughout the state in August, September and October. Due to the nature of the topic, meetings were held separately with clergy and with the laity (consisting of lay convention delegates, wardens and treasurers). For the neighbor islands, one laity and one clergy meeting was held on Hawai'i, Kaua'i, Maui and Moloka'i (laity only as clergy attended one of the O'ahu meetings). On O'ahu, three clergy and laity meetings were held, with a fourth laity meeting being scheduled for mid-October at the time of this writing.
- 2. Additionally, two changes are being submitted to the auto allowance:
  - a. Adjust the auto allowance to catch up to the current AAA index. The 2005 AAA index is \$7,142 with the current allowance being \$6,041. Thus, the recommended change for 2006 is mid way to the index, or \$6,600, with the remainder to be recommended at next year's convention.
  - b. Allow congregations and clergy to mutually determine if the auto allowance should be the flat rate mentioned above or if it should be provided in the form of mileage reimbursement, following the standard Internal Revenue Service cents per mile formula.
- 3. CRC is also recommending a block of funds of \$14,400 be allocated in the budget for diocesan staff salary increases to be allocated at the discretion of the Bishop.
- 4. From the budget meetings held statewide, the CRC has been charged with evaluating more closely our Bishop's compensation package, work which is just underway at this writing.
- 5. CRC is recommending a 4.5% increase for the pension to diocesan retirees.
- 6. CRC met with Diocesan Council, Commission on Ministry, the Standing Committee, Congregational Health and Growth, and the Strategic Task Force Group on Clergy Recruitment, Retention, and Professional Development for feedback and comments to our recommendation.

The Committee would like to acknowledge and thank Mr. Peter Pereira for his tireless work and support to this committee, and to the Diocese.

## **Congregational Health & Growth Commission**

The Congregational Health and Growth Commission worked towards helping congregations develop their own strategic plans by offering training to trainers that would be willing to go back to their congregations and help other congregations in the Diocese. The trainers were given tools to align the congregations' strategic plans in alignment with the Diocesan Strategic Plan that was adopted in the 2004 Convention. Thirty-five trainers attended the training.

The Commission sent Mimi Wu and Amado Yoro to Seattle, Washington, to attend the Episcopal Asian American Consultation Ministry Conference. The theme was Equipping The Saint: Finding Our Voice, Discovering Our Gifts and Sharing Our Stories. There were discussions on the issues of leadership development, stewardship, church growth, and other concerns of the Asian American congregations and ministries in the Episcopal Church.

During June 2005, the Commission sponsored a workshop for Clergy, Wardens, and Treasurers. The speakers were Hugh Jones from the Department of Taxation, and Deputy Chancellors Wayne Yoshigai and Ray Kamikawa. The attendees were briefed on legal issues of employment, taxes, and regulatory requirements as they concern congregations.

Training Via Media trainers was held in September 2005, for those congregations that purchased Via Media and those looking to use Via Media for evangelism or formation programs.

Being Da kine...Multicultural, a workshop for clergy and their spouses new to the Diocese of Hawai'i, was held in October. It was to help the clergy understand the various cultures of Hawai'i. Topics covered in the workshop were: Growing up Local and Da Jesus Book, Cultural Competencies, pastoral ministries with the Filipino and Hawai'ian people, and the lawsuits, sovereignty and a People's Identity of the Hawaiian people.

Addressing the Diocesan Budget 2006 began in February of 2005 with the development of the Resource Request forms as well as a matrix to evaluate how well the replies were aligned with the Diocesan Strategic Plan. This is the third year of a 5-year plan for 2 congregations working toward independence from diocesan support. Support for these congregations has been at levels to help them achieve the goal. Recommended support for some congregations was at levels sufficient to provide a supply clergy with a challenge to improve their stewardship, evangelism, and community outreach. Other congregations in transition because they have new clergy or are in the process of searching for new clergy were given support they requested. The Commission recommended the greatest percentage of the congregational support be given to St Nicholas, the new church plant.

## **Ecumenical Relations**

For the past four years Ecumenical Relations and Interreligious Dialogue have been at a standstill in our Diocese, as it has been in many other Episcopal Communities. Among the reasons for this somewhat static situation are our own internal problems within the Episcopal Church, agreements with other Christian Churches which have not been implemented, and a decreasing interest in Ecumenism.

In the Diocese of Hawai'i the most notable priority ecumenically has been with our sisters and brothers in the Evangelical Lutheran Church in America. The licensing of Lutheran clergy and the appointment of a Lutheran pastor to St. Philip's, Maili, are positive steps in living ecumenically.

In general, various Christian communities share the some agreement on many issues of social justice locally, nationally, and internationally. Theological issues such as intercommunion, human sexuality, and the role of women in ministry are areas of some disagreement.

As with many issues in the Church, the implementation of Ecumenism is most effective at the local level, both parish and diocesan. In the Diocese of Hawai'i we may be at a time that is ready for another forward thrust in Ecumenical Relations and Interreligious Dialogue. This can be effectively accomplished by a vibrant ecumenical committee in each parish, by a study of the agreements reached with others in ecumenical dialogue, and by joint ecumenical activities including common worship, mutual ecumenical education, and services and projects needed in our local communities.

Also the chaplain from Hawai'i Preparatory Academy on the Big Island of Hawai'i, the Rev. Walter Stevens, accepted our invitation to fly to O'ahu to meet with Brian. Brian preached at the Cathedral and then took off for Maui. He was hosted there by the Rev. Heather Mueller-Fitch and the Rev. Marvin Foltz. The Rev. Ricky Melchor facilitated an evening with Brian at Good Shepherd.

The annual ERD convention in San Diego at the end of May was full of news about the tsunami relief efforts. ERD says it was tsunamied by your wonderful response to the tragedy in South Asia. # **Native Hawaiian Ministry Report**

In January, the Rev. Darrow Aiona, Mahi Beimes, Melanie Holt and her daughter, Jasmine Bostock (who aspires to become an Episcopal priest one day), attended the WINTERTALK XVII gathering in Wewoka, Oklahoma. The theme was ordination, and we were honored to participate in the ordination of Native American Debbie Royals to the transitional diaconate. Participants included Bishop Mark MacDonald of Alaska, Bishop Michael Smith of North Dakota, Bishop Carol Gallagher of Southern Virginia, the Rev. Canon Hone Kaa from Aotearoa (New Zealand). Malcolm Chun and Linda Sproat, along with other members of the Episcopal Council on Indigenous Ministry (ECIM), planned the awesome event, which was attended by numerous native Americans from many different tribes who also witnessed the eventful ordination. Linda Sproat and Malcolm Chun helped plan the gathering as members of the sponsoring Episcopal Council on Indigenous Ministry (ECIM).

In April, CONHM attended the 9<sup>th</sup> biennial gathering of the Anglican Indigenous Network (AIN) held on the Pala Indian Mission reservation in Pala (San Diego), California. As AIN Secretary-General and member of the hosting ECIM, Malcolm Chun spearheaded the gathering, along with the other ECIM members, including Linda Sproat. Delegations of 5 representatives from the host Native Americans, Native Hawai'ians, First Peoples of Canada, Maori from Aotearoa, and Aborigines from Australia and the Torres Islands Straits, included 3 indigenous American bishops, a Maori bishop, and an Aboriginal bishop. CONHM delegates included the Rev. Darrow Aiona (Clergy), Kainalu Chong (Youth), Paul Nahoa Lucas (Educator), David Sproat (Elder), and Mahi Beimes (Women). The women's group agreed to schedule a follow-up indigenous women's gathering here in Hawai'i, which will be held November 7–10, 2005, at the Kilauea Military Camp (KMC) on the Big Island.

In May, Ka Papa Anaina and the Native Ministries Study Board (NMSB) jointly sponsored a prayer service, lecture, and pa`ina at St. Mark's in Kapahulu. The guest lecturer was the Rev. Canon Hone Kaa, visiting from Aotearoa (New Zealand). Another Ka Papa service and a NMSB lecture on *pono* — one of the core Hawai'ian values — by Malcolm Chun is scheduled for Saturday, October 8<sup>th</sup> at St. Clement's Church.

In August, CONHM was delighted to be awarded a \$7,000 New Opportunities Grant from the Office of Native American Ministries, ECIM, and the National Church. The money will be used to support our plan to work with native Hawai'ian Episcopal youth and adults to mentor and raise up new church leaders to take and share our gifts by celebrating the Holy Eucharist in the Hawai'ian language in congregations on this and each of the other islands where there are native Hawai'ian Episcopalians.

# **Report of the Historiographer**

# **Archival Facilities**

Through the courtesy and support of St. Andrew's Cathedral and the Office of the Bishop, a space in the Cathedral precinct has been renovated to house the archival collections of The Episcopal Church of Hawai`i. The collections were removed permanently from commercial storage at Crown Pacific and transferred to the Cathedral grounds in August. They are stored on chrome-plated steel shelving in a secured 24-hour temperature and relative humidity controlled storage vault. An adjoining reading room is available, by appointment, to the church membership and greater community for viewing documents from the collections.

# **Collections Development**

Collecting primary source materials, such as photographs, documents and registers, is essential for the growth of any archives. Additions to the Church's archival holdings this year include: photographic prints from St. Andrew's Priory; letters of Hawai`i bishops from an ebay auction (funds for purchase provided by John Lockwood); photographic prints from the estate of The Rev. John Engelcke; and back issues of the Hawaiian Church Chronicle from the HCC office.

# **Collections Management**

An assessment of the collections is now taking place to determine the housing requirements for the different types of material in the collections (i.e. acid- and lignin-free folders for manuscripts; archival boxes for photo albums and scrapbooks; mylar sleeves for photographic prints; phase boxes for rare books, etc.). Once archival supplies are delivered, the collections, which are now stored in cubic foot cartons or banker's boxes, will be reorganized into smaller units for easier access and handling. Due to specific storage requirements, photographs have been separated from manuscript collections and arranged in file folders by parish or church organization.

# **Exhibit Development**

A collection of photographic portraits of the Bishops of Hawai`i, obtained from `Iolani School, was re-matted and reframed and now hangs in the entry corridor to the Bishop's office.

# **Pest Management**

As part of a comprehensive pest management program, the 41 boxes housing the archival collections were sent to Bishop Museum for freeze-sterilization. Island Movers was contracted to facilitate the move. Any new acquisitions now entering the Archives are bagged in plastic to prevent contamination of existing collections. Due to the expense involved, materials are sent for freeze-sterilization only when a sufficient amount is gathered. For ongoing monitoring for pests, sticky traps have been laid in both the storage vault and reading room.

# **Public Access**

A brief presentation and preview of the new archival facility was given to participants at the Annual National Episcopal Historians and Archivists Conference earlier this summer.

# **Resource Development Department**

During 2005, the Resource Development Department carried out its mission to identify, manage, and enhance the assets and resources of members, congregations, and the diocese to focus on transforming the diocese and its congregations to vibrant faith communities, on growth, and on reducing the administrations costs of the diocese consistent with the Diocesan Strategic Plan. Our department had two representatives on each of the other departments as members, which greatly enhanced communication among the departments, and the overall functioning of the Council.

The Department monitored the performance of the investments in the diocesan portfolio, and met with all our investment managers and our investment consultant. We recommended the replacement of one fund manager to Diocesan Council. We reviewed the diocesan financial reports including the balance sheet, cash flow and unexpended funds. We reviewed the 2004 Audited Financial Statements.

The Department monitored congregations' payments of their assessments and other obligations to the diocese and proposed actions to take in response to delinquencies. We monitored the Camp Mokule`ia financial reports as required by Diocesan Convention Resolution. We supported the management change of Camp PECUSA.

The Department met with the insurance agent for the diocese and reviewed insurance needs and options and recommended to Council that we change our carrier to Church Insurance Company – Vermont.

The Department reviewed General Convention resolutions that relate to our areas of responsibility and discussed with other departments and commissions how to respond to those resolutions. We met with the Rev. Brian Grieves to discuss the Episcopal Church's approach to socially responsible investing.

The Department consulted with other departments about the uses of the Frances Adams Fund, helping congregations comply with EPA requirements for cesspools, and the funding of lease payments for missions on leasehold land.

The Department coordinated the developing of the 2006 Draft Budget and facilitated the Council's deliberations on the budget. We recommended lowering the assessments to 21%.

The Department reviewed lease agreements and other contracts entered into by various congregations as required by the Diocesan Canons and referred those needing Council approval to Council and those needing Standing Committee approval to that body.

The Department drafted a resolution to Diocesan Convention to provide for a three-year budget process and explored the feasibility of launching a capital funds campaign.
