The Opening Song and Prayer

The Bishop's Address

Bishop Fitzpatrick addressed The 44th Annual Meeting of the Convention of the Episcopal Diocese of Hawai`i.

Report of the Credentials Committee

Ms. Karen Sender reported that 49 clergy delegates and 125 lay delegates were present. Bishop Fitzpatrick determined that a quorum was established and declared The 44th Annual Meeting of the Convention of the Episcopal Diocese of Hawai'i duly constituted.

Action Item. The Credentials Committee made the following motion:

Be it resolved, that the members of the lay delegation from Christ Church, Kealakekua, be admitted to seats and votes in this Annual Meeting of the Convention.

The motion passed. The lay quorum was amended and 129 were present.

Action Item. The Credentials Committee moved to grant seat and voice to clergy licensed in The Episcopal Diocese of Hawai`i: The Rev. Helen Harper, The Rev. Anna Joo, The Rev. David Oh, The Rev. Gaylord Hitchcock, and The Rev. David Turner; to lay members of The Diocesan Council who are not delegates: Ms. Penny Chu, Mr. John Decker, Mr. Tom Kelly, Ms. Amy Null, and Ms. Mary Schulz; to lay members of the Standing Committee who are not delegates: Ms. Cecilia Fordham; and to Chairs of Reporting Committees/Commissions who are not delegates: Ms. Donna Oba (Compensation Review), and Mr. Jim Putnam (Finance and Administration). The motion passed.

Report of the Committee on the Dispatch of Business

Action Item: Rev. Jackson moved the Adoption of the Agenda as circulated and set forth in the Booklet of The 44th Annual Meeting of the Convention of the Episcopal Diocese of Hawai'i with the addition of two special orders as time allows from Camp Mokulē'ia and the Priory School. **The motion passed.**

Consideration of Resolutions

Resolution #1: Second Reading of "Amendment to Article I of the Constitution of the Protestant Episcopal Church in the Diocese Of Hawai'i"

Be it resolved, that Article I of the Constitution of the Protestant Episcopal Church in the Diocese of Hawai'i be amended in its entirety to read as follows:

Article I

TITLE AND BOUNDS OF THE DIOCESE

This Diocese shall be known as "the Diocese of Hawai'i" and its geographical boundaries shall be coextensive with those of the State of Hawai'i.

And that this amendment to the constitution, having been adopted at the last Annual Meeting with approval by a two-thirds majority of each order voting separately thereon, and approval by the Bishop, be immediately adopted and effective.

The resolution passed with a two-thirds majority in each order and Bishop Fitzpatrick consented to the amendment of the constitution, effective immediately.

Resolution #2: 2013 Minimum Clergy Compensation & Benefits Policy of the Episcopal Diocese Of Hawai'i

Be it resolved, that the 2013 Minimum Clergy Compensation and Benefits Policy of the Episcopal Diocese of Hawai`i be adopted.

There are no video clips this year. We have celebrated the past. We have reflected on the past 150 years. This evening we will have a birthday party. The journey of faith and the promise of hope is not over. Now, I rise to speak to you about today – right now -- and tomorrow. This bishop's address is going to be simple. Much is what many of you have heard me say on my visits in the past year.

Every day as I say Morning Prayer, I include Paul's direction from the first letter to the Corinthians: "Therefore, my beloved, be steadfast, immovable, always excelling in the work of the Lord, because you know that in the Lord your labor is not in vain." (1 Corinthians 15:58) It has become a source of certainty and strength for me. I know Jesus Christ to be my Lord and Savior, and that we – you and I – are about the work of building and living – if only for now and only in a small corner of God's creation – the Reign of God. We are fulfilling in this place – if even for an instant – God's intention for all of love with justice, and healing and holiness.

I have now been the Bishop of Hawai'i for over five years. I am deeply grateful to you all and to God for this ministry. I give thanks every day for the preparation I received serving as Bishop Chang's Canon to the Ordinary. He is an invaluable teacher.

I have a small, dedicated staff. Everyone in the office has taken up more duties. Liz Beasley, Peter Pereira, June Choriki and Irina Martikainen work tirelessly to support me and to serve you – God's people of this Diocese. Liz, Peter, June and Irina, Mahalo.

Likewise planning this Sesquicentennial Convention has been an adventure and Carol Arney has carried the load. Thank you, Carol.

Two people are unpaid, yet I depend upon them -- Stuart Ching the diocesan Historiographer and Martha Im, the Chancellor. To you both, thank you.

As many of you know, this has also been an interesting year for my family. My son, Ed, is a First Lieutenant with the 91st Cavalry Regiment, a light Airborne Reconnaissance Squadron serving with the 173rd Airborne and currently halfway through a nine-month deployment in Afghanistan. My younger son, James, not only works as an intern at St. Elizabeth's in Palama – he rides a motorcycle thanks to one of the Priests of this Diocese. In the midst of such worry, Bea is a support for me. I am blessed by having Bea in my life and by our sons. I thank God for them every day.

These past few years have not been easy. We all know too well that it has included the worst economic crisis since the Great Depression. Now, as the visitor industry has begun to rebound, we have yet to measure the impact of Hurricane Sandy.

The two wars of the United States of the past decade have had a deep impact on lives in Hawai'i. We are a community with deep military connections, and repeated deployments of both those stationed in the Islands and local National Guard units have taken a toll. This Veteran's Day weekend, I am reminded of those who have sacrificed all and those who have served on our behalf. Please, my sisters and brothers, keep those who now serve and have served in the military in your prayers and in your care.

All of that said, I have seen us come together in recent years. We have cared for those in responding to New Zealand after the earthquake and to Japan after the tsunami with generousity. I have experienced the Spirit in our midst and a focusing of our mission.

As your Bishop, I am blessed with wonderful Clergy with whom to share ministry.

Some have completed advanced academic degrees – Michael Barham a Doctor of Ministry and David Jackson a Ph.D. The Priests have served in complicated times and have provided care for God's people. Some have secular employment and serve, and many "officially" retired still serve at the altar nearly every week. The Archdeacon is now also officially retired, but she too continues to serve. Thank you, Pat. Frank and Norma Chun are amazing chaplains to retired clergy. On a personal note, Father Tom Yoshida has decided to fully retire and will no longer be listed on the supply list. Tom and I shared ministry at St. Luke's some years ago early in his retirement. To all who supply and give in retirement, mahalo.

I am excited by the developing shared ministry on the Windward and Leeward coasts of Oahu. The shared ministry of St. George's, St. Timothy's and Joy of Christ Lutheran Church is taking shape, and now the conversation is expanding to include St. Nicholas and St. Philip's. The move on the Windward side has been a bit slower, but congregations are working together. I hope we will continue to actively seek to share ministry and break down the walls of congregationalism

for true regional mission to meet the needs of those in our neighborhoods. I will have more to say about shared ministry in a moment.

I am always strengthened by the exciting ministry of our communities of faith. The jazz festival and expanding ministries at St. Michael's rock Lihue and all of Kauai. The ministry at St. James cannot be contained on Mauna Kea and has rolled down to the beach on Saturday evenings. St. Peter's Holy Ground still explores emerging worship and community on Sunday evenings. Other churches are seeking those with no faith in new ways and venues – be on the lookout for new things at St. Clement's and St. Andrew's. You can join St. Nicholas – and the Rock Star Priest -- online for worship every week.

I am humbled by your ministries of service. St. Elizabeth's inclusion and care of the Palama neighborhood and the residents of Mayor Wright Housing have produced a church that sings in several languages. The spirit of Saimone Lino has continued to inspire ministry. May God bless his soul. Food banks at St. Stephen's, St. Clement's and many other churches continue to meet the needs of the hungry. Care of the homeless goes on in parks, at beaches and in shelters. I even walked into St. Jude's Church in Ocean View recently to find the Church converted into a free veteranarian clinic to spay and neuter dogs. We care in many ways for our communities and those in need. Thank you. I am proud of our Diocese.

The transition of the Diocese resulting from Convention's reorganization of Council will continue in 2013. You have amazing servants in your elected leaders. I appreciate their service, their wisdom, their support and their prayers.

I make note especially of the Standing Committee. I have often asked the Standing Committee to help me with tough decisions and to aid in the course of the Diocese. The President of the Standing Committee, Cecilia Fordham, as so many times before, has been a wise counselor.

The Diocesan Council has been moving to function like a board of directors, having been reduced in half to twelve members by last year's Convention. New Commissions have been created to oversee expenditures and direct the work of committees and task forces.

As I told the neighbor island budget meetings, I think the budget you have before you is at best an outline. Much work still needs to be done, as focusing the mission of the Diocese will press the Council to adjust the budget to meet emerging needs.

In 2012, we saw the need to be nimble as Campus ministry at UH-Manoa was revitalized thanks to the work of a new committee and in partnership with Lutheran Church of Honolulu. The Korean ministry was inaugurated as we welcomed David Oh and Anna Joo – again made possible by a sharing of resources and ministry from the Diocese, the Priory School and the Cathedral, and with a genrous gift from St. Luke's Church – and, of course, the help of Archbishop Kim and the Church in Korea. The Pacific Island ministry has continued.

The Planned Giving Committee has more than doubled the size of the Legacy Society. One moment here: I expect everyone in this room – as leaders of the Church – to make provision for the ministry of the Church in your wills or through planned giving. Every member of the clergy – especially those who are retired or nearing retirement – should remember the Church. I would urge clergy to specifically name the Diocese – even the Episcopate Fund – to ensure the future governance of the Diocese.

"Each of you must give as you have made up your mind, not reluctantly or under compulsion, for God loves a cheerful giver." 2 Corinthians 9:7

When Paul uses the word "cheerful giver," he uses a Greek word that is the root of the English word "hilarity." Not just cheerful, but true hilarity – with joy. That is how I pray we give of our time and of our money, of our very lives, for the love of Jesus Christ.

Another use of the word by Paul is in Romans 12. Paul lists the gifts given to us as members of the Body of Christ: "We have gifts that differ according to the grace given to us: prophecy, in proportion to faith; ministry, in ministering; the teacher, in teaching; the exhorter, in exhortation; the giver, in generosity; the leader, in diligence; the compassionate, in cheerfulness."

The compassionate – the mercy giver – in hilarity.

Perhaps our calling as the followers of Jesus Christ is to live with hilarity – with joy and maybe foolishness.

I am often asked about my vision for the Diocese. I think the vision for the Church – any Church, at any time -- is summed up by Jesus when the followers of John the Baptist ask if he is the expected One:

"And he answered them, 'Go and tell John what you have seen and heard: the blind receive their sight, the lame walk, the lepers are cleansed, the deaf hear, the dead are raised, the poor have good news brought to them." Luke 7:22

That is the mission of God. We are to take the love of Christ into the world with hilarity – with joy and foolishness.

How do we do that ministry? It will need to be locally adapted.

I do think we need to do this with "Shared Ministry."

Shared Ministry is the gathering of communities of faith for a common ministry on an island or in a region of Oahu. It may be formal, with agreements, or less formal. Realistically I think it is going to mean a reallocation of resources and an evaluation of what we have.

I have asked the Standing Committee and the Diocesan Council to form an Asset Management Task Force. This team is to help evaluate the property of the Diocese and the sites of our churches. How can we best use what we have to share the story of God's love and to serve those in need?

Likewise, I hear regularly how hard it is to get people to sit on committees or to find someone to serve as the treasurer. I will spend more time training lay leaders in the next couple of years. I have asked Peter (Pereira) to develop a standard chart of accounts for all churches and an accounting system to support volunteer treaurers and bookkeepers.

In the end, how can we best work together for the mission of God? Historic accidents of location and identity must be evaluated. Congregationalism and isolation of churches will not serve the mission of God. Together we have the skills and resources for ministry. This may mean sharing clergy, but also sharing lay leadership and working as one team on projects and in starting new ministries and congregations.

As a Diocese, there are some things we can do better together than on our own. For example, I will be hiring a new youth coordinator before the end of the year. We all owe St. Peter's Church, Honolulu, for allowing their staff – especially Mike Woods and Jar Pasalo – to take the lead in youth ministry in the Diocese. It is again time for the Diocese to have someone devoted to youth ministry.

This vision of a shared ministry with God's people working together throughout the islands will demand new models of formation for ordained Ministry and lay leadership. There is now a local education program for the priesthood: Waiolahui'ia; and there is a local community of education for the vocational diaconate: Naimiloa. Some – especially younger candidates – will still go to seminary in North America or New Zealand. I hope there will be several deacons in every community, and that the clergy team will include priests formed in various ways and some who have secular employment.

The purpose is to create communities of faith and to engage mission opportunities where "the blind receive their sight, the lame walk, the lepers are cleansed, the deaf hear, the dead are raised, the poor have good news brought to them."

We must get over the wasteful notion of one congregation in one building with one priest. We can cast off the poor stewardship of buildings standing empty during the week.

The mission of God is about being the Body of Christ. We share Jesus Christ by word and action.

In December, an ABCD (Asset Based Community Development) Workshop for Church Renewal will be offered here on Oahu. This is one model for discerning God's will and direction in mission to the community. It has been offered on Maui in the recent past.

Shared ministry, local formation for leadership, and creation of new congregations and engaging in new mission opportunities require us to work together and to talk. Above all else we must pray – and dance and laugh – together.

We are not in this alone. We can learn from and with other Anglicans —especially from Aotearoa and the Philippines, but also Taiwan and Korea. We can look to our sisters and brothers in The Episcopal Church.

In the end, we must do Church the Hawai'i way – different from The Episcopal Church in the United States, but still part of The Episcopal Church.

Local theology, local mission, local Hawaiian style.

What do I ask of you - the leaders of the Diocese?

Be involved in training and education – as learners and teachers.

Call out new leaders – lay and ordained.

Study the Bible – especially the Gospel of Luke and the Letter of James.

Get your hands dirty – to serve the hungry, the lost, and the lonely.

Help me find the uniquely Hawaiian way of being the Body of Christ and engaging God's Mission. Together –

- o In Shared Ministry
- o By raising and forming Leaders for these islands
- So that new communities of faith new congregations will be created and we can engage in service with and for our communities.

All to make disiciples of Jesus Christ and to serve Christ in the rejected and the outcast.

Go and tell what you have seen and heard: the blind receive their sight, the lame walk, the lepers are cleansed, the deaf hear, the dead are raised, the poor have good news brought to them.

And, my sisters and brothers, laugh.

And as we continue the journey of faith and seek to fulfill the promise of hope, when you can, pray for me.

"Therefore, my beloved, be steadfast, immovable, always excelling in the work of the Lord, because you know that in the Lord your labor is not in vain." (1 Corinthians 15:58)

RESOLUTION #1: Second reading of Amendment to Article I of the Constitution of the Protestant Episcopal Church in the Diocese of Hawai'i

BE IT RESOLVED, That Article I of the Constitution of the Protestant Episcopal Church in the Diocese of Hawai'i be amended in its entirety to read as follows:

ARTICLE I

TITLE AND BOUNDS OF THE DIOCESE

This Diocese shall be known as "The Diocese of Hawai'i" and its geographical boundaries shall be coextensive with those of the State of Hawai'i.

And that this amendment to the Constitution, having been adopted at the last annual meeting with approval by a two-thirds majority of each order voting separately thereon, and approval by the Bishop, be immediately adopted and effective.

BE IT RESOLVED, that the 2013 Minimum Clergy Compensation and Benefits Policy of the Episcopal Diocese of Hawai'i be adopted.

RATIONALE/ EXPLANATION

The 2013 Minimum Clergy Compensation Schedule includes a 2% increase for all categories.

The 2% increase is less than the 3.6% increase in cost of living for Hawaii and the U.S. nationwide. The Committee supports maintaining a competitive compensation level, recognizing that Hawaii's cost of living is one of the highest in the nation. The Committee is also mindful of the current economic challenges in the U.S. and globally; thus the recommendation for a smaller increase than the cost of living increase. Nothing prevents a congregation from paying its clergy an amount greater than the minimum.

Per the 2012 AAA quidelines, the automobile allowance for 2013 will be \$8,780.

Regarding Mutual Ministry Review: Compensation provides a means by which Congregations enable Priests to exercise and express a professional vocation entrusted by God and affirmed by the Church. Inherent to the sacred trust shared by Priest and Congregation is the mutuality and accountability of communion. The following schedule and terms articulate the shape and expression of this mutuality and communion by providing the minimum expectations of compensation and professional support, according to various conditions necessary for life and ministry in the Diocese of Hawai'i. These minimum expectations articulate the base by which we support and affirm the ministry and leadership of our Priests. As an important part of our mutuality of ministry and life in communion, compensation must be considered and developed with clear expectations of ministry and presence. In order to achieve this, all Priests providing ministry and leadership beyond supply ministry will have a mutually agreed upon: Letter of

Agreement; Position Description (to include a statement of ministry and professional goals); and biennial Mutual Ministry Review. This Mutual Ministry Review should discern and provide for the continued mutual life, ministry and vitality shared by Priest and Congregation.

Materials, resources, and guidance for Letters of Agreement, Position Descriptions, and Mutual Ministry Reviews are available from the Office of the Bishop.

An agreement among the Clergy, Wardens and Vestry/Bishop's Committee to a biennial discussion and mutual review of the total ministry of the Parish/Mission allows for the following:

- The opportunity to assess how well they are fulfilling their responsibilities to each other and to the ministry they share,
- The establishment of goals for the work of the Parish/Mission for the coming year(s),
- The identification of areas of conflict or disappointment that may be adversely affecting mutual ministry which may then be addressed appropriately, and
- The clarification of expectations of all parties to help reduce possible future conflicts and if any occur, make them more manageable.

A mutually agreed-upon third-party may be engaged to facilitate this process. (The Clergy Compensation Review Committee suggests that this resolution with the attached schedule be presented and discussed with the Diocesan community around the State in pre-Annual Meeting gatherings with Clergy, Lay Delegates, Wardens and Treasurers as scheduled by the Diocesan Council)

I. Full Salaried Positions

- **a.** The compensation categories and ranges are intended to be used as a framework within which the Vestry/Bishop's Committee and the clergy negotiate a mutually acceptable compensation. The compensation ranges are based on "years of service" to provide a guide for compensation increases as years of service increase. This compensation schedule sets the minimum for churches in the Diocese of Hawaii. "Years of service" means the number of years of status as a clergy person in good standing in The Episcopal Church in the USA. In Parishes, compensation is negotiated between the clergy person and the vestry. For Missions, compensation is negotiated between clergy and the Bishop's Committee with the approval of the Bishop. Credit for prior years of service as an ordained person in-good-standing in another denomination is negotiated between the clergy and the Vestry/Bishop's Committee with the approval of the Bishop. With respect to clergy newly called or appointed to a congregation, the Vestry/Bishop's Committee is required to notify the Treasurer of the Diocese as to the number of years of service at which they enter the Compensation Schedule approved by Diocesan Convention. In order to maintain accurate records, a schedule will be attached to the Parochial Report reporting the clergy compensation and the number of years of service as it increases each year.
- **b.** Clergy must be paid at least the minimum of the applicable category with salary reviews at least annually. Congregations and clergy should schedule and hold a biennial Mutual Ministry Review, complete with clear goals and objectives, mutual accountabilities and shared expectations by both the laity and the clergy.
- **c.** These categories are minimums and should be used as a starting point for salary negotiations. Vestries/Bishop's Committees shall seriously consider appropriate compensation.
- **d.** For ease of administration, all compensation figures will be rounded up into amounts divisible by 12.

- e. Each Vestry/Bishop's Committee, working in consultation with their clergy, shall approve a resolution determining the housing allowances for the following year. This Internal Revenue Service (IRS) requirement shall be completed by December 31st of the year preceding the commencement of the allowance.
- **f.** For clergy who are paid a cash housing allowance, the amount of the housing allowance shall be determined by negotiation between clergy and Vestry/Bishop's Committee.
- g. The 2013 Housing Allowance Guideline is \$20,460 and is included in the compensation amounts stated above. Any congregation that furnishes housing for a Fair Market Value that is less than the \$20,460 is encouraged to pay the difference in cash to the clergy. The value of housing that is decided shall be added to the cash salary in order to compute the total compensation for Church Pension Fund purposes.
- **h.** Congregations with assisting clergy are encouraged to classify the assistant's position into a category appropriate to the scope of the position.

II. Part Salaried Positions

a. Part salaried clergy in charge of congregations will be paid according to the applicable range above, times the % as agreed for the position.

III. Full Salaried Clergy Benefits

- a. An automobile allowance of \$8,780 will be provided, unless the clergy and Vestry/Bishop's Committee mutually determine by December 31 of the year preceding the commencement of the allowance that a mileage plan (using the current IRS cents per mile) will be provided for the year instead. Clergy are encouraged to consider use of pre-tax dollars by setting up a reimbursable expense account plan or have the congregation provide an automobile.
- **b.** The congregation will pay the mandatory Church Pension Fund Assessment on salary, housing, social security reimbursement and on utilities (if applicable).
- **c.** \$100,000 Group Life Insurance as provided by the Church Pension Fund at no cost to the congregation.
- **d.** The congregation must provide the Diocesan Health Maintenance Organization (HMO) Plan for clergy. For exceptions, please apply to the Office of the Treasurer. Clergy will receive full family medical coverage according to the terms of the Diocesan HMO Plan, paid for by the congregation.
- e. The congregation will pay the cost of Worker's Compensation coverage.
- **f.** The Temporary Disability Insurance Plan for clergy is provided by the Church Pension Fund at no cost to the congregation.
- **g.** The congregation will pay the clergy social security costs at 7.65% of salary and housing.
- h. Full Salaried clergy are entitled to one month (30 calendar days) of annual vacation with full stipend and allowances. This vacation time cannot be more than 45 calendar days in any one year, except by the agreement of the Vestry/Bishop's Committee and with the consent of the Bishop in Aided Parishes and Missions. (In other words, no more than 15 days can be carried over to the

following year.) Congregations should encourage clergy to take vacation.

IV. Part Salaried Clergy Benefits

- **a.** Part salaried clergy will receive the federal guideline reimbursement of business automobile mileage instead of the stipulated allowance.
- **b.** The congregation will pay the mandatory Church Pension Fund assessment of salary, housing, social security reimbursement and on housing utilities (if applicable).
- **c.** If qualified, part salaried clergy will receive the designated Group Life Insurance benefit as provided by the Church Pension Fund.
- **d.** The congregation must provide the Diocesan HMO plan for part salaried clergy who are 50% or more salaried. Part salaried clergy who are less than 50% salaried will receive the dollar value of the percentage of the value of a full coverage HMO plan.
- e. The congregation will pay the cost of Worker's Compensation coverage.
- **f.** The Temporary Disability Insurance Plan for part salaried clergy is provided by the Church Pension Fund.
- **g.** The congregation will pay the clergy social security costs at 7.65% of salary and housing.
- h. Part salaried clergy are entitled to one month (30 calendar days) of annual vacation with agreed stipend and allowances. This vacation time cannot be more than 45 calendar days in any one year except by the agreement of the Vestry/Bishop's Committee and with the consent of the Bishop in Aided Parishes and Missions. (In other words, no more than 15 days can be carried over to the following year.) Congregations should encourage clergy to take vacation.

V. Other

- **a.** Moving Expenses: Clergy will receive an allowance for moving expenses from the US Mainland, typically in the range of \$12,000 to \$20,000 depending on location.
- b. Sabbatical: Clergy are eligible for sabbatical leave at the ratio of one month per year of service in the congregation, to be available after the third year, and cumulative through the fourth year. The maximum amount of leave is limited to 4 months. The Vestry/Bishop's Committee shall annually budget funds to accumulate to provide pastoral and sacramental supply during the clergy person's sabbatical leave. Sabbatical leaves are provided for the benefit of both the congregation and clergy. Thus, before a sabbatical leave is granted, clergy must agree to serve the congregation for at least one year upon returning from the sabbatical. In addition, the request for sabbatical must be accompanied by a full and detailed description of the activities to be undertaken during the leave and, if granted, clergy shall submit to the Bishop and the Vestry/Bishop's Committee at the end of the leave, a report on the accomplishments of the leave. Accrued but not taken sabbatical leave can be carried over to following years in the same parish/mission. Accrued but not taken sabbatical leave is not paid out at retirement.

c. Continuing Education: Clergy are required by Canon and Diocesan policy to continue their education. The congregation should provide funds in its annual budget for this continuing education. The minimum recommended amount is \$950/year. This amount should accumulate if unused and may carry over to the next year. This fund should also be available for sabbatical expenses.

VI. Supply Clergy Compensation

a. The minimum compensation for supply clergy shall be as follows:

One Service: \$163 Two Services: \$219

Each additional Service: \$107

Clergy will be reimbursed for travel (mileage, airfare, etc.), overnight parking and housing (if necessary).



ADDENDUM TO MINIMUM CLERGY COMPENSATION SCHEDULE

Examples:

- 1. Clergy with 5 years service is called to serve in a Category 4 Parish/Mission. Minimum compensation should be \$71,844. As a minimum this should be used as a starting point in the negotiation. Vestries/Bishop's Committees should seriously consider appropriate compensation.
- 2. Clergy with 20 years of service is called to serve in a Category 2 Parish. Minimum compensation should be \$103,464. As a minimum this should be used as a starting point in the negotiation. Vestries/Bishop's Committees should seriously consider appropriate compensation.
- 3. Clergy with 25 years of service is called to serve as a part salary vicar in a Category 4 Mission. The position is for 50% of salary. Minimum compensation should be \$42,780 (\$85,560 divided by 2 = \$42,780). As a minimum this should be used as a starting point in the negotiation. Vestries/Bishop's Committees should seriously consider appropriate compensation.
- 4. Clergy with 2 years of service is called to serve in a Category 3 church. Minimum compensation should be \$69,684. However, due to the parameters of the search and the scarcity of applicants, the congregation agreed to pay the clergy \$85,000.

1 a **Assessments**

The proposed assessment for the 2013 to 2015 budget is 20% and is based on each congregation's 2011 to 2013 operating income. For the entire history of this Diocese the assessment rate has been 20% or higher. Historically, the total assessment is shown below:

The Diocesan Council does not currently foresee a change in the 20% assessment rate in 2013, 2014, or 2015.

1 b Investment Income

Income from the Portfolio (Unrestricted), the Von Holt Fund, and the Ing Fund represent a 5% total return distribution. The diocese endowment spending policy is five percent of its endowment fund's average market value over the prior twelve quarters. Income from the Portfolio (Restricted) is primarily from the Episcopate Endowment Fund. The distribution is limited to the expenses related to the Office of the Bishop–Episcopate, (excludes the Bishop's Secretary). The Diocese is the beneficiary of the investment income from the Catton Fund, Parke Trust, Prisanlee Fund, and Valvon Fund. We do not have investment management oversight of these funds. Income from the Valvon trust fund is down because the fund has not recovered from the economic meltdown. The Catton Fund income is restricted by the donor for retired church workers. All investment income is net of investment fees (management and custodial fees).

Rentals

1 c Apartments

This is the rental income from the diocesan-owned apartments (6 units) at Queen Emma Square. One of the units is provided to St Andrew's Priory to house the school's Chaplain.

1 d Parking

This income is from the Priory's rental of parking spaces in the parking lot behind the diocesan offices.

1 e Interest

This represents the interest on diocesan cash accounts and from a loan that we refinanced for St Philip's, to assist them in making the loan payment, when Bishop Estate stopped renting St. Philip's Parish Hall and was replaced with a new tenant at a lower rent. We paid off the bank loan and lent the church the funds from our money market accounts.

1 f Miscellaneous

This represents miscellaneous gifts and other income.

1 g Emergency & Opportunities Reserve Fund

Any unused funds from the Emergencies and Opportunities current year allocation is transferred to this reserve fund. The current fund balance as of June 30, 2012 is \$70.300.

COMMISSION ON VIBRANT CHRISTIAN COMMUNITIES

The Commission on Vibrant Christian Communities shall have responsibility for congregational life and evangelism including leader formation, local congregational formation/education, evangelism, music, worship, ministry funding, stewardship, planned giving, new congregations, and congregational revitalization.

2 a Direct Congregational Support

These line items financially support mission congregations to meet the necessities of congregational life. Grace Church (Molokaʻi), St. Jude's Church (Hawaiʻi), and the Episcopal Church on West Kauai (St. John's Church, 'Ele'ele, and St. Paul's Church, Kekaha). These congregations serve isolated, economically challenged communities. There are other such communities in our Diocese, but these three congregations face particular challenges and have unique needs. For more information on these congregations, contact the Bishop.

2 b Audit Expenses - Missions

This line item provides funding for the Treasurer's office to enable missions and aided parishes (18 in total) to comply with the national canonical requirements for an annual audit. Parishes are also required to meet this requirement at their own expense. For more information on these congregations contact the Treasurer.

2 c Planned Giving Committee

This line item allows the Committee to meet the following priorities: visiting congregations to increase planned giving and gift planning opportunities by offering a program of education and providing direct support for congregations, and by working with the Episcopal Church Foundation (see http://www.episcopalfoundation.org/) on marketing, training, and gift planning. In 2010 the diocese had its first Hō'ike Ulu Legacy Society event to honor those good stewards who have remembered their congregations, the Diocese, or another ministry in their wills or estate plans. The Hō'ike Ulu Legacy Society events were held on all islands in 2011 and 2012. These events will continue in 2013-2015. For more information contact the Committee Chair, Jane Tonokawa, through the Treasurer's office.

2 d Stewardship Committee

This line item supports the ministry of the Stewardship Committee to develop or sponsor programs that engage the Diocese in a greater understanding of Stewardship with a focus on congregational giving. Moreover, the Stewardship Committee is a diocesan resource available for congregational consultation to encourage giving. The Stewardship Committee also participates in the wider stewardship discussion by participating in The Episcopal Network for Stewardship (TENS), Alban Institute, and other forums. For more information contact the Committee Chair, Lindsay Kamm, through the Treasurer's office.

2 e Treasurers' Consultations

This line item covers the travel costs for new treasurers from congregations to meet with the Diocesan Treasurer on matters relating to their duties and responsibilities. For more information contact the Treasurer.

2 f Christian Formation Committee

This line item allows the Commission to aid congregations in the areas of adult and children's education. This includes diocesan membership fees for such programs as Education for Ministry (EfM) and Godly Play. The amount listed funds the costs of speaker(s), logistical support, and some scholarship funds for diocesan formation events. The Christian Formation line item also supports congregations and educators seeking resources to support local Christian education initiatives. In the past, this line item also included the costs of developing and holding the Diocesan Convocation, an annual diocesan gathering for the purposes of formation and mission called for by the 2007 annual meeting of the Convention. In 2012 this line item was reduced because the Convocation in 2012 was replaced by the celebration of the Diocese's 150th anniversary. This line item was not restored for 2013 as the Diocesan Council reevaluates the mission and needs for formation in the Diocese.

2 g Commission Travel

This line covers the cost of travel and online meeting costs for Commission members to attend meetings.

2 h Congregational Health & Growth Committee

This line item funds programs that encourage congregational growth and evangelism, and directs grants to congregations that will help them build vital and vibrant Christian congregations in the areas of church growth, evangelism, and new member ministries.

2 i Emergencies & Opportunities, Current Year

This line item provides funds to respond to expected ministry opportunities or to cope with major emergencies. It is available to congregations that have called new clergy whose salary packages are difficult to project and/or moving costs must be covered, to help when congregations have had sudden or unpredictable changes in finances or leadership, and/or when the condition of facilities demand immediate attention. Any assistance granted to the congregation is considered a one-time, nonrenewable grant made during the current year.

2 | New Ministries / Projects

This line item was added to provide the Commission with funds to respond to requests in support of new ministry events/programs/projects. Also, this will also enable us to plan for more focused, strategic use of resources by Task Forces and congregations for evangelism and education.

COMMISSION ON MINISTRY

The Commission on Ministry shall have responsibility for education for ordination, lay leader training, licensed ministries, clergy retreats, continuing education, and ministry discernment.

3 a Commission Travel

This line covers the cost of travel and online meeting costs for Commission members to attend meetings.

3 b Diversity Committee

This line item funds training, communication, and resource development for the committee members, congregations, and individuals. This training was created and is maintained by resolution of General Convention. Based on our Baptismal Covenant promises to "seek and serve Christ in all persons, loving [our] neighbors as [ourselves]" and to "respect the dignity of every human being," this committee seeks to create dialogue on racism; to facilitate respect for diversity; and to promote healing, reconciliation, and transformation in our members and institutions.

3 c Ministry Development

This line item includes the following costs and they are explained below:

Clergy Conferences (\$23,500 for 2013 budget)

Clergy Conferences funds the expenses (mostly airfare) for two Presbyters' Days per year (meetings of the priests with the Bishop) and represents a substantial subsidy for the annual clergy retreat, held at Camp Mokule'ia. These events sometimes are led by the Bishop or a resident priest and sometimes have outside speakers. In using outside speakers, we have often been able to tag onto another event in order to reduce costs.

Community of Deacons (\$4,500 for 2013 budget)

This line item pays for two meetings per year of the Deacons of the Diocese with the Bishop, annual membership dues in the Association of Episcopal Deacons (AED) for both the Deacons and those in formation to be Deacons, attendance at an AED conference, and expenses of the work of the Archdeacon of the Diocese.

Ordination Process (\$13,000 for 2013 budget)

This line item covers the work of the Commission on Ministry related to the ordination process: discernment, psychological testing and background checks for those in the process, assistance with tuition costs for seminarians, and a partial funding of the cost of formation programs in the Diocese. Also included in are the cost of background checks for candidates for positions in mission congregations or on the Bishop's staff.

Ministry Resources (\$4,000 for 2013 budget)

This line item covers expenses for licensed ministries training, the purchase of some resources for clergy and congregations, and other miscellaneous funds for the formation of ministry throughout the Diocese.

3 d Sexual Misconduct Prevention / Response

This line item funds canonically required classes for the identification and prevention of sexual misconduct, as well as the costs incurred by the trainers. It includes, in some years, the costs of training kits or fees for "training the trainers" sessions. Training in preventing sexual misconduct against both children and adults is required by General Convention resolutions and by diocesan policy.

3 e Bishop's Staff: Canon to the Ordinary

This line item funds the compensation and benefits (namely, auto allowance, medical insurance, pension, social security and Medicare taxes, and worker's compensation insurance) for the Canon to the Ordinary.

Continuing Education for Clergy & Lay Professionals

Not included in the Diocesan Budget is money for grants toward Continuing Education for clergy and congregational lay professionals in the Diocese. These grants are funded from the income of an endowment fund especially set up for this purpose. The income is about \$25,000 per year. A Continuing Education Committee receives grant applications and approves grants up to \$1,500 per person per calendar year. Those receiving grants are expected to submit a follow-up evaluation of their experience and submit an annual report of their continuing education hours. Continuing education is required of all clergy by the Canons of The Episcopal Church. Diocesan policy sets the expected amount at 24 contact hours per person per year.

COMMISSION ON SHARED MINISTRY

The Commission on Shared Ministry shall have responsibility for ministries, activities, and programs by diocesan groups and/or facilitated by a team of congregations for individual and congregational growth, including summer camp, youth events, communications, regional ministries, ministries with the communion partners (ELCA), and yoked congregations.

4 a Advertising

This line item covers the cost of advertising in the phone books and in the military information booklets for all churches.

4 b E-Chronicle / E-News

This line item encompasses areas of communications within the Diocese: e-chronicle (diocesan electronic newspaper), e-news (biweekly electronic updates), public relations/brochures, flyers, etc., as needed. This line includes the funding for an independent contractor hired for this work.

4 c Internet/Website Support

This line item fulfills the work of the Internet Evangelism Project Task Group. The goal of the task force was to expand the pilot to include additional churches in opportunities to utilize websites to support diocesan and parish evangelism efforts to: (1) bring additional churches into the Digital Faith online community; (2) provide opportunities for churches, regardless of their participation in Digital Faith, to participate in conversations about success with using the Internet to reach out to others to proclaim the Gospel; (3) offer workshops on aspects of website development, and tools/resources available for creatively sharing the Gospel; and (4) offer on-site assistance when possible for handson instruction and advice in website development. The funding for the diocesan website is included in this line item.

4 d Camp Mokule'ia

This budget line item is to support the position of an Executive Director of Camp Mokule'ia. The recommendation for financial support for the Executive Director's position comes out of The Transition Action Team's 2009 recommendations for sustained leadership, vision, and oversight of the operation. This commitment was for three years starting in 2010. Starting in 2013, there is no funding for this line item.

4 e Commission Travel

This line covers the cost of travel and online meeting costs for Commission members to attend meetings.

4 f Korean Ministry

This line item provides for the salary of two priests from South Korea, Diocese of Seoul, who are working to reestablish the ministry for a Korean-speaking congregation. The

grant continues support begun during 2011 when funds were granted from the Emergencies and Opportunities Reserve Fund. This ministry is made possible by a partnership with St. Luke's Church (who has provided a car); the Cathedral and the Priory School, who each provide one-half of the cost of health insurance in exchange for some ministry time; and a \$5,000 grant from The Episcopal Church to cover program costs.

4 g Native Hawaiian Ministries Committee

This line item funds the Committee created in 1990. In recent years, the funds have largely been used for travel for individuals to attend meetings of the Anglican Indigenous Network (AIN), the Executive Council Committee on Indigenous Ministries (ECCIM), and the Indigenous Theological Training Institute (ITTI). This Committee maintains close contact with other indigenous peoples and their faith communities throughout the United States and other parts of the world and offers various opportunities for education and mission. The 2013 line allocation is the same as 2012. If programs or events of the Committee meet the criteria of fulfilling the Five Marks of Mission, funding may be available through diocesan or Episcopal Church grants.

4 h Pacific Islander Ministries Committee

This committee acts as a guide and provides resources for the Pacific Islander Ministry.

4 i Pacific Islander Ministry

This line item provides for the salary of the Missioner for Pacific Island Ministry. The intent of this ministry is to provide for and facilitate activities and services for the targeted group of the Pacific Islanders' youth and their families who have not had the privileges of engaging in activities because of financial and social reasons. This ministry will attempt to meet the needs of this targeted group by arranging services to include feeding, educational, recreational and social activities, pastoral visitations and church services. Congregations considering outreach ministries to Pacific Islander immigrants and desiring a consultation are encouraged to contact St. Elizabeth's Church.

Congregational Support

4 j St. Nicholas, Kapolei

This line item supports the only current diocesan Church plant and is, therefore, a shared ministry of the entire Diocese (http://www.stnickschurch.episcopalhawaii.org/).

4 j St. Philip's, Maili

This line item has supported the shared ministry with Maluhia Church (Evangelical Lutheran Church in America) on the Waianae coast of Oahu.

4 j St. Stephen's, Wahiawa

This line item supports the shared ministry with St. Luke's Church, Honolulu.

4 j St. George's, Pearl Harbor

This line item supports the shared ministry with St. Timothy's and Joy of Christ (Evangelical Lutheran Church in America) in Aiea.

4 k Windward Shared Ministry

This line item supports the shared cost of clergy support for the Windward Region. Part-time clergy serve the Kaneohe Episcopal Mission at the site of the former Calvary Episcopal Church, Emmanuel in Kailua, St. Matthew's in Waimanalo, and St. John's By-the-Sea in Kahaluu. Each of these four congregations also contributes to the clergy compensation and benefits.

4 | Youth and Young Adult Committee

This line item supports the work of the Youth and Young Adult Committee in providing programs for youth and young adults in the Diocese that are viable, thriving, spiritually refreshing, resourceful, cost-effective, and, most importantly, God centered.

An estimate of a breakdown of the budget is as follows:

Inter-Island Youth Events (\$36,000)

Three inter-island youth events per year would be funded at approximately \$12,000 each: "God Camp" (a residential summer camp program); Happenings (high school students) or New Beginnings (junior high school students), held in alternate years; and one to be determined (such as 30-Hour Famine, or the Provincial Youth Event, or Episcopal Youth Event).

Additional support to inter-island ministry (\$6,000)

This might support one of the above events if there is a high turn-out and a consequential budget over-run, but more likely would support trainings and travel of our youth and adult leaders to the mainland or for a mission experience.

University age program expenses (\$1,200)

MacCray House (\$15,000)

This covers the cost of keeping and maintaining the MacCray House near University of Hawai'i–Manoa for Campus ministry.

The Commission plans to devote the remainder (approximately \$30,000) toward the support of a youth ministry position in the Diocese.

4 m Bishop and Secretary

This line item includes the compensation and benefits for the Bishop Diocesan and the Bishop's Secretary.

4 n Bishop's General Convention Travel

This line item supports the annual allocations for the travel and meeting costs for the Bishop to attend the triennial General Convention of the Episcopal Church.

4 o Hospitality

This line item supports the Bishop's ministry who, as part of his episcopate office, hosts individuals and groups, exhibiting Hawai'i's aloha spirit, reciprocating hospitality, and developing partnerships.

4 p Keyman Insurance

This line item provides the insurance premium for the Bishop's life insurance benefitting the Diocese as the executive of the Diocese in the event of the Bishop's death.

4 q Travel & Continuing Education

This line item provides for inter-island travel (parish visitations, deanery and clerics meetings, search & vestry consultations, & other meetings), mainland travel (House of Bishops' meetings), spousal travel, continuing education, and other unanticipated travel.

4 r Lambeth Fund

This Fund was established to cover the cost of Lambeth. No annual allocation is needed for future budgets as the current Lambeth Fund balance of \$28,900 will be sufficient to cover our next Lambeth conference. It is maintained in the budget as a placeholder in case additional allocations are determined to be needed.

4 s Election Process Fund

This fund was established to accumulate monies for electing a new bishop. We did not use the Election Process Funds to pay for the election of the Bishop as the 2006 operating income was adequate to cover the cost of the election. No annual allocation is needed for future budgets as the current Election Process Fund balance of \$143,700 will be sufficient to cover our next Bishop election.

4 t Meeting Costs: Other

This line item provides funds for incidental and travel costs for meetings that arise because of emergencies or other unanticipated circumstances.

4 u Staff Travel and Related Expenses

This line item supports the ministries of members of the Bishop's staff, especially the Canon to the Ordinary and the Treasurer, to travel to all islands in the state and to North America for meetings, consultations, and church-related programs.

COMMISSION ON MISSION BEYOND THE CHURCH

The Commission on Mission beyond the Church shall have responsibility for ministries of justice, peace and reconciliation, being responsive to human needs beyond our walls, including Episcopal Relief and Development, seminary support, feeding ministries, interfaith/ecumenical, and relationship with the Anglican Communion partners and the Philippine Independent Church.

5 a Commission Travel

This line covers the cost of travel and online meeting costs for Commission members to attend meetings.

5 b Ecumenical/Interfaith Relationships

This line item supports efforts to build relationships with, and community among, other faiths through shared communication and participation in the areas of faith-based, spiritual, and social issues aligned with the mission of our Diocese. Institutional membership in The Interfaith Alliance Hawaii (TIAH) and representation on the Board of Hawai'i Council of Churches Fund (HCCF) are part of this support.

5 c Mission Ministries (global and local outreach)

This line item supports funds ministries that advocate for the marginalized, voiceless, dispossessed, needy, oppressed, or imprisoned, through partnerships within the Diocese, the larger Anglican Communion, and with other faith and secular organizations, local, national, and global. The diocesan Convention, at its annual meeting in 2006, mandated that 0.7% of the Episcopal Diocese of Hawai'i's budget be committed to community and international development programs in pursuit of the Millennium Development Goals (MDGs).

COMMISSION ON FINANCE & ADMINISTRATION

The Commission on Finance and Administration shall have responsibility for the corporate and financial needs of The Episcopal Church in Hawai'i including investments, property, compensation review, and budget formation.

6 a General Convention Deputy Support

This line item provides for the accumulation of funds annually to be held in reserve over three years to support the eight deputies and two alternates from our Diocese to attend the General Convention. The 2015 General Convention will be held in Salt Lake City, Utah.

6 b The Episcopal Church Quota

This line item funds the assessment the Diocese pays to The Episcopal Church to contribute toward its work and ministry. It is based on Diocesan income, which includes parochial giving, unrestricted operating investment income, and restricted investment income used to pay operating expenses for the respective years. The National Church asking, after deducting a \$120,000 exemption from Diocesan income, is computed at a flat rate. The rate was 21% for 2010. The rate dropped to 20% in 2011 and to 19% in 2012 and 2013. The rate is set at 19% for 2014 and 2015. The 2014 to 2015 assessment is based on the 2012 to 2013 diocesan income respectively.

6 c Province VIII Quota

This line item funds the assessment the Diocese pays to the Province. Hawai'i is part of Province VIII of the Episcopal Church, and this is the amount the Diocese pays to help with Provincial programs and administration. Through the Synod (the official meeting of representatives of the Province), the Province has set the assessment for 2013 at a minimum contribution of 0.3% of net disposal income, and for 2014, a minimum contribution of 0.35% of net disposal income from those dioceses currently contributing at or below that amount.

6 d Provincial Synod Delegate Support

This line item supports the expenses for two delegates to attend the Synod meeting. There is no funding for 2013.

6 e Bishop's Staff

This line item funds the compensation and benefits (namely, auto allowance, group life insurance, medical insurance, pension, social security and Medicare taxes, State unemployment taxes, temporary disability insurance, and worker's compensation insurance) for the Diocesan Treasurer (CFO), Accountant, and Events Coordinator/Office Manager.

6 f Archives

This line item covers the cost to maintain the archives for the Diocese of Hawai'i, including archival supplies, pest management, reproduction of images from other institutions, exhibits, and attendance by the Archivist at a professional development conference.

6 g Audit Expenses - Diocese

This line item covers the cost of a certified public accounting firm to conduct an audit of the diocesan financial records and to prepare a report as annually required by the Canons.

6 h Shared Cathedral Expenses

This line item pays a portion of the Cathedral's maintenance budget because of the presence of the Office of the Bishop in the facilities and because the Diocese uses Cathedral facilities for meetings. This is not income; it is a non-assessable building use

expense reimbursement as established by agreement of the Diocesan Council and the Cathedral's Chapter.

6 i Chancellor's Expenses

This line item allows the Chancellor to participate in the Western Chancellors' Conference, and provides access to a computer research service and certain publications in support of the legal assistance that the Chancellor's Office gives to the Diocese and its congregations and institutions.

6 j Diocesan Convention

This line item covers the unreimbursed cost of holding the annual meeting of Diocesan Convention, including area meeting costs, convention meeting costs, supplies, materials, and postage. This cost is net of registration fees/meals and shared travel costs. It also includes an amount for temporary staff help.

6 k Directors & Officers Insurance

This line item provides for liability (errors & omissions) insurance to insure The Episcopal Church in Hawai'i, its directors and officers. The insurance premium is based on our claims experiences and market conditions.

6 | Legal & Related Expenses

This line item represents legal and related costs incurred by the Diocese. Unexpended legal expenses up to \$5,000 will be set aside as a reserve to cover potential legal expenses relating to charges brought against a priest under the new Title IV disciplinary Canons. If legal expenses are fully expended then the funds will be set aside from end-of-the-year budget surplus.

6 m Meeting Travel

This line item covers travel costs for the neighbor-island members of Standing Committee, Diocesan Council, Compensation Review Committee, Cathedral Chapter, Commission of Finance and Administration and clergy meetings with the Bishop. We are increasingly trying to use video conferencing.

6 n Office Expenses

This line item includes telephone, copying costs, equipment maintenance, computer help, subscriptions, postage, equipment purchase, supplies, etc. The budget also includes the cost of software and computer upgrades and staff training.

6 o Property Maintenance

This line item covers the costs of maintenance of the Cluett apartments owned by the Diocese, and it includes utilities and repairs of the apartments and the Office of the Bishop, Insurance (property, liability, & auto), property management fees, and General Excise Tax.

6 p Property Taxes

This line item pays the property taxes on the parking lot and apartments rented for income by the Diocese.

6 q Security

This line item covers the Diocese's portion of the cost of maintaining security for the Queen Emma Square. The other Episcopal identities on the Square share the full cost of these services.

6 r Kapolei land

This line item covers the property taxes and expenses to maintain the property. Until a church facility is built on the site, the Diocese must pay property taxes.

6 s Medi-gap Program

This line item provides a subsidy to eligible retired clergy and their spouses to cover a portion of the Medi-gap insurance costs.

6 t Renewable Energy Project

This line item continues to support the Renewable Energy Project that was created by the 2010 Annual Meeting of the Convention to help the Diocese "explore the use and implementation of renewable energy options and the theological, financial and environmental implications for the Diocese, its congregations and institutions and (provide) information and (engage) with congregations and groups regarding the use of renewable energy options."

6 u St. George's Lease Rent

This line item covers the payments on the current lease with the Navy, which is due to end on December 31, 2013 ("Holdover status thereafter pending sale"). The Navy has declared the land "in excess," which means they intend to sell it. The Diocese is working with the Navy regarding the possibility of purchase once a price has been established and options are evaluated. The site is The Episcopal Church's Pearl Harbor Memorial and it has easy access to the Airport.

SUBJECT: ANNUAL REPORT OF THE TREASURER

The Balance sheet of The Episcopal Church in Hawai'i on December 31, 2011 showed assets of \$32,989,154; liabilities of \$14,877,899 (of which \$13,213,697 represents parish/mission investments balances); and net assets of \$18,111,255. The total operating income of the diocese exceeded operating expenses in 2011 by \$7,025. It should be noted that all congregations have paid their 2011 assigned assessments.

James Hasselman, CPA, audited our financial statements. The audited financial statement is posted on our web site. (www.episcopalhawaii.org/resources/(Forms & Documents)finance/audits)

Our audit shows that we have an adequate system of internal control. Appropriate parties must properly authorize all disbursements, and two authorized officers must sign all checks. Our audit committee met with the auditor to review the audit report

2012

- 1. In your Convention Packet, you will find the current Budget versus Actual Operating Report as of August 31, 2012. The report is summarized to cut printing costs. If you want a detail report, please call me.
- 2. In your Convention Packet, you will also find a report on our Theological Education Offering for 2011. You will note that we contributed \$27,546, which amounted to less than one-third of our 1% goal. Now is the time to be checking on the performance of your Parish or Mission this year so that we can meet our 1% goal in 2012.

- 3. Our Investment performance numbers are as follows: Year to date at 8/31/12 = 10.4%; trailing 12 months = 8.4%; 3 Year trailing = 7.9%; Since 6/30/92= 8%
- 4. During the year the Commission of Finance and Administration met with our investment monitor and managers to review the performance of our investment portfolio and also to review our Investment Policy. In March 2012, the Commission added an additional portfolio manager Boyd Watterson, a domestic Fixed Income Manager. We have a long-term view towards our portfolio management with the understanding that the stock market will experience fluctuations from time to time. We have a total return investment policy and spending policy. Our policies are implemented to ensure that there will be a steady stream of earnings annually, while at the same time ensuring that the fund assets will be there for the future. Our spending policy is set at a payout rate of 5 percent (5%) of the average market value of the Investment Fund over twelve quarters. The spending policy (which we will continue to review), together with sound investment performance, ensures that, over time, the fund will retain its ability to produce earnings. For more information, please go to our web site. (www.episcopalhawaii.org/resources/(Forms & Documents)finance/investments)
- 5. The setting up of the Shared Travel Expense Fund for the 2012 diocesan convention has been accomplished
- 6. The rate of assessment for 2012 to 2015 is proposed at 20%.
- 7. The Compensation Review Committee (CRC) is submitting a compensation schedule reflecting a 2% increase over the current year. Please refer to the CRC report and the 2013 Clergy Compensation and Benefits policy for details. I am working with the Church Medical Trust to implement the Denominational Health Plan (DHP)
- 8. During the year, I worked with treasurers advising and training them on various matters, such as taxes, accounting and audit, investments, insurance, parochial reports, employment, insurance and property issues. I also worked with them on refinancing loans from the bank at competitive rates for various renovation projects.
- 9. During the year, I coordinated with the auditors and treasurers to audit their churches' financial records. Thanks to the church treasurers for doing the audit work papers for the audit.
- 10. I am working with our Church Insurance Company of Vermont to renew our property and liability insurance renewal for the year 2013. In 2012 we stopped using an agent (AON) and I worked directly with Church Insurance Company of Vermont. This resulted in approximately \$50,000 savings in total premium for 2012.
- 11. I continue to work with the Church Pension Fund (CPG) to assist the churches in enrolling lay employees in the Lay Pension Plan.

- 12. We continue to hold training workshops for Safeguarding God's Children and Preventing Sexual Misconduct (adult). We are now using the Church Insurance web-based training available for Safeguarding God's Children.
- 13. Please use our website, www.episcopalhawaii.org. We are working to add more content to the web site. It has helped us cut down our copying and mailing costs.
- 14. I reviewed the update to the National Church Manual in Business Methods in Church Affairs
- 15. We continue to monitor the financial condition of Camp Mokule'ia.
- 16. The Planned Giving Commission had its third Legacy Society event in 2012, In 2012 the Legacy Society events were held on Hawai'i Island, Kaua'i, Maui and on O'ahu. We have increased our Legacy Society membership to 91. The purpose of the Legacy Society is to recognize those who have remembered their church in their estate plans, and -more so to enable members to witness to the value of their church in their lives and to secure ministries for generations to come. Thank you all for including your church in your will. Please go to our website to see the Planned Giving Material. (www.episcopalhawaii.org/resources/(Forms & Documents)finance/Legacy Society)
- 17. The Diocesan Stewardship Commission meetings began in March of 2010. In 2011, we spent our time doing Bible and book study, drafting our mission statement, goals and objectives and got trained on stewardship mentoring. The Commission also had stewardship conference training events on O'ahu and Kaua'i in 2011 and on Maui and Hawai'i Island in 2012. A workshop was also held for clergy in 2012. We are currently working on mentoring two congregations in conducting stewardship programs.

June and I would like to thank the treasurers, wardens and clergy whose work, cooperation and goodwill have helped us in our work. Many thanks also to the members of Diocesan Council, Commission of Finance and Administration and all its sub Committees, Diocesan Compensation Review Committee, Planned Giving Commission, Stewardship Commission, Chancellor and Vice Chancellors and Office of the Bishop staff. Thank you all for your support and the gifts you share with us.

I would also like to thank Sharon Billingsley for volunteering her time to assist me with various projects during the year.

National Canon Title 1-Canon 7 Sec.1(f)

All accounts of the Diocese shall be audited annually by an independent Certified Public Accountant. All accounts of Parishes, Missions or other institutions shall be audited annually by an independent Certified Public Accountant, or independent Licensed Public Accountant, or such audit committee as shall be authorized by the Finance Committee, Department of Finance, or other appropriate diocesan authority.

Diocesan Canon- Section 41.1.5

All accounts shall be audited annually by such an accounting method as shall be permitted by the Diocesan Council. All reports of such audits, including any memorandum issued regarding internal controls or other accounting matters, together with a summary of action taken or proposed to be taken to correct deficiencies or implement recommendations contained in any such memorandum, shall be filed with the Bishop or Ecclesiastical Authority not later than thirty (30) days following the date of such report, and in no event, not later than September 1 of each year, covering the financial reports of the previous calendar year. Those congregations that fail to comply with the September 1 deadline shall be reported by name to the next Annual Meeting of the Diocesan Convention and such report shall be recorded in the minutes of said Annual Meeting.

Review of activities:

The Commission on Ministry seeks mainly to follow, support, and evaluate people who are considering ordained ministry (the diaconate and priesthood), and to recommend the guidelines for licensed ministries. Also falling under our purview are clergy deployment, continuing education, safe church trainings, and other facets of leadership development in the Diocese. The COM meets as a committee with individuals at key points in the ordination process. We help guide people through the numerous steps involved, and assist in setting the direction for education. Since last year's meeting of the Convention, one person has been ordained to the transitional Diaconate and three to the Priesthood. One person graduated from seminary in May, and another person enrolled in seminary this past September.

The COM spent a major portion of time this year addressing local formation programs. We provided additional structure to the Na Imiloa program for prospective vocational Deacons. This group continues to meet monthly and currently has seven participants. We also reviewed possible means of local formation for the priesthood. To this end, the Diocese has become a participant in the Iona Initiative, a program for local formation, especially for rural dioceses, growing out of the Diocese of Texas. Currently, plans are being made for three students to start this program in January 2013. The group is called Waiolahui'ia.

Review of expenditures:

As of mid-October 2012 we have spent \$38,960. Seminarians receive \$1,000 per semester for tuition assistance. To sign on with the Iona Initiative cost \$10,000 this year, and will cost an additional \$10,000 in each of the next two years. Additional facets of the ordination process have cost \$12,156. Also covered in the COM budget are subsidies for the annual clergy retreat and the costs of, and travel for, several clergy continuing education days and gatherings during the year. We close with thanks to all who make our work possible. This includes the applicants, postulants and candidates, those helping with the diocesan education programs (Na Imiloa program for prospective vocational deacons and Waiolahui'ia for prospective priests), examining chaplains, individual mentors, discernment committees, Bishop's committees, and vestries. We give thanks to God for all of your assistance in this and, primarily, for the work of the Holy Spirit in all discernment.

Based on a 3.6% rise in Hawaii's cost of living last year and a thorough review of the work of last year's committee, the CRC proposes a 2% increase in compensation for 2013. The CRC continues to recognize that Hawaii's cost of living is one of the highest in the country. The committee is also mindful of the current economic challenges in the U.S. and globally, thus our recommendation for a smaller increase than the rise in the cost of living. We are committed to keeping our median compensation at the top of the nation, maintaining our competitive edge for attracting quality clergy. The CRC reminds everyone that we can only propose a minimum guideline; many congregations compensate their clergy above the proposed minimums.

For 2013, the CRC proposes the AAA automobile allowance of \$8,780.

The CRC has begun to analyze how our diocese might implement the decision of our past General Convention, providing equal medical benefits to both clergy and lay employees with a Denominational Health Plan (DHP). Please see Memo on Implementation of the DHP in your convention booklet

The only expense of the CRC is travel for neighbor island committee members.

The work of the CRC is most directly related to our second diocesan goal: transforming the Episcopal Church in Hawai'i and congregations into vital and vibrant faith communities. Healthy clergy create healthy congregations; when clergy are valued by their congregations, they perform better in their work. Appropriate financial care of our clergy, as well as the upholding of mutual ministry ideals, go far in the creation of vital and vibrant churches.

The Committee would like to acknowledge and thank Mr. Peter Pereira for his dedication and support to the CRC and the Diocese.

REVIEW OF ACTIVITIES

Acquisition highlights:

- Ceremonial silver trowel Used by Queen Liliuokalani to lay the cornerstone of the Theophilus Harris Davies Memorial Hall and Parish House on May 9, 1907. Later used by Bishop Harry S. Kennedy to lay the cornerstone of the final addition to the Cathedral building on February 10, 1958. Donated by Louise Schubert in memory of her mother, Virginia Dominis Koch.
- Prayer book Inscribed as being given by the Priory Sisters to Her Majesty Liliuokalani in July of 1894. Donated by Louise Schubert in memory of her mother, Virginia Dominis Koch.
- *Prayer book and hymnal set* Inscribed to Sybil Dominis by the Rev. Leopold Kroll, who became Missionary Bishop of Liberia in 1936 after serving at the Cathedral Church of St. Andrew in Honolulu. Donated by Louise Schubert in memory of her mother, Virginia Dominis Koch.
- Registers from St. Luke's Church, 1920-1995.
- Register of Church Services from Holy Cross Church, 1960-1991.

Sacramental Registers:

Canon 35 stipulates that "great care shall be taken to preserve church records," and "when a new Parish Register shall be begun in any of the Parishes or Missions, the old one shall be sent to the Registrar for safekeeping, unless the Parish or Mission has a place for safekeeping satisfactory to the Bishop. "To guard against theft (which did happen in one church) or damage from pest infestation, fire, floods, mold, mildew, paper embrittlement, and mishandling, rectors and vicars are encouraged to deposit their inactive registers with the diocesan archives. The registers will be preserved in archival housing in a secured and temperature- and humidity- controlled storage vault governed by an integrated pest management program. The records will still be accessible, and available for reference.

Registers that are presently stored in the diocesan archives include the following parishes and missions: Cathedral Church of St. Andrew, Christ Church, Church of the Transfiguration (closed), Holy Spirit (closed), Holy Trinity (closed), Kohala Mission Churches, St. Andrew's Priory School, St. Anne (closed), St. Barnabas, St. Elizabeth, St. James (Papaaloa), St. Luke, St. Paul (Makapala), St. Philip, St. Stephen (Waialua),

St. Stephen (Wahiawa), and Waikiki Episcopal Chapel. Baptisms, confirmations, and marriage records for residents of Hawaii Island, Kauai, and Maui, at the end of the 19th and beginning of the 20th centuries, are found in the Cathedral or Bishop's registers.

Exhibits:

- Davies Memorial Hall Ceremony— a small display of the recently-donated ceremonial trowel, along with an original program from the laying of the building's cornerstone in 1907, were displayed during a ceremony inaugurating restoration of Davies Memorial Hall on March 30th.
- Windows to Our Future Reception The first register of the Cathedral, along with a collection of Bibles and prayer books belonging to Hawaiian royalty, were displayed during a reception for members of the Office of Hawaiian Affairs on June 6th.
- Cleveland-Liliuokalani Lectures The Cathedral register with Queen Liliuokalani's baptismal record, along with her prayer books, were placed on view in Tenney Theatre on September 4th.

Sesquicentennial Activities:

- Gave a presentation at Waianae on September 3rd and in Tenney Theatre on September 4th on the relationship between the Hawaiian Monarchy and the Anglican/Episcopal Church in Hawaii. This was part of the Cleveland-Liliuokalani Lectures, Queen Liliuokalani Educational Project, sponsored by the Episcopal Church in Hawaii, Pacific Justice and Reconciliation Center, Office of Hawaiian Affairs, and The Interfaith Alliance, Forgiveness Project.
- Furnished photographic images and provided other support in the production of the documentary, "Grace and Beauty: 150 Years of the Episcopal Church in Hawai'I."
- Managed project to produce a facsimile reprint of the 1862 Book of Common Prayer translated into Hawaiian by King Kamehameha IV, and his Hawaiian-language preface translated by him into English. Digital scanning of the original book was made possible with the assistance of the Hawaii State Archives. Barbara Pope Book Design was contracted to do the book design and production. Printing of the book was done in the United States.

In 2012, Journals of the Annual Meetings of Convention of the years 2006 through 2010 were sent to the Archives of the Episcopal Church. We also posted all Journals of Convention back to 2000 on the Diocesan Website.

The CD version of the Journal of the 43rd Annual Meeting of Convention, October 29, 2011 shall be distributed to each church in the Diocese and to every Canonically Resident Clergy at the meeting of the 44th Convention on November 10, 2012.

According to Canon 9 of the Canons of the Episcopal Diocese of Hawai'i: It shall be the duty of the Registrar of the Diocese to receive and preserve in some safe place, the Journals of the Convention of this Diocese, the Journals of the General Convention, such other records as belong or shall hereafter belong to the Convention and all Parish Registers, documents and papers belonging to the Diocese, the Standing Committee or other Diocesan bodies or officers and not required to be kept by any other person or officer.

It is my determination that the safe place in this Diocese is in the Archives, which are managed by our Historiographer, Mr. Stuart Ching. The archives contain the fireproof safe specified in the canons, and are accessible to all on an appointment basis. During my tenure, I intend to establish a system for keeping the records of the meetings of Council and Standing Committee and other Diocesan bodies as well as the Journals of Conventions.

It should be noted that space is limited in the Archives, and at such time that the Diocese reviews its needs for additional space, that the Archives be taken into consideration.

Attachment # 16 Reports from the Diocesan Council

Diocesan Council Reports

At the 43rd Meeting of the Convention, the governance structure of the Diocese was reorganized. The Diocesan Council was reduced from 21 members to 12, and has assumed a role more like a board of directors. Committees have been restructured as well, and have sought to find membership from people with expertise in the subject. They are no longer automatically populated by members of Diocesan Council.

2012 has been a year of learning about the new responsibilities of each committee. Some committees have carried on almost without interruption and others have worked on reorganization.

Commission on Vibrant Christian Communities

The Commission on Vibrant Christian Communities shall have responsibility for congregational life and evangelism including leader formation, local congregational formation/education, evangelism, music, worship, ministry funding, stewardship, planned giving, new congregations, and congregational revitalization.

For an adult Christian, having a valid will and estate plan is essential. Unfortunately, many Americans die without a valid will and allow the state courts to distribute their assets however the state thinks best. Having a planned gift benefiting your church or an Episcopal ministry is righteous and legacy-giving. The deep connection you feel for your church can be available for those who come after you, sustaining the future of your church.

<u>Planned Giving is Simple</u> – There are many resources to guide you and help you with this planning. You may simply complete a codicil to your existing will. Or you can contact the Episcopal Church Foundation and seek confidential advice. Contacting Peter Pereira, the Diocesan Treasurer, is advised.

The purpose of the Stewardship Commission is to help clergy, lay leadership, and congregations in the Diocese of Hawaii to grow in their relationship with Jesus Christ by responding to God's generous blessings with their time, talents, and treasure.

- A. Our first goal is to offer guidance to clergy and lay leadership in understanding that stewardship is integral to our journey of becoming disciples of Jesus Christ. To that end:
 - The Committee produced an informational card that highlights its services, which was sent to all ministry leaders and given to the Bishop to share with parishes on his visits.
 - In May we hosted The Rev. Laurel Johnston, National Church Program Officer for Stewardship, for the second year in a row. She consulted with the Stewardship Committee and conducted a workshop, *Stewards by Design*, for congregations on Maui (31 attendees) and the Big Island (15 attendees). She also conducted a Clergy Day workshop at the Cathedral on May 10th for 21 attendees.
 - The Committee has engaged with Church of the Holy Apostles, Hilo, to support stewardship efforts through 2013.
- B. Our second goal is to articulate the Christian responsibility to grow in giving to the tithe or beyond and to collaborate with the Office of the Bishop and the parishes to embed this understanding. We asked The Canon to the Ordinary Liz Beasley to include questions about a commitment to the tithe in the deployment process. We advocate honest reflection and open conversation about proportional giving. We recognize that congregational giving will not rise above the giving of clergy and lay leadership; therefore, we encourage them to serve as stewardship models by growing in giving and talking about it.
- C. Our third goal is to encourage other commissions in the Diocese to embrace stewardship formation in their programs. Since the governance structure in the Diocese has been reorganized, we have not made an effort to communicate with the new commissions and committees. Our intent was to make our presence known and to keep stewardship formation in the forefront as a diocesan effort. We also want to encourage the practices that have formed our ministry: book study, spiritual reflection, prayer, personal reflection and sharing. We intend to have a display table at Convention.
- D. Our last goal is to offer ourselves as ambassadors of generosity to congregations. The Rev. Moki Hino responded to a request from St. Elizabeth's, Palama, for a stewardship talk. Members of the Committee are also engaging with parishes to conduct book studies of *Ask, Thank, Tell*.

Commission on Ministry

The Commission on Ministry shall have responsibility for education for ordination, lay leader training, licensed ministries, clergy retreats, continuing education, and ministry discernment.

Attachment # 17 Camp Mokule'ia Annual Report – Diocesan Convention 2012

There are many places in the world that offer us beautiful views. Hawaii may well have the most per square mile. Rare though is the 360 degree view in which not only everything you see is before you is powerful, but so too is that which is behind and that which remains usually unseen to the naked eye. This morning sitting on the wall at Mokule' ia I mused on that 360 degree view.

Directly before me was a stunning landscape, freshly lit from the sun's morning rise. Before me lay Kaiahulu Bay where the honu feed and play. Today, a manta ray family joined them as they cruised in the very same areas that delight the occasional monk seal. Just to my left was one of the many ohana who were weekend camping and had ventured to this spot so their keiki could play in a sea calmed by our protective reef. To my right in front of two of our cabins was another ohana beginning the preparations for a vast multi-generational breakfast feast. Soon the harmonies of a youth group staying in our cabins would begin to lift with songs of praise that would emanate from our chapel behind me. All around me, wherever I looked, there was not just view-plane beauty, but the beauty as well of joyful loving lives.

Yet there is also much more beauty that is unseen. Long before the sun's rise our cooks had been preparing for a day of delicious food for many of our guests. On the table was a bounty of "camp" food, but an increasingly large amount of ono fresh produce grown by our North Shore neighbors. This growing partnership with our neighbors is part of that glorious yet mostly unseen view. In much the same way, is the work of our staff. Today one group leaves the lodge and four hours later someone else moves in. In a short time, guests will be welcomed to remade beds, and cleaned rooms complete with bedspreads and tablecloths made for us by friends at Epiphany Church. Its not just the view that will welcome our guests, the numbers of which have risen by over a third in the last three years (more than 20,000 visitors a year now, and a revenue stream that will surpass \$1,000,000 this year), but it is also the loving care they receive from our staff, whether it's the first phone call into our office, or the quick replacement of a burned out bulb, or the gentle hands that holds you in place before you push off on our zip-line. These dedicated and caring people, the employees of Camp Mokule'ia, are the pulse and beat of the camp and are an essential part of our wonderful 360 degree view

If I had eyes that could travel from my perch on the wall, they might gaze upon the test garden plots coming to life behind my office, or the shed where we create fuel for our camp vehicles from waste vegetable oil, or the recycling and composting efforts that have reduced our waste by 50%, or the gray water systems that enable foliage to flourish behind and besides our cabins, or the photovoltaic panels that will soon cover lodge and cabin roofs. There too my eyes would find the Fantastic Four, our Episcopal Service Corps interns who began with us this Fall and have daily given themselves in service to the camp, to our guests, and to their spiritual journey. They stand side by side with each of us as we strive to live in harmony with God's Creation and to be integral to understanding that the "Earth is the Lord's and the fullness thereof."

It is a beautiful view and one that I can only expect to become more glorious as we move forward with conceptual plans to fully utilize all the City and County acres that we lease between us and Mokule'ia Beach Park and the Sutton Lands across the road. From those parcels will spring an abundance of food, of programming, and of lives transformed by the touch of God's grace that flourishes in the wildness and serenity of these lands. It is a magnificent view and all of us at Camp Mokule'ia look forward to the opportunity to share it with the wider community and our brothers and sisters of The Episcopal Church in Hawaii. Come enjoy the view!!
