Presentation of 2014-2016 Budgets

The Rev. Paul Lillie, Vice President of the Diocesan Council, reported. Action Item. Rev. Lillie moved adoption of the 2014-2016 Budgets on behalf of the Diocesan Council. The floor was opened for discussion. There was no discussion.

Action Item: A motion was made and seconded to call the question. The motion passed.

The budgets were adopted.

Consideration of Resolutions

Action Item: The Very Rev. Walter Brownridge, Chair of the Resolutions Committee, moved the following resolution:

Resolution #1: Task Force on Constitution and Canons Revisions

Be it resolved that the Bishop appoint, with the advice of the Standing Committee, a special Task Force of no more that four appointed members of the Diocese to review for possible revision the Constitution and Canons of the Diocese of Hawai'i, and the Rules of Order of Convention;

Be it further resolved that this Task Force shall also include, in addition, the Chancellor (or a Deputy Vice Chancellor appointed by the Chancellor with the agreement of the Bishop), one member of Diocesan Council and one member of the Standing Committee; and

Be it further resolved that the Task Force present its findings and proposed revisions to the 2014 Annual Meeting of the Convention for response and possible action.

There was no discussion.

The motion was adopted.

Be it resolved that the Annual Meeting of the Diocese of Hawai'i encourages the Hawai'i state legislature to pass the Marriage Equality bill that is being presented at a special session of the legislature, meeting October 28 – November 1, 2013.

Action Item: a motion was made and seconded to call the question. The motion passed.

The motion was adopted.

Report on Ballot #13 (General Convention Deputy, Clergy)

Bishop Fitzpatrick made the following report on the results of Ballot #13:

Substitute Resolution #3:

Be it resolved that the 2013 Annual Meeting of the Convention of The Episcopal Diocese of Hawai'i establish a Task Group for Youth and Young Adult Ministries, appointed by the Bishop. This Task Group shall be charged to develop a plan for the future of campus ministry and young adult ministry in the diocese. The Task Group shall consider, but not be limited to, the following areas:

- The role of McCray House and the Hale Haumana program in campus ministry, especially at the University of Hawai'i, Manoa;
- 2) The opportunities for campus ministries at other tertiary level education institutions;
- 3) Examine whether a Committee for Youth and Young Adult Ministries can best support such campus ministries, or if a new body is needed for this ministries;
- 4) This Task Group shall complete its work by April 30, 2014 and shall submit a report to the Diocesan Council and Bishop.
- 5) Upon submission some members of the Task Group may collaborate with the Diocesan Council to explore the financial and budgetary issues.

The substitution motion was accepted as the main motion.

THE BISHOP'S ADDRESS

at the Annual Meeting of the Convention of the Diocese of Hawai'i The Cathedral of St. Andrew, Honolulu, Hawai'i Saturday, October 26, 2013

The address was to have begun with a short clip from the "Wrath of Khan" where Captain Kirk says he doesn't believe in No-Win Scenarios, unfortunately there was a technical problem (the Bishop still encourages a viewing of the movie just for fun). While the address was being presented, images from Star Trek were shown on the overhead behind the Bishop.

All right, I am a product of my generation. I love Star Trek – especially the original series.

My sons know it and they often send me links for those online quizzes that tell you which character you are most like – or at least you seem to fool yourself that you're most like.

Yes, in Star Trek quizzes, I come out as James T. Kirk. The first time I took one and I came out as Kirk, my older son, Ed, commented, "Dad, we all knew that already. You'd rather go do it and figure out the details later. You seem to always figure it out, but the rest of us are a bit worried for a while. You're certainly no Earl Grey–drinking Picard, and you have way too much emotion to be Spock. Yes, James T. Kirk."

And besides, "I don't believe in the no-win scenario."

Especially for the Church.

So, I'm here today to let you know where I think we're headed. Last year was about celebrating the past 150 years. It was a big party and great fun. That was last year.

Looking ahead, who are we called to be?

One Body, One Mind, One Spirit: The Episcopal Church in Hawai'i serving Jesus Christ.

Notice I didn't say the congregations or even the Diocese – but the Church. *One* Church – One Body of Christ – with different sites responding to different needs with One Spirit and acting with One Mind.

One Body, One Mind, One Spirit.

I call all of you to be part of "The Episcopal Church in Hawai'i" serving together as One Body, seeking One Mind, empowered by One Spirit.

What do I mean?

We're going to jump right in.

I am convinced that the parochialism of the past is no longer helpful or even that meaningful in a small diocese such as ours. We live in a small state and on small islands – relatively. That is true even for the Big Island. In some dioceses with the same number of people as ours, it is not uncommon for there to be a five- or six-hour drive between Episcopal churches.

There is little difference between an organized mission and a parish in this Diocese. With a few exceptions, the distinction has no real meaning. We worship from the same Prayer Book. We use the same Bible. We have the same name – the same Bishop. We are The Episcopal Church in Hawai'i. Together we are one Body. Separately as individual congregations, we will dwindle and fade. Together we can flourish.

Our churches are not trees standing in a field, or even in an orchard.

The Standing Committee suggested a new image when I described my vision of the Church in Hawai'i.

That image was the Banyan Tree.

[From point forward in the speech, images of banyan trees were also projected on the screen behind the Bishop]

Jesus teaches something of the image in John 15:5: "I am the vine; you are the branches. If you remain in me and I in you, then you will produce much fruit. Without me, you can't do anything."

The image is delightful in that the branches reach up and the roots pour down.

We are all from one tree – Jesus Christ. Early in the life of the Church, the first Christians appropriated the image for Christ by looking to Isaiah 1:11: "A shoot will grow up from the stump of Jesse; a branch will sprout from his roots."

I see The Episcopal Church in Hawai'i as a Banyan tree spread out all over the islands, putting down roots in local communities and reaching into heaven.

One Body, One Mind, One Spirit: The Episcopal Church in Hawai'i serving Jesus Christ.

What does that mean?

We must be rooted.

One Body. One Mind. One Spirit.

Faith in Jesus Christ as Lord and Savior, as God Incarnate, is central to all that we do. This is the anchor root.

I have a profound belief in the Incarnation. Jesus Christ is God for me. In Jesus Christ, God is made fully known. In Jesus Christ, God took flesh and lived among us, and as a consequence the person of every man and every woman is sacred. Because of Jesus Christ, every human being is an icon – a holy image – of God.

As Archbishop William Temple wrote, "...the Word of God does not consist of printed propositions; it is living; it is personal; it is Jesus Christ. That living Word of God speaks to us through the printed words of Scripture; and all our study of those printed words helps us to receive it. But the point of vital importance is the utterance of the Divine Word to the soul, the self-communication of the Father to His children..."

We are rooted in Jesus Christ.

Michael Ramsey, another Archbishop of Canterbury, wrote that "[l]iving through dying is what faith means; it is what baptism means, it is what Holy Communion means; it defines the life to which every Christian is called.... [Every Christian] will, in following Christ, devote himself to the removing of suffering from his fellows whenever possible, supporting every effort to reduce its causes and its incidence."

Our faith in Jesus Christ must be rooted in the Scripture, the Sacraments, and Service to others. We do this to have a personal relationship with God through Jesus Christ.

Scripture, Sacrament, and Service.

To know God in the narrative of Scripture,

To be fed by God in the bread and the wine, the Body and the Blood, of the Sacrament. To serve God in the flesh and blood of human beings just like Jesus Christ – the rejected, the hungry, the houseless.

One Body, One Mind, One Spirit: Formed together by Scripture, Sacrament, and Service.

These three require us to be in relationship.

We need other people. We have to keep learning.

As Captain Kirk once said, "You know the greatest danger facing us is ourselves, an irrational fear of the unknown. But there's no such thing as the unknown – only things temporarily hidden, temporarily not understood."

I know many have been involved with Education for Ministry. This is a four-year program designed for lay education and discernment for lay ministry in a small group. It does require considerable commitment and personal discipline to complete the program. I commend it to you as one possibility. It is particularly effective when offered by island across congregations.

I have been told that there is a desire for shorter-term adult programs and I will encourage a new Formation Committee to help with this.

What I can offer is an online Bishop's Bible study to begin during the first week of Advent. I will post a weekly reflection with questions online. My hope is that as The Episcopal Church in Hawai'i we can walk through the Gospel according to Luke and Luke's Acts of the Apostles. I will ask you to read a chapter (sometimes two) a week. I will also invite guest commentators to join me now and then. This could be used for a small group study or for personal reflection. My focus will be on what the story means for us as The Episcopal Church in Hawai'i. I am inviting you to ask: What is God's Spirit saying to The Episcopal Church in Hawai'i? It can also give you an opportunity to give me feedback and seek with me God's mission for The Episcopal Church in Hawai'i.

I also hope that through this Bible study, relationships will be formed and then leaders – lay and ordained – can be raised up. We have to keep learning about our faith and our communities. We do that together.

In these changing times, we sometimes can't get beyond ourselves. Our local church. Our own needs. Our local crisis.

We confuse the leaf for the whole tree.

Local leadership sometimes gets so worried about the clump of leaves in their kuleana that it becomes easy to get upset. To be anxious.

You are not alone.

I want to spend more time with wardens and other lay leaders to get a sense of what is happening in local congregations and neighborhoods. Local lay training on each island with me – and with Peter, Liz, and others. The "others" is very important. We have the skills and the expertise to share among ourselves within The Episcopal Church in Hawai'i to engage God's mission. It is already happening as clergy ask for help with thrift shops, personnel issues or accounting, and lay folk from other churches go to help. We must call on the lay leaders and clergy in neighboring churches.

We must ask for help. We must ask for prayers. We must be willing to help. We need each other.

I need your help. I need your prayers. I need you.

You need help. He needs your help. She needs our help. We all need prayers. We need each other. We need God.

One Body, One Mind, One Spirit.

I also need you to help me explain that there is no large bureaucratic Diocese with buckets of money somewhere here on the second floor of the Cathedral. All of our diocesan policies were

written and enacted by clergy and lay people of the Diocese – a committee, a commission, the Diocesan Council, the Standing Committee, the Convention – years (and sometime decades) ago. Usually they were written to answer an immediate need. Canon Liz, Peter, and others in my office are following the policies your predecessors established for good reasons.

There is a resolution before you at this Convention asking that a special Task Force be formed to review our Constitution, canons, by-laws, policies – you know, all the organizational stuff. We need to downsize and simplify to meet the needs of the 21^{st} century. Most importantly, the resolution asks that the review take place and proposals be shared for feedback before anything is brought to Convention. I hope we can do this in an open, collaborative way.

I've also asked the staff to make a list of all that they do for congregations so that you – the leaders of The Episcopal Church in Hawai'i – can better explain all that is done for the congregations by the few people in my office. You can't explain if you don't know.

Beyond that, I think we need more time together by island and, on O'ahu, by region to discuss God's mission in our place. We must engage one another to come to one Mind.

We are too small to be a top-down system.

Many of you know that a "Property Task Group" made up of members of Standing Committee and Diocesan Council produced a report on the state of our buildings and property. The report is entitled "Phase 1-A Report." It is a look at our property and buildings as assets and liabilities.

Some have asked me if this report includes a "hit list" of what churches will be closed. No, it is not a hit list. The report provides data, but our work is not finished

The next phase of work will be to engage every island (and region of O'ahu) to look at our property as assets of The Episcopal Church in Hawai'i as a whole. Can the mission and ministry carry on at another site? Do we need so many buildings and property in a given area? Is the asset being used effectively for ministry? Has the building become a clubhouse for the members or is it a center of discipleship? Is the property essentially a rental unit so that a few people can get together on Sunday morning for an hour with Communion followed by a cup coffee? If a given local congregation disappeared tomorrow would anyone really notice – except maybe the kids at the preschool or those who rent a parking space in the church's lot?

There is an important difference between membership and discipleship. Clubs have members. Jesus Christ has disciples. Members pay dues to the club. Disciples of Jesus Christ give their all for the Mission of the Church. Members worry about themselves and their own needs and their own preferences. Disciples focus on the needs of the local neighborhood and those not in the Church. Members want to be comfortable and served by the staff. Disciples know they are the servants and are willing to risk to share God's love.

We will have to be honest and open about our ministry.

No Bishop, no Standing Committee, no Diocesan Council, no one wants to close churches or sell property. We all want thriving ministries that are centers of Scripture, Sacraments, and Service. We aren't, however, in the business of providing clubhouses for a few people to gather on Sunday morning. We – no, I as Bishop – have a responsibility to ensure there is pastoral care for those who need it in old age and infirmity. I accept that. I cannot promise it will be in a particular building or with your private chaplain. I don't know that we can or should keep all the property that we have when the resources could be used for expanded ministry and to fulfill God's mission in other parts of the islands. What I can promise is that there will be no surprises and that everyone will be part of the conversation. The conversations cannot take place in isolated congregations, but must be part of an overall conversation by island or region of O'ahu, and they must take place with congregations and clergy with the elected leadership of the Diocese and me. Likewise, such gatherings may discern that we need to develop new congregations either in new communities or within established churches to reach new people.

We don't need to be afraid of the unknown. We have one another. We have Jesus Christ.

We are One Body, One Mind, One Spirit.

The roots of this tree of life – The Episcopal Church in Hawai'i – spread out to different places in new and sometimes messy ways.

The One Spirit is an essential fertilizer of this tree of life.

I will ask members of the Standing Committee and others to help develop a local model of group spiritual renewal and communal discernment for our congregations and Diocese. I hope this can be a way for us to be open to the Spirit and to new possibilities for mission – as the Church and as individual Christians.

One of the qualities of Captain Kirk that I most admire is that he was always part of the away team.

As Kirk said, "Risk is our business. That's what this starship is all about. That's why we're aboard her."

That is true of the Church too.

I would like to change the nature of my visitations.

I will continue the two-year cycle with a Sunday visitation to every congregation at least every 24 months.

Frankly, that has worked well and is not that different from the 18-month cycle used by previous bishops. I hope the Sunday visits will always include a time to teach. I hope that can happen even in churches that normally don't have a Sunday morning education time.

I would like to better focus the weekday visits in 2014. I hope they can take place on Wednesday evening and will include a time for a simple meal, preaching, prayer, and renewal. I hope that all the congregations on an island – or region of O'ahu – will be invited to the Wednesday evening service at whatever church I am visiting. I hope my visitations can focus on teaching and renewal. Pulling us all together as One in the Spirit.

I will work to have office hours in local churches. Come see me. We can talk story. We can pray.

We will dig our roots deep into the 'aina.

Captain Kirk always had advisors with different worldviews. As he said to Bones, "One of the advantages of being a captain, Doctor, is being able to ask for advice without necessarily having to take it."

Now, I have my office staff:

My own Spock is Irina (though she sees herself as Seven of Nine). Liz is too often my Dr. McCoy patching things up. Peter is the Scotty in the engine room. June, Sarah, and Katrina are in the crew. I am grateful for all they do.

I must say that I depend for advice as much from the Standing Committee. Their work on the Diocesan Mutual Ministry Review helped to shape much that is in this address. I must also say that my monthly conversations with Liz Zivanov as President of Standing Committee have been helpful and something of a joy.

And from the clergy, I want and receive invaluable advice and care.

It is my desire that we can meet together more often in 2014. These are interesting times. We will need to support one another. I count on my experienced clergy to mentor less-experienced clergy. The clergy will have to make the time to meet.

We are blessed to have two seminarians – Jar Pasalo and Annalise Castro – who hope to return to the islands in a couple of years. We will need to be sure that we have curacies for them or we will loose them to a diocese in North America.

Some of our congregations need ordained leadership, but find it increasing difficult to maintain full-salaried clergy. The finances, size, or location of such congregations make a traditional model of clergy leadership difficult. Furthermore, the cultural and community needs invite different styles and experiences in ordained leaders.

Local formation for ordained leadership – Naimiloa for vocational deacons and Waiolaihui'ia for Priests – will provide ordained leadership as part of a shared ministry with other congregations.

My personal hope is that through these programs and through traditional seminary education, in ten years many of our clergy will have local ties to the islands. That can provide family and personal connections for the long-term leadership of the Church rooted in the islands.

The Episcopal Church in Hawai'i must be broad and welcoming.

When former Presiding Bishop and second Bishop of our Diocese, Bishop Ed Browning, declared that "there will be no outcasts in the Church," he was speaking to and for us.

For me, that means making room for new people. I recently was interviewed by a reporter of a small local magazine. The reporter wrote me afterwards to ask, "Why haven't I heard of The Episcopal Church in before now?" He went on about how we were "catholic" and "inclusive." He asked for a referral to a local congregation – I gave him the names of the three churches nearest to where he lives.

We don't communicate our message to the world very well. We are the inclusive, liberal catholic church. That is part of our core identity. We struggle with that identity. We don't always agree. But we strive together to be...

One Body, One Mind, One Spirit.

But I am convinced there is room in our tree for everyone to be fed.

We have to communicate better.

With each other, we need to use e-News and e-Chronicle. Sybil is doing a great job. But we – the leaders of The Episcopal Church in Hawai'i – have to be subscribed to it and we have to read it. No excuses are acceptable. If you are an active leader – lay or ordained – you must have access to and read the electronic communication of The Episcopal Church in Hawai'i. Please signup at www.eosicopalhawaii.org (at the bottom of the page).

Irina is training to help us do online seminars. We will have more meetings online in 2014 -with much less travel.

I will work on trying to have a couple of mailings a year. We have a limited database -a thousand or so names of leaders. We need help gathering the names and contact information for everyone in the Diocese.

Communication is really all about relationships.

Let Sybil know what is going on locally and please support one another. Share with one another.

My friends, we need one another.

The world needs our message. We will find a way to let the world know in 2014.

I will ask the Standing Committee to help me explore the ways and cost of getting the name of the Episcopal Church in Hawaii out into the community.

More people need to hear a message like that of "A Cup of Cold Water" on Maui.

A shared ministry of all our Maui churches, grounded in prayer and Scripture, arising from God's people to serve those the world has overlooked, forgotten, or ignored.

This is One Body, One Mind, One Spirit. This is The Episcopal Church in Hawai'i.

This is an example of Christian discipleship that holds together faith and works, personal and social holiness, physical and spiritual concerns, works of piety and works of mercy.

It is certainly not the only example – the St. James' Saturday afternoon beach Mass, the Farmers Market on Thursdays at St. Clement's, the Community Garden at St. Paul's, Kekaha; and others. This is The Episcopal Church in Hawai'i meeting the world in the local community: Disciples of Jesus Christ being about God's mission.

I think the next year will be our time for renewal and engagement. We have examples. We have one another.

I don't believe in the no-win scenario.

Not in the Church.

There will be much to do. We have hard decisions ahead.

We also are One Body, One Mind, One Spirit.

We are The Episcopal Church in Hawai'i.

And so,

"Glory to God, who is able to do far beyond all that we could ask or imagine by his power at work within us; glory to him in the church and in Christ Jesus for all generations, forever and always. Amen" (Eph. 3:20-21).

BE IT RESOLVED that the Bishop appoint, with the advice of the Standing Committee, a special Task Force of no more than four appointed members of the Diocese to review for possible revision the Constitution and Canons of the Diocese of Hawai'i, and the Rules of Order of the Convention;

BE IT FURTHER RESOLVED that this Task Force shall also include, in addition, the Chancellor (or a Deputy Vice Chancellor appointed by the Chancellor with the agreement of the Bishop), one member of Diocesan Council and one member of Standing Committee; and

BE IT FURTHER RESOLVED that the Task Force present its findings and proposed revisions to the 2014 Annual Meeting of Convention for response and possible action.

* * * * * * * * *

RATIONALE/EXPLANATION:

The 43rd (2011) Annual Meeting of Convention referred several resolutions on canonical revisions to the Diocesan Council. Consideration of these revisions is really beyond the scope of a standing governance body of the Diocese, and requires a focused study and dedicated time commitment. Such revisions also demand broad input by and response from the Diocese at large before being presented to Convention. There are additional constitutional and canonical revisions that need to be addressed. For example, the Rector of St. Peter's Church is now an ordained Minister in the Evangelical Lutheran Church in America (ELCA), a full-Communion partner of the Episcopal Church. The Constitution of the Diocese allows only canonically resident Episcopal Priests and Deacons to be voting clergy of the Convention. Some dioceses allow ELCA clergy serving as rectors, vicars or on staffs of churches to have seat, voice and vote in Convention. Experience has shown that it is important to get proposed revisions into the hands of the leaders of the Diocese early so that feedback can be included before final proposals are presented to Convention. A Task Force devoted to this work is needed. This Task Force will need to commit time in early 2014 (January to March) to produce a first draft of revisions for response by the Diocese. The Task Force could then receive feedback and address concerns in the second quarter of the year (April to June) before presenting formal proposals (in September) for action (in October). It is also important that the Chancellor and Bishop be involved early in all revisions. It also needs to be recognized that the work of this Task Force may not be complete until 2015 (Constitutional changes require action at two successive meetings of Convention).

BE IT RESOLVED that the Annual Meeting of the Diocese of Hawai'i encourages the Hawai'i state legislature to pass the Marriage Equality bill that is being presented at a special session of the legislature, meeting October 28 – November 1, 2013.

RATIONALE/EXPLANATION:

Marriage equality in the United States is a civil issue. The separation of church and state protects citizens from the establishment of a state religion. Much, if not most, of the opposition to this bill is based on the religious beliefs of some religious bodies. However, other faith communities have different opinions and support the bill in accordance with their beliefs. Codifying the beliefs of particular faith communities over those of others into our marriage laws violates the Constitution of the United States. No objections to marriage equality can be found in any credible sociological or psychological studies; homosexuality has been removed from all diagnostic professional materials. A civil solution protects all citizens, regardless of belief or non-belief, from being forced to abide by a law that is based on the opinion of one religious group. Nor can equal rights be determined by popular vote; they are rights accorded to all citizens, regardless of the number of people, color of skin or ethnicity, gender, or any other characteristic that results in a group's exclusion from full access to the rights afforded all citizens under the Constitution and the Bill of Rights.

RATIONALE/EXPLANATION:

The Episcopal Diocese of Hawai'i has consistently provided resource programming for children and youth because it is desirable to provide and nourish our keiki about the Good News of Jesus Christ and their place in God's faith community. This vision and mission ought to continue once the children leave their childhood and enter young adulthood such that their spiritual path can continue in the Episcopal tradition. Not having a commitment to opportunities for an Episcopal faith experience once children leave high school does not bode well for our beloved children nor the Episcopal Church's spiritual development in Hawai'i. There is potential that home-grown Episcopal clergy may come out of an Episcopal University of Hawai'i Campus Ministry program. The foregoing was the mission, intent and purpose of Hale Haumana a o ke Akua (translated as Student's House in the Lord) and deserves another look for the sake of our young collegiates.

BE IT RESOLVED, that the 2014 Minimum Clergy Compensation and Benefits Policy of the Episcopal Diocese of Hawai'i be adopted.

RATIONALE/ EXPLANATION

When a church calls a Priest, it enters into a shared mutual ministry, a stewardship, of caring for each other. Part of that stewardship provides that the church has a responsibility, a covenant, to provide for the financial support of its clergy and their family. The Diocese of Hawai'i establishes minimum guidelines to assist churches in determining fair compensation for clergy that will allow a reasonable, moderate standard of living and, that will attract, retain, and support them in their role and growth as faithful ministers of the Gospel, and in the pastoral care of the church.

The Committee is committed to this stewardship and covenant relationship and, as such, the 2014 Minimum Clergy Compensation Schedule includes a 2% increase to all compensation categories.

The 2% increase is less than the 2.5% increase in cost of living for Hawai'i. Recognizing that Hawai'i's cost of living is one of the highest in the nation, the Committee supports maintaining a competitive compensation level to attract and retain talented, dynamic, entrepreneurial and vibrant clergy. The Committee is also mindful of the current economic challenges in the U.S. and globally; thus the recommendation for a smaller increase than the cost of living increase. Nothing prevents a congregation from paying its clergy an amount greater than the minimum. And, it is strongly recommended that annual salary negotiations at the church level be carried out with prayerful candor, clarity and, most importantly, in Christian love *"For where your treasure is, there your heart will be also." The Gospel of Matthew 6:21.*

The automobile allowance for 2014 will be \$8,800.

<u>Regarding Mutual Ministry Review</u>: Compensation provides a means by which Congregations enable Priests to exercise and express a professional vocation entrusted by God and affirmed by the Church. Inherent to the sacred trust shared by Priest and Congregation is the mutuality and accountability of communion. The following schedule and terms articulate the shape and expression of this mutuality and communion by providing the minimum expectations of compensation and professional support, according to various conditions necessary for life and ministry in the Diocese of Hawai'i. These minimum expectations articulate the base by which we support and affirm the ministry and leadership of our Priests. As an important part of our mutuality of ministry and life in communion, compensation must be considered and developed with clear expectations of ministry and presence. In order to achieve this, all Priests providing ministry and leadership beyond supply ministry will have a mutually agreed upon: Letter of Agreement; Position Description (to include a statement of ministry and professional goals); and biennial Mutual Ministry Review. This Mutual Ministry Review should discern and provide for the continued mutual life, ministry and vitality shared by Priest and Congregation.

Materials, resources, and guidance for Letters of Agreement, Position Descriptions, and Mutual Ministry Reviews are available from the Office of the Bishop.

An agreement among the Clergy, Wardens and Vestry/Bishop's Committee to a biennial discussion and mutual review of the total ministry of the Parish/Mission allows for the following:

- The opportunity to assess how well they are fulfilling their responsibilities to each other and to the ministry they share,
- The establishment of goals for the work of the Parish/Mission for the coming year(s),
- The identification of areas of conflict or disappointment that may be adversely affecting mutual ministry which may then be addressed appropriately, and
- The clarification of expectations of all parties to help reduce possible future conflicts and if any occur, make them more manageable.

A mutually agreed-upon third-party may be engaged to facilitate this process. (The Clergy Compensation Review Committee suggests that this resolution with the attached schedule be presented and discussed with the Diocesan community around the State in pre-Annual Meeting gatherings with Clergy, Lay Delegates, Wardens and Treasurers as scheduled by the Diocesan Council)

2014 MINIMUM CLERGY COMPENSATION AND BENEFITS POLICY The Episcopal Diocese of Hawai'i

This table does not include self-employment tax. Compensation includes salary and housing.

I. <u>Full Salaried Positions</u>

- a. The compensation categories and ranges are intended to be used as a framework within which the Vestry/Bishop's Committee and the clergy negotiate a mutually acceptable compensation. The compensation ranges are based on "years of service" to provide a guide for compensation increases as years of service increase. This compensation schedule sets the minimum for churches in the Diocese of Hawai'i. "Years of service" means the number of years of status as a clergy person in good standing in The Episcopal Church in the USA. In Parishes, compensation is negotiated between the clergy person and the vestry. For Missions, compensation is negotiated between clergy and the Bishop's Committee with the approval of the Bishop. Credit for prior years of service as an ordained person in-good-standing in another denomination is negotiated between the clergy and the Vestry/Bishop's Committee with the approval of the Bishop. With respect to clergy newly called or appointed to a congregation, the Vestry/Bishop's Committee is required to notify the Treasurer of the Diocese as to the number of years of service at which they enter the Compensation Schedule approved by Diocesan Convention. In order to maintain accurate records, a schedule will be attached to the Parochial Report reporting the clergy compensation and the number of years of service as it increases each year.
- **b.** Clergy must be paid at least the minimum of the applicable category with salary reviews at least annually. Congregations and clergy should schedule and hold a biennial Mutual Ministry Review, complete with clear goals and objectives, mutual accountabilities and shared expectations by both the laity and the clergy.
- **c.** These categories are minimums and should be used as a starting point for salary negotiations. Vestries/Bishop's Committees shall seriously consider appropriate compensation.
- **d.** For ease of administration, all compensation figures will be rounded up into amounts divisible by 12.
- e. Each Vestry/Bishop's Committee, working in consultation with their clergy, shall approve a resolution determining the housing allowances for the following year.

This Internal Revenue Service (IRS) requirement shall be completed by December 31st of the year preceding the commencement of the allowance.

- **f.** For clergy who are paid a cash housing allowance, the amount of the housing allowance shall be determined by negotiation between clergy and Vestry/Bishop's Committee.
- **g.** The 2014 Housing Allowance Guideline is \$20,880 and is included in the compensation amounts stated above. Any congregation that furnishes housing for a Fair Market Value that is less than the \$20,880 is encouraged to pay the difference in cash to the clergy. The value of housing that is decided shall be added to the cash salary in order to compute the total compensation for Church Pension Fund purposes.
- **h.** Congregations with assisting clergy are encouraged to classify the assistant's position into a category appropriate to the scope of the position.

II. Part Salaried Positions

a. Part salaried clergy in charge of congregations will be paid according to the applicable range above, times the % as agreed for the position.

III. Full Salaried Clergy Benefits

- **a.** An automobile allowance of \$8,800 will be provided, unless the clergy and Vestry/Bishop's Committee mutually determine by December 31 of the year preceding the commencement of the allowance that a mileage plan (using the current IRS cents per mile) will be provided for the year instead. Clergy are encouraged to consider use of pre-tax dollars by setting up a reimbursable expense account plan or have the congregation provide an automobile.
- **b.** The congregation will pay the mandatory Church Pension Fund Assessment on salary, housing, social security reimbursement and on utilities (if applicable).
- **c.** \$100,000 Group Life Insurance as provided by the Church Pension Fund at no cost to the congregation.
- **d.** The congregation must provide the Diocesan Health Maintenance Organization (HMO) Plan for clergy. For exceptions, please apply to the Office of the Treasurer. Clergy will receive full family medical coverage according to the terms of the Diocesan HMO Plan, paid for by the congregation.
- e. The congregation will pay the cost of Worker's Compensation coverage.
- **f.** The Temporary Disability Insurance Plan for clergy is provided by the Church Pension Fund at no cost to the congregation.
- **g.** The congregation will pay the clergy social security costs at 7.65% of salary and housing.
- h. Full Salaried clergy are entitled to one month (30 calendar days) of annual vacation with full stipend and allowances. This vacation time cannot be more than 45 calendar days in any one year, except by the agreement of the Vestry/Bishop's Committee and with the consent of the Bishop in Aided Parishes and Missions. (In other words, no more than 15 days can be carried over to the following year.) Congregations should encourage clergy to take vacation.

IV. Part Salaried Clergy Benefits

- **a.** Part salaried clergy will receive the federal guideline reimbursement of business automobile mileage instead of the stipulated allowance.
- **b.** The congregation will pay the mandatory Church Pension Fund assessment of salary, housing, social security reimbursement and on housing utilities (if applicable).
- **c.** If qualified, part salaried clergy will receive the designated Group Life Insurance benefit as provided by the Church Pension Fund.
- **d.** The congregation must provide the Diocesan HMO plan for part salaried clergy who are 50% or more salaried. Part salaried clergy who are less than 50% salaried will receive the dollar value of the percentage of the value of a full coverage HMO plan.
- e. The congregation will pay the cost of Worker's Compensation coverage.
- **f.** The Temporary Disability Insurance Plan for part salaried clergy is provided by the Church Pension Fund.
- **g.** The congregation will pay the clergy social security costs at 7.65% of salary and housing.
- h. Part salaried clergy are entitled to one month (30 calendar days) of annual vacation with agreed stipend and allowances. This vacation time cannot be more than 45 calendar days in any one year except by the agreement of the Vestry/Bishop's Committee and with the consent of the Bishop in Aided Parishes and Missions. (In other words, no more than 15 days can be carried over to the following year.) Congregations should encourage clergy to take vacation.

V. Other

- **a.** Moving Expenses: Clergy will receive an allowance for moving expenses from the US Mainland, typically in the range of \$12,000 to \$20,000 depending on location.
- b. Sabbatical: Clergy are eligible for sabbatical leave at the ratio of one month per year of service in the congregation, to be available after the third year, and cumulative through the fourth year. The maximum amount of leave is limited to 4 months. The Vestry/Bishop's Committee shall annually budget funds to accumulate to provide pastoral and sacramental supply during the clergy person's sabbatical leave. Sabbatical leaves are provided for the benefit of both the congregation and clergy. Thus, before a sabbatical leave is granted, clergy must agree to serve the congregation for at least one year upon returning from the sabbatical. In addition, the request for sabbatical must be accompanied by a full and detailed description of the activities to be undertaken during the leave and, if granted, clergy shall submit to the Bishop and the Vestry/Bishop's Committee at the end of the leave, a report on the accomplishments of the leave. Accrued but not taken sabbatical leave can be carried over to following years in the same parish/mission. Accrued but not taken sabbatical leave is not paid out at retirement.
- c. Continuing Education: Clergy are required by Canon and Diocesan policy to continue their education. The congregation should provide funds in its annual budget for this continuing education. The minimum recommended amount is \$970/year. This amount should accumulate if unused and may carry over to the

next year. This fund should also be available for sabbatical expenses.

VI. Supply Clergy Compensation

a. The minimum compensation for supply clergy shall be as follows:

One Service: \$167 Two Services: \$224 Each additional Service: \$110

Clergy will be reimbursed for travel (mileage, airfare, etc.), overnight parking and housing (if necessary).

ADDENDUM TO MINIMUM CLERGY COMPENSATION SCHEDULE

Examples:

- 1. Clergy with 5 years service is called to serve in a Category 4 Parish/Mission. Minimum compensation should be \$73,284. As a minimum this should be used as a starting point in the negotiation. Vestries/Bishop's Committees should seriously consider appropriate compensation.
- 2. Clergy with 20 years of service is called to serve in a Category 2 Parish. Minimum compensation should be \$105,540. As a minimum this should be used as a starting point in the negotiation. Vestries/Bishop's Committees should seriously consider appropriate compensation.
- 3. Clergy with 25 years of service is called to serve as a part salary vicar in a Category 4 Mission. The position is for 50% of salary. Minimum compensation should be \$43,638 (\$87,276 divided by 2 = \$43,638). As a minimum this should be used as a starting point in the negotiation. Vestries/Bishop's Committees should seriously consider appropriate compensation.
- 4. Clergy with 2 years of service is called to serve in a Category 3 church. Minimum compensation should be \$71,088. However, due to the parameters of the search and the scarcity of applicants, the congregation agreed to pay the clergy \$85,000.

1 a Assessments

The proposed assessment for the 2014 to 2016 budget is 20% and is based on each congregation's 2012 to 2014 operating income. For the entire history of this Diocese the assessment rate has been 20% or higher. Historically, the total assessment is shown below:

The Diocesan Council does not currently foresee a change in the 20% assessment rate in 2014, 2015, or 2016.

1 b Investment Income

Income from the Portfolio (Unrestricted), the Von Holt Fund, and the Ing Fund represent a 5% total return distribution. We took a smaller distribution from the Von Holt Fund in 2012, because budgeted expenses were not spent. The diocese endowment spending policy is five percent of its endowment fund's average market value over the prior twelve quarters. Income from the Portfolio (Restricted) is primarily from the Episcopate Endowment Fund. The distribution is limited to the expenses related to the Bishop–Episcopate. The Diocese is the beneficiary of the investment income from the Catton Fund, Parke Trust, Prisanlee Fund, and Valvon Fund. We do not have investment management oversight of these funds. Income from the Valvon trust fund is down because the fund has not recovered from the economic meltdown. The Catton Fund income is restricted by the donor for retired church workers. All investment income is net of investment fees (management and custodial fees).

Rentals

1 c Apartments

This is the rental income from the diocesan-owned apartments (6 units) at Queen Emma Square. One of the units is provided to house the Korean Missioners.

1 d Parking

This income is from the Priory's rental of parking spaces in the parking lot behind the diocesan offices.

1 e Interest

This represents the interest on diocesan cash accounts and from a loan that we refinanced for St Philip's, to assist them in making the loan payment, when Bishop Estate stopped renting St. Philip's Parish Hall and was replaced with a new tenant at a lower rent. We paid off the bank loan and lent the church the funds from our money market accounts.

1 f Miscellaneous

This represents miscellaneous gifts and other income.

1 g Emergency & Opportunities Reserve Fund

Any unused funds from the Emergencies and Opportunities current year allocation is transferred to this reserve fund. The current fund balance as of June 30, 2013 is \$92,400.

Commission on Vibrant Christian Communities

The Commission on Vibrant Christian Communities shall have responsibility for congregational life and evangelism including leader formation, local congregational formation/education, evangelism, music, worship, ministry funding, stewardship, planned giving, new congregations, and congregational revitalization.

2 a Direct Congregational Support

These line items financially support mission congregations to meet the necessities of congregational life. Grace Church (Moloka'i), St. Jude's Church (Hawai'i), the Episcopal Church on West Kaua'i (St. John's Church, 'Ele'ele, and St. Paul's Church, Kekaha). These congregations serve isolated, economically challenged communities. There are other such communities in our Diocese, but these three congregations face particular challenges and have unique needs. For more information on these congregations, contact the Bishop.

2 b Audit Expenses - Missions

This line item provides funding for the Treasurer's office to enable missions and aided parishes (18 in total) to comply with the national canonical requirements for an annual audit. Parishes are also required to meet this requirement at their own expense. For more information on these congregations contact the Treasurer.

2 c Planned Giving and Stewardship Committee

For Planned Giving, this line item allows the Committee to meet the following priorities: visiting congregations to increase planned giving and gift planning opportunities by offering a program of education and providing direct support for congregations, and by working with the Episcopal Church Foundation(see http://www.episcopalfoundation.org/) on marketing, training, and gift planning. In 2010 the Diocese had its first Hō'ike Ulu Legacy Society event to honor those good stewards who have remembered their congregations, the Diocese, or another ministry in their wills or estate plans. The Hō'ike Ulu Legacy Society events were held on all islands in 2011 and 2012. These events will continue in 2013-2016. For more information contact Jane Tonokawa, through the Treasurer's office.

For Stewardship, this line item supports the ministry of the Committee to develop or sponsor programs that engage the Diocese in a greater understanding of Stewardship with a focus on congregational giving. Moreover, the Committee is a diocesan resource available for congregational consultation to encourage giving. The Stewardship Committee also participates in the wider stewardship discussion by participating in The Episcopal Network for Stewardship (TENS), Alban Institute, and other forums. For more information, contact the Committee Chair, Lindsay Kamm, through the Treasurer's office.

2 d Treasurers' Consultations

This line item covers the travel costs for new treasurers from congregations to meet with the Diocesan Treasurer on matters relating to their duties and responsibilities. For more information contact the Treasurer.

2 e Christian Formation Committee

This line item allows the Committee to aid congregations in the areas of adult and children's education. This includes diocesan membership fees for such programs as Education for Ministry (EfM) and Godly Play. The amount listed funds the costs of speaker(s), logistical support, and some scholarship funds for diocesan formation events. The Christian Formation line item also supports congregations and educators seeking resources to support local Christian education initiatives. In the past, this line item also included the costs of developing and holding the Diocesan Convocation, an annual diocesan gathering for the purposes of formation and mission called for by the 2007 annual meeting of the Convention.

2 f Commission Travel

This line covers the cost of travel and online meeting costs for Commission members to attend meetings.

2 g Commission Programs

This line item funds programs that encourage congregational growth and evangelism, and directs grants to congregations that will help them build vital and vibrant Christian congregations in the areas of church growth, evangelism, and new member ministries. For example, the Rev. Kevin Martin, author of *5 Keys for Church Leaders*, will be in the Diocese to conduct trainings in 2014.

2 h Emergencies & Opportunities, Current Year

This line item provides funds to respond to expected ministry opportunities or to cope with major emergencies. It is available to congregations that have called new clergy whose salary packages are difficult to project and/or moving costs must be covered, to help when congregations have had sudden or unpredictable changes in finances or leadership, and/or when the condition of facilities demand immediate attention. Any assistance granted to the congregation is considered a one-time, nonrenewable grant made during the current year.

Commission on Ministry

The Commission on Ministry shall have responsibility for education for ordination, lay leader training, licensed ministries, clergy retreats, continuing education, and ministry discernment.

3 a Commission Travel

This line covers the cost of travel and online meeting costs for Commission members to attend meetings.

3 b Diversity Committee

This line item funds training, communication, and resource development for the committee members, congregations, and individuals. This training was created and is maintained by resolution of General Convention. Based on the promises in our Baptismal Covenant to "seek and serve Christ in all persons, loving [our] neighbors as [ourselves]" and to "respect the dignity of every human being," this committee seeks to create dialogue on racism; to facilitate respect for diversity; and to promote healing, reconciliation, and transformation in our members and institutions.

3 c Clergy Conferences

Clergy Conferences funds the expenses (mostly airfare) for two Presbyters' Days per year (meetings of the priests with the Bishop) and represents a substantial subsidy for the annual Clergy Retreat, held at Camp Mokule'ia. These events sometimes are led by the Bishop or a resident priest and sometimes have outside speakers. In using outside speakers, we have often been able to tag onto another event in order to reduce costs. This fund also often covers the airfare for clergy spouses to attend the Clergy/Spouse Dinner, if there is one, during the annual meeting of the Convention.

3 d Community of Deacons

This line item pays for two meetings per year of the Deacons of the Diocese with the Bishop, annual membership dues in the Association of Episcopal Deacons (AED) for both the Deacons and those in formation to be Deacons, attendance at an AED conference, and expenses of the work of the Archdeacon of the Diocese.

3 e Licensed Ministries/Ministry Resources

Licensed Ministries covers any costs associated with the training and licensing of laypersons to the licensed ministries spelled out in Title III of the Canons of The Episcopal Church. Ministry Resources covers the cost of various books, periodicals, and other resources intended to promote leadership or congregational development throughout the Diocese, such as membership in the Alban Institute and a subscription to *The Parish Paper*.

3 f Local Ordination Formation Programs

The Diocese of Hawai'i has two groups to train people locally for ordination: Naimiloa for those to be ordained Deacons, and Waiolaihui'ia for those to be ordained Priests. Each group meets regularly throughout the year for one-day or weekend gatherings for instruction, worship, and fellowship. For the curriculum, the Diocese is part of the Iona Initiative, a nine-diocese consortium that is developing a curriculum for dioceses to use for local formation. This line item

covers the cost of the curriculum, small honorariums to instructors, and a partial subsidy for the cost and travel associated with the groups' gatherings.

3 g Other

This line item covers other items that are part of the work of the Commission on Ministry, such as psychological testing and background checks for those in the ordination process (both required by church canon). Also included are the costs of background checks for candidates for positions on the Bishop's staff or as priests in mission congregations.

3 h Seminarian Support

This line item represents a \$1,000 grant per semester to help cover tuition for anyone being sponsored for ordination by a congregation in the Diocese of Hawai'i and attending a seminary. The Diocese currently has two seminarians.

3 i Sexual Misconduct Prevention / Response

This line item funds canonically required classes for the identification and prevention of sexual misconduct, as well as the costs incurred by the trainers. It includes, in some years, the costs of training kits or fees for "training the trainers" sessions. Training in preventing sexual misconduct against both children and adults is required by General Convention resolutions and by diocesan policy.

3 j Bishop's Staff: Canon to the Ordinary

This line item funds the compensation and benefits (namely, auto allowance, medical insurance, pension, social security and Medicare taxes, and worker's compensation insurance) for the Canon to the Ordinary.

Continuing Education for Clergy & Lay Professionals

Not included in the Diocesan Budget is money for grants toward Continuing Education for clergy and congregational lay professionals in the Diocese. These grants are funded from the income of an endowment fund especially set up for this purpose. The income is about \$26,000 per year. A Continuing Education Committee receives grant applications and approves grants up to \$1,500 per person per calendar year. Those receiving grants are expected to submit a follow-up evaluation of their experience and submit an annual report of their continuing education hours. Continuing education is required of all clergy by the Canons of The Episcopal Church. Diocesan policy sets the expected amount at 24 contact hours per person per year. The fund also sometimes covers the honoraria or travel costs of speakers at clergy events.

Commission on Shared Ministry

The Commission on Shared Ministry shall have responsibility for ministries, activities, and programs by diocesan groups and/or facilitated by a team of congregations for individual and congregational growth, including summer camp, youth events, communications, regional ministries, ministries with the communion partners (ELCA), and yoked congregations.

4 a Advertising

This line item covers the cost of advertising in the phone books and in the military information booklets for all churches.

4 b E-Chronicle / E-News

This line item encompasses areas of communications within the Diocese: E-Chronicle (diocesan electronic newspaper), E-News (biweekly electronic updates), public relations/brochures, flyers, etc., as needed. This line includes the funding for an independent contractor hired for this work.

4 c Internet/Website Support

This line item covers the contract with Digital Faith, the online community through which we create the diocesan website. This contract allows any church in the Diocese to have a website at no cost, by using the same template as the diocesan website or one of two other templates available.

4 d Camp Mokule'ia

This budget line item is to support the position of an Executive Director of Camp Mokule'ia. The recommendation for financial support for the Executive Director's position comes out of The Transition Action Team's 2009 recommendations for sustained leadership, vision, and oversight of the operation. This commitment was for three years starting in 2010. Starting in 2013, there is no funding for this line item.

4 e Commission Travel

This line covers the cost of travel and online meeting costs for Commission members to attend meetings.

4 f Korean Ministry

This line item provides for the salary of two priests from South Korea, Diocese of Seoul, who are working to reestablish the ministry for a Korean-speaking congregation. The grant continues support begun during 2011 when funds were granted from the Emergencies and Opportunities Reserve Fund. This ministry is made possible by a partnership with St. Luke's Church.

4 g Native Hawaiian Ministries Committee

This line item funds the Committee created in 1990. In recent years, the funds largely were used for travel for individuals to attend meetings of the Anglican Indigenous Network (AIN), the Executive Council Committee on Indigenous Ministries (ECCIM), and the Indigenous Theological Training Institute (ITTI). This Committee maintains close contact with other indigenous peoples and their faith communities throughout the United States and other parts of

the world and offers various opportunities for education and mission. More recently, this line item has helped to fund diocesan workshops on various aspects of Hawaiian culture and tradition offered by the Committee.

4 h Pacific Islander Ministries Committee

This committee acts as a guide and provides resources for the Pacific Islander Ministry.

4 i Pacific Islander Ministry

This line item provides for the salary of the Missioner for Pacific Islander Ministry. The intent of this ministry is to provide for and facilitate activities and services for the targeted group of the Pacific Islanders' youth and their families who have not had the privileges of engaging in activities because of financial and social reasons. This ministry will attempt to meet the needs of this targeted group by arranging services to include feeding, educational, recreational and social activities, pastoral visitations and church services. Congregations considering outreach ministries to Pacific Islander immigrants and desiring a consultation are encouraged to contact Mrs. Fane Lino through St. Elizabeth's Church.

4 j St. Nicholas, Kapolei

This line item supports the only current diocesan Church plant and is, therefore, a shared ministry of the entire Diocese (<u>http://www.stnickschurch.episcopalhawaii.org/</u>).

4 j St. Philip's, Maili

This line item has supported the shared ministry with Maluhia Church (Evangelical Lutheran Church in America) on the Waianae coast of O'ahu. That partnership is not continuing and exploration will be needed about possibilities of shared ministry with other Episcopal congregations in West O'ahu.

4 j St. Stephen's, Wahiawa

This line item supports the shared ministry with St. Luke's Church, Honolulu.

4 j St. George's, Pearl Harbor

This line item supports the shared ministry with St. Timothy's and, at least from 2011 to the present, Joy of Christ (Evangelical Lutheran Church in America) in Aiea.

4 k Windward Shared Ministry

This line item supports the shared cost of clergy support for the Windward Region. Part-time clergy serve the Calvary Kaneohe Episcopal Mission at the site of the former Calvary Episcopal Church, Emmanuel in Kailua, St. Matthew's in Waimanalo, and St. John's By-the-Sea in Kahaluu. Each of these four congregations also contributes to the clergy compensation and benefits.

4 | Youth and Young Adult Committee

This line item supports the Diocese in providing programs for youth and young adults that are viable, thriving, spiritually refreshing, resourceful, cost-effective, and, most importantly, God-centered.

An estimate of the 2014 Budget is as follows: (\$32,700)

Three interisland events annually, each estimated at \$3,000. There will be a middle school event, a high school event, and a joint middle-high event.

- High school annual gathering (\$3,000)
- Middle school annual gathering (\$3,000)
- Joint middle/ high school gathering (\$3,000)

Neighbor Island Youth additional support (\$4,000). This will serve to support island-wide events or activities on our neighbor islands. It may be used to host an inter-island event or specific island activities or support trainings and travel of our youth and adult leaders to an event or conference.

O'ahu Youth monthly gatherings (\$3,000). This will serve to support a monthly activity, worship, and/or dinner bringing O'ahu youth together to share faith and community.

Youth Leader trainings/meetings/materials (\$2,000). This is for a youth leader materials/ gathering/ training event or conference support for leaders from all islands.

Episcopal Youth Event (\$13,000). Every three years, there is a nation-wide Episcopal Youth Event. In 2014, it will be hosted in Philadelphia, Pennsylvania. It is the Diocese's position to fund one-third of the cost, while anticipating parish and individual support and fiscal responsibility towards the total cost.

University age program expenses (\$1,700). This is to support a young adult event or activities, supporting those ages 18-25.

4 m MacCray House

This covers the cost of keeping and maintaining the MacCray House near University of Hawai'i– Manoa for Campus Ministry.

4 n Summer Camp

"Hui Pu," the Diocesan youth summer camp, will consist of three separate age groups in 2014 and is held at Camp Mokule'ia annually. It will consist of a high school group, a middle school group, and a shorter elementary school (entering grades 4-6) group. There will be a hired trained staff for this event including female and male counselors, a cook, and a camp chaplain.

4 o Youth Director (part time)

This line item includes the compensation and benefits for the Youth Director.

4 p Bishop

This line item includes the compensation and benefits for the Bishop Diocesan.

4 q Bishop's General Convention Travel

This line item supports the annual allocations for the travel and meeting costs for the Bishop to attend the triennial General Convention of the Episcopal Church.

4 r Hospitality

This line item supports the Bishop's ministry who, as part of his episcopate office, hosts individuals and groups, exhibiting Hawai'i's aloha spirit, reciprocating hospitality, and developing partnerships. This also includes funding for the Bishop to support the fundraising activities of the entities on whose board of directors he serves (St. Andrew's Priory, 'Iolani School and Seabury Hall) by virtue of the office.

4 s Keyman Insurance

This line item provides the insurance premium for the Bishop's life insurance benefitting the Diocese as the executive of the Diocese in the event of the Bishop's death.

4 t Travel & Continuing Education

This line item provides for inter-island travel (parish visitations, deanery and clerics meetings, search & vestry consultations, and other meetings), mainland travel (House of Bishops' meetings), spousal travel, continuing education, and other unanticipated travel.

4 u Executive Assistant

This line item includes the compensation and benefits for the Bishop's Executive Assistant.

4 v Lambeth Fund

This Fund was established to cover the cost of Lambeth. No annual allocation is needed for future budgets as the current Lambeth Fund balance of \$31,500 will be sufficient to cover our next Lambeth conference. It is maintained in the budget as a placeholder in case additional allocations are determined to be needed.

4 w Election Process Fund

This fund was established to accumulate monies for electing a new Bishop. We did not use the Election Process Funds to pay for the election of the Bishop as the 2006 operating income was adequate to cover the cost of the election. No annual allocation is needed for future budgets as the current Election Process Fund balance of \$157,000 will be sufficient to cover our next Bishop election.

4 x Administrative Assistant (part-time)

This line item includes the compensation and benefits for the Administrative Assistant.

4 y Meeting Costs: Other

This line item provides funds for incidental and travel costs for meetings that arise because of emergencies or other unanticipated circumstances.

4 z Staff Travel and Related Expenses

This line item supports the ministries of members of the Bishop's staff, especially the Canon to the Ordinary and the Treasurer, to travel to all islands in the state and to North America for meetings, consultations, and church-related programs.

Commission on Mission Beyond the Church

The Commission on Mission beyond the Church shall have responsibility for ministries of justice, peace and reconciliation, being responsive to human needs beyond our walls, including Episcopal Relief and Development, seminary support, feeding ministries, interfaith/ecumenical, and relationship with the Anglican Communion partners and the Philippine Independent Church.

5 a Commission Travel

This line covers the cost of travel and online meeting costs for Commission members to attend meetings.

5 b Ecumenical/Interfaith Relationships

This line item supports efforts to build relationships with, and community among, other faiths through shared communication and participation in the areas of faith-based, spiritual, and social issues aligned with the mission of our Diocese. Institutional membership in The Interfaith Alliance Hawaii (TIAH) and representation on the Board of Hawai'i Council of Churches Fund (HCCF) are part of this support.

5 c Mission Ministries (global and local outreach)

This line item supports funds ministries that advocate for the marginalized, voiceless, dispossessed, needy, oppressed, or imprisoned, through partnerships within the Diocese, the larger Anglican Communion, and with other faith and secular organizations, local, national, and global. The diocesan Convention, at its annual meeting in 2006, mandated that 0.7% of the Episcopal Diocese of Hawai'i's budget be committed to community and international development programs in pursuit of the Millennium Development Goals (MDGs).

Commission on Finance & Administration

The Commission on Finance and Administration shall have responsibility for the corporate and financial needs of The Episcopal Church in Hawai'i including investments, property, compensation review, and budget formation.

6 a General Convention Deputy Support

This line item provides for the accumulation of funds annually to be held in reserve over three years to support the eight deputies and two alternates from our Diocese to attend the General Convention. The 2015 General Convention will be held in Salt Lake City, Utah.

6 b The Episcopal Church Quota

This line item funds the assessment the Diocese pays to The Episcopal Church to contribute toward its work and ministry. It is based on diocesan income, which includes parochial giving, unrestricted operating investment income, and restricted investment income used to pay operating expenses for the respective years. The National Church asking, after deducting a \$120,000 exemption from diocesan income, is computed at a flat rate. The rate was 21% for 2010. The rate dropped to 20% in 2011 and to 19% in 2012 and 2013. The rate is set at 19% for 2014 and 2015 and estimated the same for 2016. The 2014 to 2016 assessment is based on the 2012 to 2014 diocesan income respectively.

6 c Province VIII Quota

This line item funds the assessment the Diocese pays to the Province. Hawai'i is part of Province VIII of the Episcopal Church, and this is the amount the Diocese pays to help with Provincial programs and administration. Through the Synod (the official meeting of representatives of the Province), the Province has set the assessment for 2013 at a minimum contribution of 0.3% of net disposal income, and for 2014 onwards, a minimum contribution of 0.35% of net disposal income from those dioceses currently contributing at or below that amount.

6 d Bishop's Staff

This line item funds the compensation and benefits (namely, auto allowance, group life insurance, medical insurance, pension, social security and Medicare taxes, State unemployment taxes, temporary disability insurance, and worker's compensation insurance) for the Diocesan Treasurer (CFO) and Accountant. This line item also covers the cost of continuing education, funding for an independent contractor hired for Information Technology work and support cost for special projects for all members of the Bishop's Staff.

6 e Archives

This line item covers the cost to maintain the archives for the Diocese of Hawai'i, including archival supplies, pest management, and reproduction of images from other institutions, exhibits, and attendance by the Archivist at a professional development conference.

6 f Audit Expenses - Diocese

This line item covers the cost of a certified public accounting firm to conduct an audit of the diocesan financial records and to prepare a report as annually required by the Canons.

6 g Shared Cathedral Expenses

This line item pays a portion of the Cathedral's maintenance budget because of the presence of the Office of the Bishop in the facilities and because the Diocese uses Cathedral facilities for meetings. This is not income; it is a non-assessable building use expense reimbursement as established by agreement of the Diocesan Council and the Cathedral's Chapter.

6 h Chancellor's Expenses

This line item allows the Chancellor to participate in the Western Chancellors' Conference, and provides access to a computer research service and certain publications in support of the legal assistance that the Chancellor's Office gives to the Diocese and its congregations and institutions.

6 i Diocesan Convention

This line item covers the unreimbursed cost of holding the annual meeting of Diocesan Convention, including area meeting costs, convention meeting costs, supplies, materials, and postage. This cost is net of registration fees/meals and shared travel costs. It also includes an amount for temporary staff help.

6 j Directors & Officers Insurance

This line item provides for liability (errors & omissions) insurance to insure The Episcopal Church in Hawai'i, its directors and officers. The insurance premium is based on our claims experiences and market conditions.

6 k Legal & Related Expenses

This line item represents legal and related costs incurred by the Diocese. Unexpended legal expenses up to \$5,000 will be set aside as a reserve to cover potential legal expenses relating to charges brought against a priest under the new Title IV disciplinary Canons. If legal expenses are fully expended then the funds will be set aside from end-of-the-year budget surplus. The current reserve balance is \$23,500.

6 | Meeting Travel

This line item covers travel costs for the neighbor-island members of Standing Committee, Diocesan Council, Compensation Review Committee, Cathedral Chapter, Commission on Finance and Administration and clergy meetings with the Bishop. We are increasingly trying to use videoconferencing.

6 m Office Expenses

This line item includes telephone, copying costs, equipment maintenance, computer help, subscriptions, postage, equipment purchase, supplies, etc. The budget also includes the cost of software and computer upgrades and staff training.

6 n Property - Cluett

This line item covers the costs of maintenance of the Cluett apartments owned by the Diocese, and it includes utilities and repairs of the apartments, insurance (property & liability), property management fees, and General Excise Tax.

6 o Property – Diocese

This line item covers cost of maintenance of the trees on the diocesan parking lot, vacant lot at the back of St. Peter's and general liability and umbrella insurance.

6 p Property Taxes

This line item pays the property taxes on the parking lot and apartments rented for income by the Diocese.

6 q Security

This line item covers the Diocese's portion of the cost of maintaining security for the Queen Emma Square. The other Episcopal identities on the Square share the full cost of these services.

6 r Kapolei land

This line item covers the property taxes and expenses to maintain the property. Until a church facility is built on the site, the Diocese must pay property taxes.

6 s Medi-gap Program

This line item provides a subsidy to eligible retired clergy and their spouses to cover a portion of the Medi-gap insurance costs.

6 t Renewable Energy Project

This line item continues to support the Renewable Energy Project that was created by the 2010 Annual Meeting of the Convention to help the Diocese "explore the use and implementation of renewable energy options and the theological, financial and environmental implications for the Diocese, its congregations and institutions and (provide) information and (engage) with congregations and groups regarding the use of renewable energy options." This is not funded in the 2014 budget.

6 u St. George's Lease Rent

This line item covers the payments on the current lease with the Navy, which is due to end on December 10, 2013 ("Holdover status thereafter pending sale"). The Navy has declared the land "in excess," and has made an offer to sell the property (2.769 acres) at \$1.1 million plus an estimated conveyance cost amounting to \$56,000. We also have to fix the sewer line estimated to cost approximately \$80,000. We have to accept the offer by December 13, 2013 and it is a binding contract. Once we accept the offer we have two years to raise the money to purchase this property. The site is The Episcopal Church's Pearl Harbor Memorial and it has easy access to the Airport. The Bishop has appointed a workgroup to do due diligence and evaluate the potential opportunities in purchasing the property.

Annual Report of the Treasurer

SUBJECT: Annual Report of the Treasurer

The Balance sheet of The Episcopal Church in Hawai'i on December 31, 2012 showed assets of \$35,641,732; liabilities of \$16,297,735 (of which \$14,331,228 represents parish/mission investments balances); and net assets of \$19,343,997. The total operating income of the Diocese exceeded operating expenses in 2012 by \$17,951. It should be noted that all congregations have paid their 2012 assigned assessments.

James Hasselman, CPA, audited our financial statements. The audited financial statement is posted on our web site. (www.episcopalhawaii.org/resources/(Forms & Documents)finance/audits)

Our audit shows that we have an adequate system of internal control. Appropriate parties must properly authorize all disbursements, and two authorized officers must sign all checks. Our audit committee met with the auditor to review the audit report.

2013

- 1. In your Convention Packet, you will find the current Budget versus Actual Operating Report as of August 31, 2013. The report is summarized to cut printing costs. If you want a detail report, please call me.
- 2. In your Convention Packet, you will also find a report on our Theological Education Offering for 2012. You will note that we contributed \$29,716, which amounted to approximately one-third of our 1% goal. Now is the time to be checking on the performance of your Parish or Mission this year so that we can meet our 1% goal in 2013.
- 3. Our Investment performance numbers are as follows: Year to date at 8/31/13 = 4.2%; trailing 12 months = 6.3%; 3 Year trailing = 8.5%; Since 6/30/92 = 8%.
- 4. During the year, the Commission of Finance and Administration met with our investment monitor and managers to review the performance of our investment portfolio and also to review our Investment Policy. In March 2013, the Commission added an additional portfolio manager: Stonebridge Advisors LLC, a Preferred Securities Manager. We rebalance our portfolio when needed. We have a long-term view towards our portfolio management with the understanding that the stock market will experience fluctuations

from time to time. We have a total return investment policy and spending policy. Our policies are implemented to ensure that there will be a steady stream of earnings annually, while at the same time ensuring that the fund assets will be there for the future. Our spending policy is set at a payout rate of 5 percent (5%) of the average market value of the Investment Fund over twelve quarters. The spending policy (which we will continue to review), together with sound investment performance, ensures that, over time, the fund will retain its ability to produce earnings. - 5. The setting up of the Shared Travel Expense Fund for the 2013 diocesan convention has been accomplished.
- 6. The rate of assessment for 2014 to 2016 is proposed at 20%.
- 7. The Compensation Review Committee (CRC) is submitting a compensation schedule reflecting a 2% increase over the current year. Please refer to the CRC report and the 2014 Clergy Compensation and Benefits policy for details.

Thank you all for complying with the recent mailings relating to the Affordable Care Act.

- 8. During the year, I worked with treasurers advising and training them on various matters, such as taxes, accounting and audit, investments, insurance, parochial reports, employment, insurance and property issues. I also worked with them on refinancing loans from the bank at competitive rates for various renovation projects.
- 9. During the year, I coordinated with the auditors and treasurers to audit their churches' financial records. Thanks to the church treasurers for doing the audit work papers for the audit.
- 10. I am working with Church Insurance Company of Vermont to renew our property and liability insurance renewal for the year 2014. In 2012, we stopped using an agent (AON) and I now work directly with Church Insurance Company of Vermont. This resulted in approximately \$50,000 savings in total premiums for 2012.
- 11. I continue to work with the Church Pension Fund (CPG) to assist the churches in enrolling lay employees in the Lay Pension Plan.
- 12. We continue to hold training workshops for Safeguarding God's Children and Preventing Sexual Misconduct (adult). We are now using the Church Insurance Co. web-based training available for Safeguarding God's Children.
- 13. Please use our website, www.episcopalhawaii.org. We are working to add more content to the web site. It has helped us cut down our copying and mailing costs.

- 14. The Stewardship & Planned Giving Commission had its fourth Legacy Society event in 2013. Legacy Society events will be held on all four islands. We have increased our Legacy Society membership to 102. The purpose of the Legacy Society is to recognize those who have remembered their church in their estate plans, and —more so to enable members to witness to the value of their church in their lives and to secure ministries for generations to come. Thank you all for including your church in your will. Please go to our website to see the Planned Giving Material. (www.episcopalhawaii.org/resources/(Forms & Documents)finance/Legacy Society)
- 15. The Diocesan Stewardship & Planned Giving Commission began stewardship in March of 2010. In 2011, we spent our time doing Bible and book study, drafting our mission statement, goals and objectives and received training on stewardship mentoring. The Commission also had stewardship conference training events on O'ahu and Kaua'i in 2011 and on Maui and Hawai'i Island in 2012. A workshop was also held for clergy in 2012. In 2013, we had a stewardship retreat at Camp Mokule'ia, which was attended by 35 folks from all islands. We are currently working on mentoring two congregations in conducting stewardship programs.

June and I would like to thank the treasurers, wardens and clergy whose work, cooperation and goodwill have helped us in our work. Many thanks also to the members of Diocesan Council, Commission on Finance and Administration and all its subcommittees, Diocesan Compensation Review Committee, Stewardship and Planned Giving Committee, Kapolei work group, St. George's work group, folks on special projects, Chancellor and Vice Chancellors and Office of the Bishop staff and Sharon Billingsley. Thank you all for your support and the gifts you share with us. Thank you, Ray Kamikawa, for serving as the Vice Chancellor for so many years and our warm regard as he concludes his ministry to the Diocese.

Most of our churches gave to the Church Divinity School of the Pacific, Virginia Theological Seminary, or University of the South School of Theology with some money going to The Anglican Church Seminary, Claremont School of Theology, Episcopal Seminary of the Southwest, Society for the Increase of Ministry, St. Andrew Theological Seminary, St. Luke's School of Theology, and others.

National Canon Title 1-Canon 7 Sec.1(f)

All accounts of the Diocese shall be audited annually by an independent Certified Public Accountant. All accounts of Parishes, Missions or other institutions shall be audited annually by an independent Certified Public Accountant, or independent Licensed Public Accountant, or such audit committee as shall be authorized by the Finance Committee, Department of Finance, or other appropriate diocesan authority.

Diocesan Canon- Section 41.1.5

All accounts shall be audited annually by such an accounting method as shall be permitted by the Diocesan Council. All reports of such audits, including any memorandum issued regarding internal controls or other accounting matters, together with a summary of action taken or proposed to be taken to correct deficiencies or implement recommendations contained in any such memorandum, shall be filed with the Bishop or Ecclesiastical Authority not later than thirty (30) days following the date of such report, and in no event, not later than September 1 of each year, covering the financial reports of the previous calendar year. Those congregations that fail to comply with the September 1 deadline shall be reported by name to the next Annual Meeting of the Diocesan Convention and such report shall be recorded in the Minutes of said Annual Meeting.

REVIEW OF ACTIVITIES:

The Commission on Ministry seeks mainly to follow, support, and evaluate people who are considering ordained ministry (the diaconate and priesthood), and to recommend guidelines for licensed ministries. Also falling under our purview are clergy deployment, continuing education, safe church trainings, and other facets of leadership development in the Diocese. Since last year's meeting of the Convention, one person has been ordained to the Priesthood. We hope that two individuals will be ordained at the Holy Eucharist service held during the meeting of Convention. We currently have two individuals pursuing the traditional Master of Divinity degree at Virginia Theological Seminary. This year and last were very busy years for us as we began Waiolaihui'ia, the local priest formation program, based on the Iona Initiative (developed by eight dioceses from the Iona School in the Diocese of Texas). There are currently three students pursuing ordination and one auditor in Waiolaihui'ia, which is a three-year program of six three-day weekends. Several priests work with these individuals to support, teach, and mentor them. Naimiloa, the local deacon formation program, has been restructured and is working well. It, too, includes priests who support, teach and mentor. Naimiloa currently includes seven students and meets one Saturday a month for two academic years.

REVIEW OF EXPENDITURES:

As of the end of August 2013, we have spent \$47,768. Last year we paid \$10,000 to begin our Iona Initiative program. We pay \$10,000 for the Iona Initiative this year (and then a final \$10,000 next year.) There are travel costs and stipends for priests who teach portions of the Iona Initiative formation, as well as those who serve as mentors. We provide tuition assistance for our seminarians at Virginia Seminary. Other facets of the ordination process (including psychological testing, background tests, etc.) are additional expenses. Also covered in the COM budget are subsidies for the annual Clergy Retreat and the costs of clergy continuing education days.

Thank you to all who make our work possible. This includes applicants, Postulants, Candidates, those in the local formation programs, those *helping* with the local formation programs, examining chaplains, seminarians, mentors, discernment committees, Bishop's Committees, and Vestries. We give thanks to our Lord for you always, and for all of your assistance in this holy ministry and, primarily, we give thanks for the work of the Holy Spirit in all discernment.

At the center of CRC discussion this year was attracting and retaining clergy whose talents and calling support the goals of transforming the Episcopal Church in Hawai'i and our congregations into vital and vibrant faith communities. How do we compensate clergy in support of those goals and in an amount that will provide a reasonable, moderate standard of living? That question is an important one. And, the answer has a profound impact not only on clergy and their family but on congregational life and the quality of the relationship between clergy and congregation.

The Diocese of Hawai'i establishes minimum guidelines to assist churches in determining fair compensation for clergy that will allow a reasonable, moderate standard of living and, that will attract, retain, and support them in their role and growth as faithful ministers of the Gospel, and in the pastoral care of the church. These guidelines are also established with the recognition that Hawai'i's cost of living is one of the highest in the nation which helps create the need to keep minimum compensation at a level that will maintain a competitive position for attracting quality clergy.

Nearly every year, the cost of basic goods and services goes up. If clergy compensation is not adjusted accordingly, we end up reducing clergy salary simply by keeping it the same. The most recent Hawaii Consumer Price Index (HCPI) increased by 2.5%. After reviewing current guidelines, compensation data for Episcopal Clergy across the nation and the HCPI, the CRC is recommending a 2% increase to all compensation categories. The CRC believes this increase will maintain a competitive compensation structure for the Diocese in the coming year in this current economy.

For 2014, the CRC proposes the automobile allowance be \$8,800.

Additionally, the CRC strongly encourages each congregation to prayerfully consider the experience, talent and skills of your clergy and review with clergy the progress towards agreed upon goals each year. The Mutual Ministry Review, as outlined in the 2014 Compensation and Benefits Policy, is designed to assist both priest and congregation in facilitating the development of expectations of the shared ministry they have entered into. These factors should be the basis for discussion with clergy in establishing an appropriate level of compensation. Even in a situation where a church's resources are severely limited and the church is unable to offer a compensation level that it might like to, the fact that discussion between priest and Vestry has taken place has a positive impact in terms of morale and open communication and is central to the sacred trust shared by clergy and their congregation.

The only expense of the CRC is travel for neighbor island committee members. The Committee would like to acknowledge and thank Mr. Peter Pereira for his dedication and support to the CRC and the Diocese.

In 2012, Journals of the Annual Meetings of Convention of the years 2006 through 2010 were sent to the Archives of the Episcopal Church. We also posted all Journals of Convention back to 2000 on the Diocesan Website.

The CD version of the Journal of the 43rd Annual Meeting of Convention, October 29, 2011 was distributed to each church in the Diocese and to every Canonically Resident Clergy at the meeting of the 44th Convention on November 10, 2012.

The Journal of the 44th Annual Meeting of the Convention, which was held on November 10, 2012, was completed by December 31, 2012. Copies were provided to the Bishop, the Archives and to the National Church Archives by December 31, 2012.

According to Canon 9 of the Canons of the Episcopal Diocese of Hawai'i: It shall be the duty of the Registrar of the Diocese to receive and preserve in some safe place, the Journals of the Convention of this Diocese, the Journals of the General Convention, such other records as belong or shall hereafter belong to the Convention and all Parish Registers, documents and papers belonging to the Diocese, the Standing Committee or other Diocesan bodies or officers and not required to be kept by any other person or officer.

It is my determination that the safe place in this Diocese is in the Archives, which is managed by our Historiographer, Mr. Stuart Ching. The Archives contains the fireproof safe specified in the canons, and are accessible to all on an appointment basis. During my tenure, I intend to establish a system for keeping the records of the meetings of Council and Standing Committee and other Diocesan bodies as well as the Journals of Conventions.

It should be noted that space is limited in the Archives, and when the Diocese reviews its needs for additional space, the Archives should be taken into consideration.

REPORT:

The purpose of the Stewardship Commission is to help clergy, lay leadership, and congregations in the Diocese of Hawai'i to grow in their relationship with Jesus Christ by responding to God's generous blessings with their time, talents, and treasure.

In 2013, the Planned Giving Commission was merged with the Stewardship Committee, and the budgets of both bodies were combined (\$23,400). The stated purpose of the Planned Giving Commission – To build awareness of planned giving in the hearts of Episcopalians throughout this Diocese – is now being fulfilled through the Stewardship Committee.

A. Our first goal is to offer guidance to clergy and lay leadership in understanding that stewardship is integral to our journey of becoming disciples of Jesus Christ. To that end:

- The Committee is sponsoring a Stewardship Retreat at Camp Mokule'ia on September 27–29, for which 35 people have registered. The Committee is paying the Camp fees plus one roundtrip airfare for each neighbor island parish, a total of approximately \$6,000. Participants are paying only the meal fee (\$65).
- Committee members have written articles on stewardship themes, including planned giving, which have been published in every issue of the e-Chronicle in 2013.
- We surveyed most of the churches in the Diocese about their stewardship activities in order to plan a relevant agenda for the retreat.
- We had a display table at the fair on the Friday prior to Convention in 2012.
- The Committee has engaged with Church of the Holy Apostles, Hilo, to support stewardship efforts through 2013.
- The Committee has engaged with the Church of the Good Shepherd, Wailuku, Maui, to strengthen the lay leadership as they conduct a search for a new rector.

B. Our second goal is to articulate the Christian responsibility to grow in giving to the tithe or beyond and to collaborate with the Office of the Bishop and the parishes to embed this understanding. Hō'ike Ulu Legacy Society luncheons have been held on Kaua'i and O'ahu and will be held on Maui and Hawai'i before the end of the year. The Legacy Society has grown from 40 founding members in 2010 to 100 members in 2013.

C. Our third goal is to encourage other commissions in the Diocese to embrace stewardship formation in their programs. We are grateful to the Commission on Vibrant Christian Communities for \$1,500 contribution that enabled two of our members to attend the Episcopal Network for Stewardship (TENS) Conference in Salt Lake City, Utah, in July, 2013.

D. Our last goal is to offer ourselves as ambassadors of generosity to congregations. Committee members have offered to lead book talks with various congregation and groups. They have engaged in book talks about *Ask, Thank, Tell*, an excellent primer on stewardship by Charles R. Lane with groups at St. Luke's, with folk from St. Mary's and Good Samaritan, and at St. Michael and All Angels.

REPORT:

Review of activities and those who participated or served:

Communications — This is a relatively small, yet vital portion of our budget. It provides staffing to generate the e-Chronicle and e-News, our principle means of communication for the Diocese. This online method allows for easy sharing too. This part of the budget also provides for some limited advertising and our Diocesan webpage. The current web provider allows for our churches to have sites at no additional cost.

Direct Ministry Support — Several of these ministries will report independently; please look for these reports as well. Camp Mokule'ia received no financial support this year and is doing well. The Korean Ministry, establishing a new Korean language ministry and outreach, included a weekly worship service at the Cathedral and a presence at UH Manoa. The Committee on Native Hawaiian Ministries is focused on helping instill Hawaiian culture within our churches, hosting a laulau-making event is an example of gathering several congregations around our heritage in the islands. The Pacific Islander Ministry and its Committee serve as an important connection in several communities.

St. Nicholas, St. Philip's, St. Stephen's and St. George's all serve Leeward O'ahu communities. Further collaboration may be possible, which could help to reduce the overall need.

The Windward Shared Ministry serves multiple congregations, a model that we as a Diocese are hoping to learn from and continue to improve upon.

Youth and Young Adult Ministry, Summer Camp, and Youth Director were an area of change in 2013. I refer you to their report.

The Episcopate — The expenses of employing our Bishop and his Executive Assistant are represented here. Our chief pastor helps shape our collective identity and direction.

Review of expenditures: Most of the Shared Ministry budget expenses are predetermined. Most of these lines are therefore not prone to over-runs; however, most are realized in full.

Review of goals achieved by activities: A great deal of ministry happened because of the funding included here. Hopefully this overview helps in providing greater understanding.

REPORT:

Much of this year has been networking and developing a plan for the future of youth ministry in this Diocese. I have tried to be in contact with many parishes and youth throughout the islands and foster connections that will help youth ministry continue to grow in Hawai'i. I am currently working to construct a "team" of adults and youth to help plan and represent different areas of the islands to help foster communication and growth in our youth ministry programming. Some of our youth programs are outlined below:

30 Hour Famine – April 2013: This past April, 32 youth participants from O'ahu, Kaua'i, Maui, and Hawai'i participated in The 30 Hour Famine, held at St. George's, Honolulu. There were also 16 adult leaders, cooks, drivers, ministers, and planners involved from three of the islands. The youth raised \$2,226 for world hunger and completed 86 collective hours of labor at a local homeless shelter and donated 202 pounds of food to the food pantries at St. Elizabeth's, St. Timothy's, and St. Clement's. There was no registration fee and the total cost for the event was less than \$1,800 for a three-day event.

Hui Pu – July 2013: Hui Pu, the Diocese's summer youth camp held at Camp Mokule'ia, was a huge success with 48 participants from grades 4–12. It was organized and run with four paid camp staff, one director, and numerous volunteers, including a camp chaplain and two kupuna. In total, camp cost around \$9,000 this year, even with having to replace and purchase much of the camping equipment.

O'ahu Monthly Youth Gatherings – Began Sept. 2013: Several churches on O'ahu participated in a survey about getting together monthly for island-wide activities in partnership with the Lutheran churches of O'ahu. These gatherings started in September with a back-to-school event, "Games, Grinds, and God," with 30 youth and 11 adults participating. The main cost of these events will be food as they are being hosted in rotating churches on the island and will include dinner, activities, and worship.

Coming in December will be a "Christmas at Camp" middle school–only event at Camp Mokule'ia. This event is going to be a great weekend retreat for 6–8th grade students for bonding, learning, and worship during the Christmas season.

There were also opportunities for youth leaders to gather and discuss youth ministry on O'ahu, Maui, and Kaua'i. Several youth leaders also became trained as trainers for the Safeguarding God's Children program.

I was able to attend some continuing education at the 2013 Hawaiian Island Ministries conference, and will be attending the Western Christian Educator's Conference in October in Tahoe, recommended by the Province VIII youth ministry network.

Commission on Mission Beyond the Church

The Commission on Mission beyond the Church shall have responsibility for ministries of justice, peace and reconciliation, being responsive to human needs beyond our walls, including Episcopal Relief and Development, seminary support, feeding ministries, interfaith/ecumenical, and relationship with the Anglican Communion partners and the Philippine Independent Church.

Commission on Finance and Administration

The Commission on Finance and Administration (COFA) is established to provide due diligence on financial, contractual, lease, real property, and investment management actions under the authority of the Diocesan Council. COFA is delegated approval authority on contracts and leases with a value to a certain amount and authority to authorize certain transactions involving the diocesan investment portfolio consistent with approved policies and guidelines.

COFA members are appointed by the Bishop as president of Diocesan Council and approved by the Council. Members are James Putnam (chairperson), John Decker, Albert Wong, Kathy Sato, Tom Kelly, and the Rev. Paul Lillie. The Diocesan Treasurer, Peter Pereira, serves as an *ex officio* advisor to the Commission. COFA members include experts in investments, real property, leases, construction, and program management. Two COFA members are also members of Council.

Investment Portfolio: The Diocesan investment portfolio includes funds managed by Council and pooled funds from parishes, missions, and instrumentalities of The Episcopal Church in Hawai'i (TECH).

-As of August 31, 2013, the market value of the investment fund was \$28,622,755. -This represents a 6.34% gain for the trailing year.

Leases, Contracts, Real Estate Reviews: COFA provided reviews on all actions requiring TECH approval, worked with the requesting parishes and missions, and either approved or recommended to Council for approval. Examples of actions include leases for church property use, such as preschools and seniors' activities, and photovoltaic installations. A number of construction contracts were reviewed, as well as actions where the Diocese had an interest in real property. Albert Wong is recognized for his efforts in working with congregations and activities in developing and implementing photovoltaic systems.

COFA's chairperson also served on the Diocesan Audit Committee and the St. George's Working Group.

The Commission wishes to express its appreciation to Peter Pereira for his invaluable assistance and leadership supporting COFA and the Diocese, its parishes and missions.

Camp Mokule'ia (Episcopal Camp and Conference Center at Mokule'ia)

Let me share about the camp's year by reflecting on a special event that occurred on August 12. The Rev. Moki Hino, the entire staff, most of their families and myriad supporters of Camp Mokule'ia gathered that day to bless and give thanks for the ministry of Camp Mokule'ia. Our gratitude for the gift the Camp represents in the lives of each of us and our guests was so deep that it took us almost two hours to pause and celebrate at its many places of ministry.

We spent time at each of our main lodging facilities and celebrated the success that has followed the last number of years of restoration and renovation. This past year, we had more than 25,000 annual guest nights (an over 80% growth in the past five years). We extended that blessing to our kitchen and staff as they work so hard to share "good, simple food cooked well" with all our guests.

Crossing the street, we stood in the middle of our 10 mauka acres and blessed the early stages of a sustainable farm which began on that land this year. Not only will local, wisely grown food come to our kitchen from this land, but also, thousands of people, as they assist our efforts, will experience first-hand the wonders of God's harmonious and balanced Creation. As this report is being written a well is being dug, and conversations have begun with our Pacific Islander brothers and sisters as to how this land might become a vehicle of ministry of and with them.

A ten-minute walk from the farmland led us to the shoreline wilderness area adjacent to our camping field that we lease from the City and County of Honolulu. We were all filled with the beauty of this special "remote" place and excited at the possibilities emerging this year for "wilderness" camping and for various spiritual activities such as a natural labyrinth.

Walking back along our more than ³/₄ miles of shoreline, albatross who have returned to nest at Ka'ena point flew above, the ocean before teemed with special life such as our regular *honu* visitors, our occasional monk seal guests, and our seasonal humpback whale guests. Part of the charm of Camp Mokule'ia is, indeed, our opportunity to appreciate that in our life as humans we are not so much apart from God's Creation, but, rather, a part of such amazing Creation splendor.

One of our last stops was at the far end of our camping field where we gave thanks not just for our many campers, but in particular, we paused in the area where the diocesan Summer Camp, now known as Hui Pu, took place just a month earlier. How excited we are for not just the faithful play and joy we anticipate for 2014 Hui Pu, but the many other diocesan youth gatherings that are now scheduled at the Camp. These additional youth events are reflective of increased diocesan use of the Camp that we saw in 2013. This is a trend we have long hoped for.

Before we concluded our time of blessing with a Eucharist celebration and a swim in the ocean we made sure that we paused in the places where our staff spend most of their days. Our staff (which now includes 4 interns each year who are part of the Episcopal Service Corps) is now almost exclusively full-time and is filled with individuals who truly are committed to the Camp's mission. They are largely responsible for our budget continuing to grow (now at over \$1.1 million), our guests continuing to love being at the camp, and our land continuing to thrive (with many sustainability projects, including native plant restoration throughout and a 56KW photovoltaic system installed this year). On August 12 we didn't just ask God's blessing on the Camp; rather, we mostly thanked God for the blessing that the Camp already is and will continue to be. It is truly a gift to be part of this sacred place.

Program Developments

The 2012–2013 academic year was devoted to a comprehensive Strategic Planning process. The School hired the firm of Ian Symmonds Associates (Portland, OR) to lead the effort. All constituencies were involved through surveys and many took advantage of the opportunity for telephone interviews and participation in meetings on campus. The Steering Committee was comprised of 18 representatives from the trustees, parents, alumnae, faculty and community leaders.

The process led the School to re-examine how its work today continues to be an extension of Queen Emma's initial vision. This led to study and conversation about the School's royal and Episcopal heritage, its academic program within a culture of technological innovation, its international focus in a global marketplace, and the many advantages of its downtown location. The conclusions drawn and decisions resulting from the process will be shared with the local community and community at large in late October.

In relation to the above, the School has continued its work in curriculum mapping and training in differentiation and blended learning (the balance between traditional and online instruction). With regard to the latter, Priory teachers have emerged as being at the cutting edge of these new educational challenges, offering training to teachers at other independent schools.

The new *Priory in the City* program will expose students in grades 10–12 to the realities of the world of work. The students will take vocational assessments and receive coaching as they discover where their future career opportunities may be. Senior girls will be ready for true internships and mentoring in a local business, government agency or non-profit organization.

Constituent Relations

The Strategic Planning process gave the School the opportunity to engage all of its constituencies in contributing to the Priory's future direction. For the communication of the plan later in October, the school will host gatherings for alumnae and parents so that they can learn about the exciting decisions that were made.

Fund Raising Initiatives

The 2013 Queen Emma Ball raised \$330,000 to support the School's financial aid program and teacher professional development.
