JOURNAL OF PROCEEDINGS

Friday, October 27, 2000

OPENING SERVICE: The 32nd Annual Meeting of the Convention of the Episcopal Diocese of Hawai'i officially began with Holy Eucharist at 1:30 p.m. at St. Andrew's Cathedral in Honolulu. The sermon was delivered by The Rt. Rev. Rustin R. Kimsey, Retired Bishop of the Diocese of Eastern Oregon.

Prior to the service, the Episcopal Church Women (ECW) held a luncheon in Davies Hall on the grounds of St. Andrew's Cathedral.

MEETINGS OF REGIONAL CAUCUSES: At approximately 3:00 p.m., the Regional caucuses were held for the purpose of deciding on their nominees to the Diocesan Council. The caucuses were held for the first time due to the amendments to Canons 13 and 13A that were adopted at the 31st Annual Meeting of the Convention in October 1999. Effective with the convening of the 32nd Annual Meeting of the Convention, the Deanery system was converted into a system of Regions. At the same time, the organization of the Diocesan Council was changed as well. In lieu of a representative being selected (serving a one-year term) by each of the seven Deaneries, each of the seven Regions of the Diocese of Hawai'i nominate at least one individual to serve a three-year term (except in this first year when terms will be staggered). These nominee(s) will be voted upon by the members of Convention, with one nominee elected per Region.

WELCOME AND CALL TO ORDER: Bishop Chang welcomed the clergy, delegates, and guests. The legislative portion of the annual meeting was called to order at 3:30 p.m. in Tenney Theatre.

QUORUM REPORT FROM THE CREDENTIALS COMMITTEE: Bishop Chang, President, called on the Chair of the Credentials Committee, Mr. Bruce Fink, for a quorum report. Mr. Fink reported that 28 of the 83 canonically resident and domiciled clergy constitutes a quorum in the clerical order, and that 85 of the 169 lay delegates constitutes a quorum in the lay order. There being 51 clergy and 150 lay delegates registered, a quorum was established and present for the transaction of business.

Bishop Chang declared the 32nd annual meeting of the Convention duly constituted, open and ready for business.

Report from the Credentials Committee Regarding Congregations that had not paid their assessments in <u>full by January 15, 2000</u>. Mr. Fink presented the following motion, and, on behalf of the Committee, moved its adoption:

BE IT RESOLVED, that the members of the lay delegation from the following parishes, such parishes now having paid in full their assessments for the fiscal year 1999, be admitted to seats and votes in this Annual Meeting of the Convention: St. Michael and All Angels', Christ Memorial.

The motion, requiring no second, carried by voice vote.

Mr. Fink reported that, with the addition of the delegates from St. Michael and All Angels' and Christ Memorial, now duly seated, the revised lay quorum is 89 of the 177 lay delegates, with 158 lay delegates present.

Report from the Credentials Committee regarding congregations that had not paid their 1999 assessments in full by January 15, 2000 and still have not done so. Mr. Fink presented the following motion, as recommended by Diocesan Council, and, on behalf of the Committee, moved its adoption:

BE IT RESOLVED, that the members of the lay delegation from the following parish, upon the recommendation of the Diocesan Council, be admitted to seats and votes in this Annual Meeting of the Convention: Trinity Church By-the-Sea.

The motion, requiring no second, carried by voice vote.

Mr. Fink reported that, with the addition of the delegates from Trinity Church By-the-Sea, now duly seated, the revised lay quorum is 91 of the 181 lay delegates, with 162 lay delegates present. The first ballot was distributed and, at 4:18 p.m., the Chair instructed the members to begin voting. At 4:27 p.m., the President announced that the polls were closed. BE IT RESOLVED that, with regard to the election of members of the Diocesan Council from the Regions, the nominees receiving the three highest number of votes shall be elected to three-year terms, the nominees receiving the next two highest number of votes shall be elected to two-year terms, and the nominees receiving the next two highest number of votes shall be elected to one-year terms;

AND BE IT FURTHER RESOLVED, that in the event of a significant tie, the nominees, or a designated representative if the nominee is not present, shall draw straws and the

individual drawing the shorter or the shortest straw, as the case may be, shall be declared the winner.

RECONVENING OF THE MEETING: The President called the meeting back to order at 6:01 p.m.

RECESS: Bishop Chang declared the Annual Meeting in recess until 8:00 a.m. Saturday morning.

<u>BANQUET</u>: A banquet, to which the entire Diocese was invited, was held in the evening at the Radisson Prince Kuhio Hotel in Waikiki.

Saturday, October 28, 2000

RECONVENE: The President called the annual meeting of the Convention back to order at 8:05 a.m. The Bishop announced that copies of his address to the Convention were available at the distribution table.

<u>INTRODUCTION OF GUESTS NOT PRESENT ON FRIDAY</u>: The President introduced Kathy Stevens, wife of The Rev. Walter Stevens, and Pat Bergen, wife of The Rev. Franklyn Bergen, who were presented with lei.

REPORT ON THE FIRST BALLOT: The President called on Mr. Dwayne Bueno, Chair of the Elections Committee to report the results of the first ballot. The number of votes cast for each nominee were announced. The following are the results of the elections:

No additional ballots were required.

MORNING DEVOTIONS AND BIBLE STUDY: The music ministry of Grace Church, Moloka'i filled the Theatre with uplifting spirit. The Rt. Rev. Rustin Kimsey introduced the Bible Study.

RECESS: The President recessed the Annual Meeting at 8:40 a.m. for bible study and small group discussion.

RECONVENE: The President called the annual meeting back to order at 9:48 a.m.

ANNOUNCEMENTS: The President announced that the Standing Committee has elected The Rev. Joseph Carr as President and Annette Jim as Secretary.

RESPONSE TO THE BISHOP'S ADDRESS - SPECIAL ORDER OF BUSINESS #2: The President called on Bill Lucas, Chair of the Committee on the Response to the Bishop's Address. Mr. Lucas introduced the Committee members: The Rev. Alejandro Geston, Marilyn Hirashima and Beverly Van Horne. The message was frequently interspersed with humor. Refer to Attachment G for the Committee's response.

STANDING COMMITTEE REPORT - SPECIAL ORDER OF BUSINESS #3: The President called on Rhoda Hackler, President of the Standing Committee. Ms. Hackler reported on the Mutual Ministry Review, conducted in response to Resolution #7 of the 1998 Annual Meeting. Refer to Attachment H for a copy of the Report.

COMPENSATION SCHEDULES FOR 2001 – RESOLUTION #1: The President called on The Rev. Marvin Foltz, Chair of the Finance and Real Estate Department, to report on Resolution #1. Fr. Foltz reported that the Department is in concurrence with the Diocesan Council and, on behalf of the Department, moved adoption of the Resolution as presented. There was no discussion on the resolution. The motion, requiring no second, carried by voice vote. Resolution #1 was adopted as presented. Refer to Attachment J.

EPISCOPAL MINISTRY ON AGING (EMOA) - SPECIAL ORDER OF BUSINESS #4: The President called on The Rev. Pat Leo, Chair of EMOA. Rev. Leo introduced The Rev. Gerhard Laun, who recited words from the nominators of the honorees. Bishop Chang presented the award on behalf of the Diocese to members of the Church who are 70 years or older and have given outstanding service in their congregation and community. PRESENTATION OF THE 2001 DIOCESAN BUDGET: The President again called on The Rev. Marvin Foltz for the presentation of the 2001 Budget. Fr Foltz, on behalf of the Finance and Real Estate Department, moved the adoption of the Budget at presented. Refer to Attachment I.

The Rev. Joe Carr, Calvary, on behalf of the Standing Committee and in accordance with the Mutual Ministry Review, moved to amend the Budget to increase the Salary of the Bishop by 15%, an increase of \$11,919 over the amount printed in the budget as circulated. Fr. Carr reported that funding for the Bishop's compensation, including the Bishop's secretary, comes from the Episcopate Endowment Fund and does not affect the level of assessments to congregations. Motion carried by voice vote.

Ernie Knudsen, All Saints, moved to amend the budget to reflect assessment level of 15%. Motion seconded. Following lengthy discussion and a voice vote, the motion failed.

Further discussion on the 2001 Diocesan Budget was continued after lunch.

STEWARDSHIP COMMITTEE PRESENTATION, PART 2 – SPECIAL ORDER OF BUSINESS

#1: The President called on Beverly Van Horne of the Stewardship Committee who introduced a video presentation (available via The National Network on Stewardship), featuring The Rt. Rev. William Burrill.

NOONDAY PRAYERS: The President called on Charlotte Holmes and the Grace Church musicians to lead the members of the Convention Noonday prayers and song and for the reading of the Necrology (Attachment R).

RECESS FOR LUNCH: The President recessed the Annual Meeting of the Convention at 12:30 for lunch.

RECONVENE: The President called the Annual Meeting back to order at 1:32 p.m.

ST. JOHN'S 100TH ANNIVERSARY CELEBRATION - SPECIAL ORDER OF BUSINESS #5: The President called on The Rev. Heather Mueller-Fitch who recognized Jean Fiddes, St. John's historian and organizer of their Centennial celebration, to review the history of the church from its founding by the Rev. Shim Yin Chin. The Convention viewed a videotape of portions of their celebration. Rev. Mueller-Fitch then asked the Convention to sing "Sandalwood Hills and Fountains of Gold" to the tune of "Faith of Our Fathers."

PRESENTATION OF THE 2001 DIOCESAN BUDGET (CONTINUED): The President called on Mr. Jim Putnam, member of the Finance and Real Estate Department, to continue the presentation of the 2001 Budget. Mr. Putnam reminded the Convention that the Budget has been amended in regards to the increase in the Bishop's compensation and a corresponding increase in the income from the endowment.

The Rev. James Hargis, All Saints', made the following motion: "I would propose, as an amendment to the 2001 budget, The Episcopal Church in Hawaii implement a mandatory assessment on all parishes and missions of 15%, and encourage all parishes and missions to voluntarily contribute additional funds to support The Episcopal Church in Hawaii." The motion failed for lack of a second.

The question was called on the 2001 Diocesan Budget as amended. Motion carried by voice vote.

<u>CLARIFICATION OF RESOLUTION PROCESS</u>: The Bishop clarified the process for considering each resolution. Departments to which resolutions were referred were asked to recommend one of the following actions:

- 1. Adoption as presented,
- 2. Adoption with amendment,
- 3. Discharge from further consideration, or
- 4. Rejection

The votes cast by the Members of Convention are on the adoption of the appropriate Department's report or recommendation. If the recommendation is to adopt the resolution, then a "yes" vote by the members supports the Convention adopt the resolution. If the recommendation is to reject, then a "yes" vote supports the rejection of the resolution.

LOWERING THE HAWAL'I DIOCESAN ASSESSMENT – RESOLUTION #2: Due to the discussion that took place during the presentation of the 2001 Budget, as detailed above, Mr. Putnam moved that the Department be discharged from consideration of the resolution (Attachment K). The motion was seconded and carried by voice vote.

<u>ADOPTION OF ZERO BASED BUDGETING – RESOLUTION #3</u>: Mr. Putnam reported that the Department recommended rejection of the resolution (Attachment L) and, on behalf of the Department, moved adoption of the Department's recommendation. The motion, requiring no second, carried by voice vote. The Department's recommendation was adopted and the resolution was rejected.

<u>DIOCESAN MISSION STATEMENT – RESOLUTION #4</u>: The President called on Nancy Ries, Chair of the Nurture and Education Department. On behalf of the Department, Ms. Ries moved adoption of the resolution with an amendment to the title (Attachment M). The amended title reads, "The Mission Statement for Christian Formation in the Diocese of Hawai`i." The amendment was accepted by John

Hawkins, a member of the Commission on Ministry, on behalf of the Commission, as a friendly amendment. The motion, requiring no second, carried by voice vote. The resolution was adopted as amended.

<u>AMENDMENT TO CANON 3 – RESOLUTION #5</u>: The President called on Adrienne King, Chair of the Constitutions and Canons Committee. On behalf of the Committee, Ms. King moved adoption of the resolution (Attachment N). The vote was taken by orders and carried in each order. The Bishop concurred. The resolution was adopted and Canon 3 was amended accordingly.

50TH **ANNIVERSARY OF THE DIOCESE OF OKINAWA – RESOLUTION #6:** Ms. King, Chair of the Church in Society Department, to which the resolution was referred, on behalf of the Department, moved adoption of the resolution (Attachment O). The motion, requiring no second, carried by voice vote. The resolution was adopted.

SET DATE AND LOCATION OF THE 2002 ANNUAL MEETING OF THE CONVENTION: The President called on Jane Tonokawa, Secretary of the Convention. Ms. Tonokawa moved that the 2002 Annual Meeting of the Convention be held on October 25-26, 2002 on the island of O`ahu. The motion was seconded and carried by voice vote. It was also noted that the 2001 Annual Meeting of Convention will be October 26-27, 2001, also on the island of O`ahu.

<u>COURTESY RESOLUTIONS</u>: The President called on The Rev. Darrow Aiona to read the Courtesy Resolutions. Mrs. Mary Day Wilson asked there be greetings sent to The Rev. Ken Perkins since this is the first Annual Meeting of the Convention he has not attended in decades. Courtesy resolutions were adopted by voice vote. Refer to Attachment Q.

POINTS OF PERSONAL PRIVILEGE: The Rev. Marilyn Watts of St. Philip's, Ma'ili rose to thank the delegates who are here for the first tine and for the new life they represent.

The Rev. Joe Carr told the Diocese about the Alpha Program and announced that in January 2001 an Alpha Conference is coming to Honolulu.

Chancellor John A. Lockwood thanked the members for handling the Regional Caucuses so well.

The Rev. Frank Cowell announced that funds have been raised for legal assistance to a couple in his congregation facing deportation charges, and thanked people for their contributions.

The Rev. Jim Hargis, All Saints', invited Members to attend Good Shepherd's 75th anniversary of their church building on November 3-5, 2000.

The Rev. Hollis Wright reminded delegates of the need of The Rev. Domingo Calag for a new kidney. Fr. Calag or herself can be contacted.

The Rev. Frank Bergen reported that Holy Apostles (Hilo) has been offered a musical organ for use by an Episcopal Church. His congregation does not have a use for it at this time, and should anyone be interested, they should contact him.

<u>ADJOURNMENT</u>: At 2:17 p.m., the President moved adjournment of the 32nd Annual Meeting of the Convention sine die. The motion was seconded and carried by voice vote. Hawai`i Aloha was sung.

CONVENTION ADDRESS BY THE RT. REV. RICHARD S.O. CHANG

EMBARGOED UNTIL FRIDAY, OCTOBER 27. CHECK AGAINST DELIVERY.

"I therefore, the prisoner in the Lord, beg you to lead a life worthy of the calling to which you have been called, with all humility and gentleness, with patience, bearing with one another in love, making every effort to maintain the unity of the Spirit in the bond of peace. There is one body and one Spirit, just as you were called to the one hope of your calling, one Lord, on faith, one baptism, one God and Father of all, who is above all and through all and in all. But each of us was given grace according to the measure of Christ's gift. *Ephesians 4:1-7*

Friday, October 13, marked the 4th anniversary of my arrival in the Diocese of Hawai`i in 1996, and the beginning of my 5th year as your bishop. The years have gone by too quickly. My fourth year of ministry has been a more difficult and challenging time for me when compared with the previous three years. Plans and schedules seemed be more crowded and frequently disrupted. The anticipated "low activity times" in the late summer when we "caught our breath and prepared for the fall" did not occur. I think it is great that there are more activities throughout our Diocese as evidenced by the competition among programs for prime weekend dates on the Diocesan Calendar. There are very few weekends when there are no diocesan or congregational programs occurring. But decisions seemed harder this past year.

There was another significant event on Friday, October 13, 2000. A check for \$54,879 was paid to First Hawaiian Bank. This was the final payment to the bank on the \$4 million loan that we had guaranteed on behalf of Episcopal Homes of Hawai`i. This September had the good news that a lawsuit in bankruptcy court to subordinate the claims of the Diocese was dismissed in our favor by the judge. Earlier this month our insurance carriers agreed to pay the defense costs for new civil suits filed in August.

We are not yet out of the "proverbial woods" with regard to Episcopal Homes of Hawai`i. There are still pending lawsuits. Trial dates have been set for two of them for March and July 2001 respectively. We need to repay the Ing and the Von Holt Endowment Funds the \$2.3 million that we borrowed in 1995, 1998, and 1999, to help pay down the bank loan. The proposed 2001 Budget includes funds for this repayment to the Ing and Von Holt Funds. Since 1994 an average of 39 percent of the operating income in our Diocesan Budget was spent on EHH-related expenses, not including the costs for travel, office support, and staff hours.

Despite these financial limitations, our diocese has been able to embark upon new ministries that have brought new vitality and hope in many lives. We can look with pride at the growth of our New Beginnings program young people in grades 6-8. We are one of twelve dioceses invited to be a pilot program for clergy and lay professional continuing education sponsored by the Eli Lilly Foundation. Barbara Street just returned the first meeting of this program and reported with pride that we "are far ahead of the other dioceses except the Diocese of Texas". I pray that EHH-related expenses will continue to decrease in the coming year and no longer be part of our operating budget in 2002. There are uncounted numbers of new ministry opportunities before us. We have each been given grace according to the measure of Christ's gift to undertake these ministries. We have always had abundance. Now we can have hope.

As a Diocese, we have not fully entered into a "recovery" mode from EHH. After more than six years, I continue to hear of clergy, lay leaders and entire congregations who still struggle with the impact of EHH upon their ministries. As we have learned from congregations outside of our Diocese where there has been a traumatic event of some kind, the recovery process involves the whole community, not selected individuals. To be fully healed from the wounds of our past, we must be prepared to name the wounds, identify the solutions, and willingly implement any changes that bring wholeness to individuals and the congregations. We must pursue the avenues to rebuild trust, strengthen interpersonal relationships, require accountability, and develop renewed vision. I give thanks to God for positive efforts in this endeavor, but the work of reconciliation is never done. It cannot be left to chance. We must be purposeful in these tasks.

In the course of the mutual ministry process, someone characterized my episcopate as "passive leadership" and called for more definitive responses to issues raised in the life of our diocese and communities. I appreciate that assessment. For the past three years I have sought to listen to the people of our diocese and sought to build relationships with clergy and laity. For the past four years mine has been a ministry of presence and conversation to rebuild trust in the office of the bishop. Remember my first convention address when I told you about my spiritual hero, Brother Lawrence, whose ministry was to bring the presence of God into his monastic community. I believe that I am now called to lead us to a deeper understanding of our ministry, better stewardship of our abundant resources, and more honest acceptance and trust of each other. To this end, I will begin to initiate changes within our diocese to achieve these objectives.

When you have called 536-7776 or 800-524-8418, you have been heard the voice of Tiare Ono saying, "You have reached the Office of the Bishop for the Episcopal Diocese of Hawaii." "229 Queen Emma Square" is not the Episcopal Diocese of Hawaii. It is a street address. Marie, Tiare, Lucille, Nancy, Peter, Frank, Bob and I are not the Diocese. You who occupy these seats in Tenney Theater this afternoon and all the other baptized members of our forty congregations and three school chapels constitute the Episcopal Diocese of Hawaii. Each of you is an integral part of that unit known as the Episcopal Diocese of Hawaii, and we work together as partners in ministry, not adversaries.

This past August I presented a proposal to the Diocesan Council that will lead to a reorganization of the Council. This process will continue over the next two months and will be implemented in January 2001. The Diocesan Council will be divided into three sections - Support, Mission, and Formation – replacing the current six departments of the Council. Peter Pereira, Bob Fitzpatrick and Lucille Tamura will serve as the primary staff persons for support, mission, and formation sections, respectively. All existing and future programs and ministries of our Diocese, whether receiving funding from the Diocesan Budget or not, will be placed within one of the sections. We currently have programs that are operating independently of the structure of the Diocese and have no accountability. This reorganization is intended to restore the Council as the policy body of the Diocese between annual meetings of the Convention, to restore its long-range planning function, and remove all program and ministry management responsibilities. The committees and commissions of the Diocese will be the managers of programs and ministries and accountable to the Diocesan Council. Because this reorganization is in process, I have yet to make appointments to the committees and commissions of the Diocese for 2001. Until I make the appointments early next year, the current committees and commissions will remain intact.

It has frequently been difficult to have conversations that identify and name the "gaps in ministry" in order to move the Diocese forward in faithful discipleship. "Gaps" are the difference between where we are now and where we want to be. We do not like to talk about the "gaps in our lives", those shortcomings that separate us from one another. For example, there are "gaps" in our relationships with each other. I am very much aware that we do not all share the level of trust with each other or the newcomer, whether lay or ordained, that will help us to become a diocese totally committed to living our baptismal covenant. When trust shapes the community, it is possible for that community to recognize God's abundance. When we do not trust, then we believe that there is never enough.

Susy Miller noted that our congregations were wonderful in welcoming the visitor in keeping with the "public image of hospitality and welcome". Her experience in Hawai`i during her workshops in August reflected an "arm's length" welcome rather than true openness and hospitality. Without depth in our ministry of hospitality, incorporating the newcomer into our church community is difficult, if not impossible.

Let me ask a question. Has our ministry of hospitality been shaped too much by the economic values of the tourist industry rather than the values of the Gospel of Jesus Christ? Do we welcome the stranger as another pledging unit that will help our financial stability in the same way that hotels view occupancy rates? Let me suggest that the hospitality offered by our congregations must be built upon the foundations of the Good News of the Gospel and our baptismal covenant. It is a hospitality that welcomes. It is welcoming that invites the stranger into deeper relationship with Jesus Christ. It is welcoming that enables the sharing of God's grace and our own abundance with the stranger in need. Jesus trusted in the abundant power of God's love enough to die on the cross for our redemption. It is incorporation that accepts the gifts of the stranger and the changes that will occur in our own lives and in our churches. A church community or diocese that does not provide an authentic welcome that risks change and even loss will not grow. Are we not Easter people whose identity comes from the resurrection? We die to self that we might have new and abundant life in Christ. We may be comfortable as a surviving congregation, but we will become insignificant as a community of faith. Jesus came among us that we might have a more abundant life.

In the course of consulting with the twelve congregations with vacant positions, I have witnessed and experienced the divisions and tensions within congregations and communities over authority, theology, race, leadership, ministry priorities, liturgy and music. These divisions are severe impediments to faithful ministry being exercised by the people of God in every congregation. These are "gaps" that must be named. As sisters and brothers in Christ, we must bridge the gaps with solutions that embrace our diversity and build up the church. "Gaps" encourage a theology of scarcity by which we live a "fortress mentality" that leads to building walls of separation and alienation in order to control what is mine. We must use our abundance to bridge the gaps that separate us for it is in giving that we live life fully.

We must move to deeper levels of personal relationship and commitment to Jesus Christ as our Lord and Savior. Our unity with each other arises from our common faith and witness to Jesus as Lord and Savior, in our baptisms, and in our sharing of the Eucharistic meal. Last May I began to meet with an eclectic group to discuss human sexuality as preparation for the General Convention and as my commitment to continue the dialogue. Since then we have met monthly for two hours to pray together, to study Holy Scripture, to share our personal stories, and to discuss the resolves of the General Convention resolution DO39a. In our time together, we have worked to create a safe place where respect, honesty, and trust can be reality. It has been hard. It has helped me appreciate each person of the group as fellow disciple of Jesus Christ seeking to be faithful as I am seeking to be faithful. I have come to see and value our unity in Christ as primary. We have been able to engage in respectful conversation on the issues

related to human sexuality. I intend to introduce this model for conversation to the regional clergy gatherings and to those congregations who wish to participate. In baptism we all have been invited to share in a banquet table in God's kingdom. We are all invited to share the Body and Blood of Christ at the Holy Table. We are called by Christ to gather with our abundant differing personal experiences and perspectives at the table of conversation trusting that God's embracing grace will lead and guide us into all truth.

Let me read again the words with which I began my address.

"I therefore, the prisoner in the Lord, beg you to lead a life worthy of the calling to which you have been called, with all humility and gentleness, with patience, bearing with one another in love, making every effort to maintain the unity of the Spirit in the bond of peace. There is one body and one Spirit, just as you were called to the one hope of your calling, one Lord, on faith, one baptism, one God and Father of all, who is above all and through all and in all. But each of us was given grace according to the measure of Christ's gift. *Ephesians 4:1-7*

Less than a month ago the Reverend John Y.F. Liu, a priest of the Church, died alone in his home in Wailuku on the island of Maui. It would be my guess that the majority of the members of this Convention never heard or knew of John Liu. Some may remember his ministry at Holy Apostles' Church, Hilo; at the Kohala Missions on the Big Island; or at St. Elizabeth's Church, Honolulu. Even fewer of us would remember his ministry with young people as a chaplain for the Civil Air Patrol. But the fewest of us will know about his ministry as an adult probation officer for the State of Hawai`i in Wailuku where he worked until his death. A few days after his death, Marvin Foltz and I met with the staff of the Probation Office to talk about John's death and to pray with them. That time was filled with memories of a man whose ministry with staff and clients was described as compassionate, stern but loving, hospitable, generous, funny and reserved.

From today John Y.F. Liu will be remembered by all of us. He will be remembered by the future generations. A little more than a year ago John established the Victory Fund of the Diocese of Hawai`i. The purpose of the Fund is to provide an annual educational scholarship to a youngster selected from public housing in Kalihi, Palama, or the Waianae Coast. It was John's dream that this scholarship would provide an opportunity for a youngster seeking to improve him or herself through education. The first scholarship will be granted in 2001. In his will, John has also provided funds from his estate to support youth ministry among mission congregations. These funds will be administered through the Diocesan Council.

No public acknowledgement of John's ministry and these gifts to the youth of our community and our diocese could be made until today. "I came quietly, I leave quietly" was a phrase John quoted to both Marvin Foltz and me. So it should come as no surprise that John requested that his ashes be scattered at sea off Maui in a private ceremony. His other request was that Marvin and I remember him at the Sunday Eucharist we celebrated after his death. I hope that every congregation of this Diocese did respond to my email request to diocesan clergy that John Y.F. Liu be remembered on Sunday, October 8, 2000.

This month the Finance and Real Estate Department of the Diocesan Council heard for the first time a proposal from the Campus Ministry Committee to rebuild "Canterbury House". The building has been closed since the summer of 1997 when it was determined to be an unsafe facility. The Campus Ministry Committee has struggled over what kind of facility should be constructed to replace the condemned building. Jim Matichuk, an architect and a member of the committee, has been a part of that struggle. Jim has patiently labored uncounted hours and produced untold number of drawings for a new

facility. Norma Chun, chair of the Committee, has provided leadership for this project.

I am pleased to announce that groundbreaking for the George W.R. MacCray Campus Center will be scheduled early next year. Once again most of you must be asking the question: who is this George W.R. MacCray? The Rev. George W.R. MacCray was a priest from the Diocese of Newark. After his retirement as the Rector of Christ Church, Short Hills, New Jersey, in 1978, he resided at the Arcadia Residence until his death in 1998. I met George only once before his death. He left his estate to several educational and religious institutions. The Diocese of Hawai'i was one of his beneficiaries. His bequest was to be administered by the Bishop of Hawai'i. Given his keen interest in education, it seems appropriate that a facility dedicated to ministry for the campus community, youth, and young adults be built in his honor. This facility will be a valuable resource for the ministry of our Diocese. It will be a place where college students can gather for fellowship and quiet, a place where faculty can have their brown bag lunches with our Campus Missioner, where our New Beginnings and Happening teams can meet to prepare for their weekends, where Eucharist and quiet meditation is available, and where the Episcopal Diocese of Hawai'i can proclaim the Good News of Jesus Christ.

John and George led lives worthy of the calling to which they been called by Jesus Christ. They served with all humility and gentleness, with patience, bearing the burdens of the ministry in love, and continued in unity with the community of faith. They discerned the gifts that God had given them and the invitation to ministry Jesus offered. In life and death, their decisions and actions proclaimed a theology of abundance, not scarcity. Theirs was a stewardship built upon the foundation of their faith in Jesus Christ as their Lord and Savior. My ministry has been blessed by these two priests, as will all of us at this Annual Meeting of the Convention of the Diocese of Hawai'i.

In closing, I ask you three questions. First, what does God desire to do with and through this Diocese? Second, what is God calling us to be about in our life and ministry? Third, on basis of God's call, what results do we desire? Let us work together seeking to answer these questions in 2001. He Lanakila Ma Ke Ke'a...Victory through the Cross.

ANNUAL REPORT OF THE TREASURER

The Balance sheet of The Episcopal Church in Hawaii on December 31, 1999 showed assets of \$37,846,994, liabilities of \$18,261,358 and net assets of \$19,585,636. The total operating income of the diocese exceeded operating expenses in 1999 by \$69,243. It should be noted that all parishes and missions have paid their 1999 assigned assessments, except for one parish.

Price Waterhouse Coopers, CPAs, audited our financial statements. If you would like to receive a copy, please call me.

Our audit shows that we have an adequate system of internal control. Appropriate parties must properly authorize all disbursements, and two authorized officers must sign all checks.

- 1. In your Convention Packet, there will be the current Budget versus Actual Operating Report as of September 30, 2000. The report is summarized to cut printing costs. If you want a detail report, please call me.
- 2. In your Convention Packet, there will also be a report on our Theological Education Offering for 1999. You will note that we contributed \$37,074 that which amounted to 66% of our 1% goal. Now is the time to be checking on the performance of your Parish or Mission this year so that we can meet our 1% goal in 2000.
- 3. The annualized rate of Total Return for our Diocesan Investment Portfolio for the three years ended September 30, 2000 is 17%.
- 4. The setting up of the Shared Travel Expense fund for the 2000 diocesan convention has been accomplished. All delegates (through their clergy) are required to request for airline coupons from Nancy Minuth.

- 5. The Finance and Real Estate Department and the Diocesan Council implemented a new budget process this year. The process involved a survey and several pre-convention budget hearings. We will find-tune this process for the 2002 budget.
- 6. The rate of assessment for 2001 is 24% (2000 was 25%).
- 7. The 2000 Church Leaders Conference included a topic on audit and on employment law. Please ask your treasurers to attend the 2001 Conference.
- 8. During the year the Finance Department met with our investment monitor and managers to review the performance of our investment portfolio and also to review our Investment Policy. We have a long-term view towards our portfolio management with the understanding that the stock market will experience fluctuations from time to time. We have a total return investment policy and spending policy. Our policies are implemented to ensure that there will be a steady stream of earnings annually, while at the same time ensuring that the fund assets will be there for the future. Our spending policy is set at a payout rate of 5 percent (5%) of the average market value of the Investment Fund over 3 years. The spending policy, together with sound investment performance, ensures that, over time, the fund will retain its ability to produce earnings.
- 9. The Compensation Committee met during the year to review the Clergy Compensation Schedule. Please refer to The 2001 Clergy Compensation Schedule for details.
- 10. During the year, I worked with new treasurers advising them of various matters, namely taxes, accounting and audit, investments, parochial reports, employment and property issues.
- 11. During the year, I coordinated with auditors and treasurers of missions to audit their church. By the end of 2000, all the missions will have completed their first year audits.
- 12. We went through a bid process for our property and liability insurance renewal for the year 2000. We setup a reserve fund to cover the increase in deductible for our hurricane policy.
- 13. We held lay pension workshops (upon request from Churches/Schools) to inform and update employees and employer representatives about the plan and the investment vehicles available.
- 14. I assisted the Hawaii Society of Certified Public Accountants to organize a workshop for non-profits.

Nancy Minuth and I would like to thank the treasurers, wardens and clergy whose work, cooperation and goodwill have helped us in our work. Many thanks also to the members of Diocesan Council, Diocesan Real Estate and Finance Department, Diocesan Compensation Review Committee, Diocesan Stewardship Education Committee and Diocesan staff. Thank you all for your support and the gifts you share with us.

RESPONSE TO THE BISHOP'S ADDRESS

Bishop and Members of the Convention:

The committee to respond to your address wishes to express its appreciation for choosing us for this awesome responsibility and opportunity. We have read, re-read and listened, to your address.

Your address was prayerful, organized, thoughtful, well written, theologically and biblically sound, challenging and inclusive. However, some of us noticed there were no jokes or humor! On behalf of the Convention--we offer you this gift to help in your preparations for next year! (*Presentation of a book of jokes*)

We embrace the themes you stressed: Hospitality, Unity, Spirituality, Abundance, Stewardship and Ministry in response to the calling of Jesus Christ and our baptismal covenant. We call upon every member of this convention to review your Address with their congregations so that they can begin to work on the issues you addressed.

You referred to; "diocese is as the basic unit of the Episcopal Church". You clarified that by saying that all baptized members make up our Diocese. Actually, each of us is the basic unit of the church. As we prepare for the future, and to remind us of our role, we wish to model the new fashion for the journey, "basic wear"! (Put on T-Shirt emblazoned with the term "Basic Unit")

Collectively, we make up the Diocese, so now at our regional meetings and caucuses we agree not to point fingers at the Diocese, because we know when we do so, we will be pointing more fingers back at us! Thank you.

We agree with your assessment that we need to return to basics. We clearly need to become, as you stated previously, "spiritually buff". As the basic units, we need to rediscover the role of the prayer book in our spiritual and corporate lives. The Prayer book is one of those things, which bind us together, like the Eucharist.

To start the discussion, hopefully leading to a response to your three questions, we looked to the Catechism in the Book of Common Prayer for guidance. "What is the duty of all Christians?" Every basic unit repeat after me: "The duty of all Christians [or all basic units] is to follow Christ; to come together week by week for corporate worship; and to work, pray, and give for the spread of the kingdom of God."

Secondly, "What is the ministry of lay persons?" Every basic unit repeat after me: "The ministry of lay persons is to represent Christ and his Church; to bear witness to him wherever they may be; and, according to the gifts given them, to carry on Christ's work of reconciliation in the world; and to take their place in the life, worship, and governance of the Church."

To carry on Christ's work of reconciliation, we must truly love one another. If we truly love one another, we are compelled us to ask for forgiveness of our sins and to offer forgiveness to those who have sinned against us. In gratitude, we each give thanks for God's enduring mercy and steadfast love. **Do it!**

We must start with a more disciplined spiritual life. The prayer book is one resource to help in this process. **Use it!**

We believe you made a significant announcement yesterday. We are <u>not</u> referring to the payoff of the EHH note. We <u>are</u> referring to the re-organization of the Diocesan Council. We believe that this reorganization, when combined with the new regional councils, represents the inversion of the "chain of command". We believe an inverted triangle better symbolizes how you envision the reorganized diocese will work. We, the laity, the basic units, now make up the top, and by far the largest portion of the triangle. This new paradigm of leadership would imply that the role of the office of the Bishop is now one of support, rather than dictation. It would also imply that we, the basic units take responsibility for the ministry of this Diocese. If we succeed, we succeed together; if we fail, we fail together. There is no "us" and there is no "them" to blame.

We, the basic units, do not seek another "hero" in our Bishop; we have that in Jesus Christ. We ask for counsel, support, guidance and comfort. As you, the staff, and the Diocesan Council work to complete the reorganization of the Diocese-think of us often. We, who are assembled here today, on behalf of all Baptized persons of the Diocese, must embrace our calls, and ministries, like Fathers Liu and MacCray. In the spirit of Fathers Liu and MacCray, we urge the laity to acknowledge our responsibility for Ministry. We urge the laity to acknowledge our fear and uncertainty. We urge the laity to affirm that we are God's be-loved. We urge the laity to follow a disciplined spiritual life, which will support us when, and as things get tough, or as we truly embrace the newcomer whose differences are most apparent. We urge the laity to affirm that through Christ, all things are possible. We urge the laity to affirm this reorganization. We welcome the opportunity to discern our ministries. Let one of the goals of our disciplined spiritual life be to: listen to what God is calling us to do. We ask for help in discernment, and we ask you and the staff to be the cheerleaders, encouraging us, upholding us, supporting us and enduring our efforts with love and patience. Here is a new tool to help you in this effort! (Delivers pompoms to the Bishop)

As you said yesterday, "Our unity in Christ is primary." It is time for us to affirm, under your leadership, that diversity is at the heart of what it means to be Anglican. Diversity is what allows spontaneity and joy in our congregations and organizations, giving pleasure to us and to God. We encourage you to give emphasis to gift identification, so that all the baptized can realize, accept and embrace the gifts that are uniquely theirs, and all of us can appreciate, value and love our differences, finally acknowledging that we all have been gifted by God with something special and unique needed for God's kingdom on earth. It is only through cooperation, shared responsibility and love that we will finally be one Ohana. We intend to "mind the gaps" until everyone has a place at the Eucharistic table.

In response to the text you chose from Ephesians, we offer an additional one to help us frame the three questions you raise at the end of your address. We have chosen our text from the Book of Deuteronomy and it reads:

"See, I have set before you today life and prosperity, death and adversity. If you obey the commandments of the Lord your God that I am commanding you today, by loving the Lord your God, walking in his ways, and observing his commandments, decrees, and ordinances, then you shall live... and the Lord your God will bless you in the land that you are entering to possess...I call heaven and earth to witness against you today that I have set before you life and death, blessings and curses. Choose life so that you and your descendants may live, loving the Lord your God, obeying him, and holding fast to him; for that means life to you..."

Bishop, the Diocese of Hawai'i is poised to enter the Promised Land. We have survived "EHH". We must account for the past and then look to the future. We know there are loose ends to be tied up—in life there always are. Only by God's Grace have we come through the ordeal, hopefully chastened and stronger. The whole world is waiting for us, the children of God in the Diocese of Hawai'i, to be seen!

Having come through the "wilderness" of "EHH", we know we need to think about the three questions you posed at the end of your Address: "First, what does God desire to do with and through this Diocese? Second,

what is God calling us to be about in our life and ministry? Third, on the basis of God's call, what results do we desire?" This committee recommends the Diocese plan and present a Diocese-wide visioning and planning conference involving every lay person and congregation.

Thank you for bringing the questions to our attention; please assist us in our efforts to discern the answers. The task ahead is enormous. It is also exciting and hope-filled. The Bishop, the staff, or the clergy cannot do it alone. It is not right or just. We must all participate in the renewal of our beloved Diocese. On behalf of the Members of the Convention we represent, we offer God's church, our gifts and skills, talents, time and treasure.

God bless you for the tender care you have given us. Through God's Grace may we be led to a "life worthy of the calling to which we (sic) have been called, with all humility and gentleness, with patience, bearing with one another in love, making every effort to maintain the unity of the Spirit in the bond of peace".

Finally, lest we succumb to the sin of pride or arrogance, let us not forget or ignore how we have come to this place of renewal and restoration. It is through God's great abundance that the \$4 million loan has been paid. We were hurt, we were lost, and we have been delivered. What is our response? It is praise! It is thanksgiving! It is adoration and honor to the One whom loves us, nurtures us, saves and redeems us. It is celebration! Praise God from whom all blessings flow! (Deliver noisemakers and confetti to the convention for a celebratory yell)

He Lanakila Ma Ke Ke`a..... Victory through the Cross. Let us go forward in Faith! Amen! October 27, 2000

MUTUAL MINISTRY REVIEW - 2000

Good Morning! I have been asked to make a few comments on the Mutual Ministry Review which was completed this year. Back in 1998 the 30th Annual Meeting of the Diocese of Hawai`i passed Resolution No. 7 which mandated a review of the ministry of the Bishop and the Diocese at intervals of not less than six months and not more than two years. You asked for it.

In the fall of 1999, the Bishop quietly reminded the Standing Committee that they had a job to do and we went to work. It was not an easy task for we quickly discovered that not only was there no model in the Diocese that we could adopt for such a Review but there was no model in the Episcopal Church. Fortunately we have The Rev. Peter Van Horne to turn to. He got to work on his computer and drew on his many friends throughout the church. A small sub-committee of the Standing Committee, consisting of Rev. Hollis Wright, Mr. Bud Doty and myself, was formed and with Father Van Horne's expertise we developed a self-study from and a review process. As far as I know we have broken new ground and I hope that our efforts overt the past year will prove to be of use not only to our Diocese but also to the whole Episcopal Church.

On June 1st, most of you here received a questionnaire. Mr. William Bowden undertook the task of tabulating the replies; Rev. Peter Van Horne translated the information into graphs; and the members of the sub-committee reviewed the data and summarized the comments and the opinions.

During the past week you have also received a letter from the Bishop enclosing a summary of the results of the Mutual Ministry Review. Like this one, I hope you had a chance to read it. In the Diocesan Office, there is a binder in which the process is explained, together with a copy of the questionnaire, the summaries, the graphs, and the Bishop's Self-Review. You are welcomed to study the results but there is only one copy, so don't all descend on Marie at once. Peter also put the information on a CD, which is in the office.


With all this information at hand, I need only tell you that both the Clergy and the Laity evaluated the Bishop's effectiveness in performing the duties of his office as <u>outstanding</u>. On that basis, the Standing Committee has recommended to the Diocesan Council and the Compensation Review Committee that, to reflect his high level of performance, the Bishop's salary be substantially increased beginning next year.

I also wish to express to The Rev. Peter Van Horne and Mr. William Bowden the deep gratitude of the Standing Committee for their invaluable assistance throughout the Mutual Ministry Review.

The Episcopal Diocese of Hawai`i 2001 Budget



THE EPISCOPAL DIOCESE OF HAWAI`I 2001 BUDGET (in \$)



TITLE: COMPENSATION SCHEDULES FOR 2001

SPONSOR: DIOCESAN COMPENSATION REVIEW COMMITTEE

BE IT RESOLVED, that the 2001 Clergy Compensation Schedule salary ranges be increased by 4%.

RATIONALE/EXPLANATION:

The above is the resolution that is required of the Diocesan Compensation Review Committee under Diocesan Canon 38, Sections 1 and 5.

Application Policies

- 1. The compensation categories and ranges are intended to be used as a framework within, which the Vestry/Bishop's Committee and the clergy negotiate a mutually acceptable compensation. Parishes may exceed the scale, while missions are governed by Application Policy #7. The compensation ranges are based on years of service to provide a guide for compensation increases as years of service increase. Previously the number of years of service used to negotiate compensation were years of service within the Diocese of Hawaii; hereafter, the years of service will be negotiated for those clergy who have served outside of the Diocese of Hawaii. Effective January 1,1998, with respect to clergy newly called to a congregation, the Vestry/Bishop's Committee is required to notify the Treasurer of the Diocese as to the number of years of service at which they enter the Compensation Schedule approved by Diocesan Convention. Additionally, in 1998, with respect to clergy already serving a congregation, their years of service will be the current position on the compensation schedule, which should be provided to the Diocesan Treasurer. The intent to provide equitable treatment to both existing and newly arrived clergy. In order to maintain accurate records, the Parochial Report should contain, in addition to the clergy compensation, the number of years of service as it increases each year.
- 2. Clergy must be paid at least the minimum of the applicable category.
- 3. Clergy must not be paid less than the previous year.
- 4. Clergy with five or more years of service (as defined in Policy number 1) must be paid at least 90% of the mid-point of the applicable range. (shown as 5-year point)
- 5. Clergy with ten or more years of service (as defined in Policy number 1) must be paid at least 100% of the mid-point of the applicable range. (shown as the 10-year midpoint)
- 6. Clergy with twenty or more years of service (as defined in Policy number 1) must be paid at least 90% of the maximum of the applicable range. (shown as 20-year point)
- 7. Mission clergy may be paid more than the maximum of the applicable range for any category with the consent of the Bishop.
- 8. For easier administration, all compensation figures will be rounded up into amounts divisible by 12.

- 9a. Each Vestry or Bishop's Committee working in consultation with their clergy shall approve a resolution determining the housing allowances for the following year. This IRS requirement shall be completed by December 31 of the year preceding the commencement of the allowance.
- 9b. For clergy who are paid a cash housing allowance, the amount of the housing allowance shall be determined by mutual negotiation between the clergy and Vestry/Bishop's committee.
- 9c. The 2001 Housing Allowance Guideline is \$14,500 and is included in the compensation amounts stated above. Any congregation that furnishes housing for the Fair Market Value is less than the \$14,500 is encouraged to pay the difference in cash to clergy. The value of housing that is decided shall be added to the cash salary in order to compute the total compensation for Church Pension Fund purposes.
- 10. In addition there will be these other compensation or benefit elements:
- 10a. A car allowance of \$5,762. Clergy are encouraged to consider the use of pre-tax dollars by setting up a reimbursable expense account plan or provide an automobile;
- 10b.The congregation will pay the mandatory Church Pension Fund Assessment on salary, housing, social security reimbursement and on utilities;
- 10c. \$50,000 Group Life Insurance as provided by the Church Pension Fund at no cost to the congregation, effective January 1, 1995;
- 10d. Active clergy serving in a congregation as of December 31, 1994 will continue to receive the same medical coverage from January 1, 1995 with the cost paid by the congregation, as long as that member of the clergy continuously serves in any congregation in this diocese.
- 10e. Active clergy who are called from outside the Diocese to serve in a congregation after December 31, 1994 will receive medical coverage according to the terms of an HMO plan. The clergy will be responsible for paying any plan whose costs are above a baseline HMO cost, which is defined as the average cost of the basic plan of available HMOs in the state. The baseline HMO cost is as follows:

Single \$2,600 Two-family \$5,200 Family \$7,800

The reference to baseline HMO cost is 100% of the rate for single coverage or family coverage. Clergy are encouraged to consider the use of pre-tax dollars when paying for amounts above the baseline HMO cost.

- 10f. The congregation will pay the cost of Worker's Compensation coverage for the clergy.
- 10g. The congregation will pay the cost of income replacement plan coverage for the clergy, as provided by Church Life Insurance Corporation.
- 11. Congregations with assisting clergy are encouraged to classify the assistant's position into a category appropriate to the scope of the position.
- 12. Congregations are encouraged to discuss with their clergy how they can help the clergy with their social security costs and to develop a plan on how to reach the 7.65% share that would be paid by

ADDENDUM TO CLERGY COMPENSATION SCHEDULE

Examples:

- 1. A Priest with 5 years service out of Hawaii is called to Hawaii to serve in a Category E Parish/Mission. His negotiated compensation package (cash salary plus housing allowance) is \$43,200. The agreed upon years of service place on the compensation schedule is 5.
- 2. A Priest with 18 years of service out of Hawaii is called to serve in a Category C Parish. Her negotiated compensation package is \$58,100. The agreed upon years of service on the compensation schedule is 10.
- 3. A Priest with 15 years of service with 4 years in Hawaii, in a Category D Parish, agrees with his Vestry to a compensation package of \$50,800. His position on the compensation schedule is agreed to be year 8.
- 4. A Priest with 6 years of service with 3 years in Hawaii in a Category P Parish/Mission agrees with her Vestry/Bishop's Committee to a compensation package of \$43,300. Her position on the compensation schedule is agreed to be year 5...
- 5. A Priest with 10 years of service with 6 years in Hawaii in a Category E Parish/Mission whose position on the compensation schedule is year 8 is called to a Category C Parish in Hawaii. His negotiated compensation package is \$52,400. The agreed upon years of service place on the compensation schedule is 5.

Once the so-called placement year has been established it will advance one year annually.

RESOLUTION NO. 2

TITLE: LOWERING THE HAWAII DIOCESAN ASSESSMENT

SPONSOR: KAUAI REGIONAL COUNCIL

CONTACT PERSON: NELSON SECRETARIO

BE IT RESOLVED, that the Hawaii Diocesan compulsory assessment of its parishes/missions be reduced from 25% to 15% beginning with the year 2001.

RATIONALE/EXPLANATION

Whereas, the basic unit of the Episcopal Church is the Diocese, which is comprised of all the parishes/missions within the Diocese, and Whereas, our Diocese compulsory assessment of 25% of the income of all the parishes/missions within the Diocese is burdensome upon most congregations, and considerably greater than many western Dioceses (see attached list of other Diocese assessments), and

Whereas, any reduction of Diocese income, as a result of lowering the compulsory assessment from 25% to 15%, can be made up by: taking a greater % of the portfolio instead of 5%; and by lowering the Diocesan budget through the use of "Zero Base" budgeting (all budget expenditures start at zero and must be justified); and finally, by funding primarily programs which are requested by the parishes/missions, rather than funding most all programs originating solely at the Diocesan level, and

Whereas, the ministry of the church is most effectively served at the parish/mission level, behooving us to spend maximum finds at this level.

RESOLUTION NO. 3

TITLE: DIOCESAN ADOPTION OF ZERO BASE BUDGETING

SPONSOR: KAUAI REGIONAL COUNCIL

CONTACT PERSON: NELSON SECRETARIO

BE IT RESOLVED, that the Diocese of Hawaii adopt the concept of "Zero Base Budgeting" for all future Diocesan budgets.

RATIONALE/EXPLANATION

Whereas, Zero Base Budgeting, by definition, is a budgeting method for an organization in which all expenditures must be justified each budget period, not just amounts in excess of the previous budget period, and,

Whereas, we are all challenged to be good stewards of the gifts God has given us. While God may shower gifts upon us from His infinite bounty, our finite ability to receive those gifts means that we end up with limited resources. We are therefore challenged not to waste our limited resources, but to use them wisely to the glory of God. It is in that spirit that we encourage our leaders and all members in the Episcopal Diocese of Hawaii to support the implementation of a "zero- base" approach in building our annual diocesan budget.

Simply described, a "zero-base budget" starts from the assumption that all expenditures must be justified, every year, and that budgeted expenditures not just be amounts added to or subtracted from the previous year's expenditures. In other words, there are no "sacred cows." We start the budget process from "zero." Each year we would decide (item by item) what items are worthy of our funding, and how much of our limited resources (dollars) we are willing to put forth in support of these various items we deem deserving.

Most of us, either consciously or unconsciously, do zero-base budgeting with our personal (family) budgets. Why should our church be any different?

We talk a lot about "ministry of the baptized", "priesthood of all believers", being more "decentralized", etc. Here's an opportunity to use our resources in a manner consistent with what we proclaim.

One of the beauties of our Episcopal church is that we have the best of the "top-down" (bishop/diocese to congregations/parishioners) and "bottom-up" (congregation/parishioners to bishop/diocese) styles of polity, that can blend into a harmoniously functioning organizational structure which is flexible enough to encompass both new and existing ministry needs. Zero-base budgeting offers us a better chance (than simply "budgeting as usual") of serving the changing needs of Christ's flock and God's creation in this new era.

Will we step up to meet this challenge? It takes lots of courage, but then, don't we have a paradigmatic example of courage in Christ Jesus, our Lord?

RESOLUTION NO. 5

TITLE: Amendment to Canon 3

SPONSOR: Jane M. Tonokawa, Secretary of Convention

BE IT RESOLVED,

That Section 3.2 of Canon 3 be amended as follows (new material underlined; deleted material struck-through):

Sec. 3.2. The Secretary of the Convention shall attend to the publication production, under the supervision of the Bishop, and distribution of a sufficient number of printed copies of the Journal of the Convention which shall contain a directory of Diocesan officers, commissions, and departments, a list of the clergy of the Diocese and of Parishes and Missions and of lay delegates present at the meeting of the Convention, the Bishop's annual address to the Convention, the minutes of the proceedings of the Convention, a list of the Committees of the Convention, the Necrology, and such reports to the Convention as may be specified. Distribution of said Journal shall be made as follows:

- Sec. 3.2.1. One copy to every member of the clergy canonically resident and domiciled in the Diocese.
- Sec. 3.2.2. One copy to the clerk of each Parish and Mission in the Diocese.
- *Sec. 3.2.3.* Two <u>printed</u> copies certified to be correct by the Bishop and by the Secretary of the Convention to the Registrar.
- *Sec. 3.2.4.* One copy each to the Presiding Bishop, the President of the House of Deputies, the Chairman of the Joint Commission on the State of the Church, and to such others as required by the General Convention or Ecclesiastical Authority.

RATIONALE / EXPLANATION:

In the past, the Journal of the Convention has been in printed form; i.e. reproduced and bound by professional printers. The printing and binding cost of the 1999 115-page publication is approximately \$8 per journal. In addition, the cost of postage is approximately \$3 per journal. Approximately 130 copies of the 1999 Journal were produced.

The revision to this resolution allows for the Journal of the Convention to be produced on other media, e.g. CD-ROM, and distributed at a significantly lower cost to the Diocese. Donated and/or volunteer services would be engaged to "burn" the CD. The cost of a single disc is approximately \$2 and the postage cost should not exceed \$1; hence a total estimated cost of \$3 per journal. The estimated savings is \$8 per mailed journal.

Until such time when it is appropriate to do otherwise, printed copies would continue to be produced for the clerk of each Parish and Mission in the Diocese, Diocesan archives and the national church offices. However, the Secretary proposes that each clergy in our Diocese receive the journal on CD-ROM, with the option to request a printed copy if desired.

RATIONALE/EXPLANATION

Whereas following the appointment of two missionaries -- Father Godfrey and Father Hefner --to Okinawa, in February 19Slthe House of Bishops assigned the Bishop of the Armed Forces in the Pacific region and the Diocese of Honolulu, the Rt. Rev. Harry S. Kennedy, ecclesiastical jurisdiction of the Ryukyu Islands

And,

Whereas the Diocese of Okinawa and the Diocese of Hawai'i share much in the way of a common heritage by virtue of culture and being "island dioceses"

And,

Whereas a Companion Diocese Relationship has been established in 2000 between the Diocese of Hawaii and the Diocese of Okinawa for the purpose of spiritual and personal sharing, so that we may grow spiritually by sharing our testimonies of faith, and grow in our community outreach in service to society by enhancing our understanding of our cultures.

TITLE: RESOLUTION ON THE CONVENTION ON THE RIGHTS

OF THE CHILD

SPONSOR: THE REV DONOR MACNEICE

WHEREAS western powers and most of the free world over the years have been appalled at the employment of children under the age of eighteen in armed conflict, and

WHEREAS at a meeting of the United Nations Security Council on August 26th. 1999, delegates deplored the increasing numbers of children killed or maimed in wars or recruited to fighting in them, and

WHEREAS the Unites States opposed the move of the Security Council because it wants to retain the ability to recruit children from high school for the military,

BE IT RESOLVED that this Thirty-First Annual Meeting of the Convention of the Diocese of Hawai'i express its disappointment at the refusal of the Government of the United States to ratify treaties to protect children from war, to cease enlisting soldiers younger than 18 to fight and at its refusal to sign the Convention of the Rights of the Child.

BE IT FURTHER RESOLVED that this Convention convey to the President of the United States, both the Majority and Minority Leaders in both the United Stated Senate and Congress, the United States Ambassador to the United Nations, as well as the Representatives to the Senate and Congress from the State of Hawai'i, the feeling of this Convention, and urging them to reverse the decision and ensure that the Convention of the Rights of the Child is signed and endorsed by the United States Government.

RATIONALE: United Nations figures show that more than 300,000 children under the age of 18 are currently under arms in places such as Sudan, Columbia, Angola, Sri Lanka and Afghanistan. In most of these countries children under the age of 15 have been taking part in armed conflict. In the past decade, 2 million children have been killed, 1 million orphaned, 6 million injured or disabled and 12 million made homeless because of war. The United States opposed the move byte United Nations because it wants to retain the ability to recruit children from High School into the forces. The United States and Somalia are the only countries that have not signed the Convention on the Rights of the Child.

PROGRAM OFFICER'S REPORT

The ministry of the Program Officer of the Diocese is to enable and to empower all ministers of the Church by serving as a staff member to the various departments, committees and commissions and as a resource to our missions and parishes. As a member of the Bishop's Management Team, I am also given the opportunity to input by sharing my observations, thoughts and recommendations.

This past year has been exciting with the addition of our Canon Missioner to the staff. He brings to us new ideas and fresh eyes to see our mission and ministry in the diocese. I am blessed to have him with us.

<u>COMMISSIONS, DEPARTMENTS, AND COMMITTEES:</u> I continue to serve as a staff and resource person for the Diocesan Council, Commission on Episcopal Schools, Diocesan Institute Board, Convention Steering Committee, Nurture and Education Department, ECW, Hawai'i Episcopal Youth, Anti-Racism, Christian Formation, Campus Ministry, Hawai'i Spiritual Directors' Formation Program, and other subcommittees appointed by the bishop.

HAWALI SCHOOL FOR SPIRITUAL DIRECTORS' FORMATION PROGRAM: The school began its first phase in September and has 21 interns in its first class. They are being taught by instructors from Mercy Center Institute for Contemporary Spirituality, Burlingame, CA and in cooperation with our diocese, Congregation of the Sacred Hearts of Jesus and Mary and Sisters of the Third Franciscan Order. A two-year grant was obtained from Trinity Institute, New York with local travel assistance for our Episcopal interns and mentors from Nurture and Education. Administrator of the program is The Rev. Canon Kay Johnson.

<u>PROVINCE VIII:</u> I continue to serve on the Executive Committee of Province VIII as a representative from the Intercultural Ministry Development (ICMD). It is important to have a voice in this body by bringing my experiences of the ministries of the province, to establish policies, and to respond to the fiduciary responsibilities of this body. I also serve on the ICMD Steering Committee and am a member of the ICMD Missioners and Archdeacons. As a member of the Executive Committee, I was involved in the planning of the gathering of the Province at General Convention this summer.

<u>CHURCH LEADERS' WORKSHOP</u>: The workshop this year included all leaders (including clergy and non-vestry/bishop committee members) with an expanded list of offerings, e.g. music, Myers Briggs and the role of leaders, etc. This was one of the largest workshops during this year.

I thank each of you for all the wonderful gifts and aloha you bring to our church. To Bishop Chang for his pastoral and administrative gifts, to my wonderful colleagues who continue to support me in my ministry, Nancy Minuth, Tiare Ono, Peter Pereira, Frank Embree, and Bob Fitzpatrick, and especially a special mahalo to Marie Elesarke for her faithful service. To Gina Perkins for her year-round office volunteer support.

PLANNED GIVING OFFICER'S REPORT

The year 2000 has been good for the Diocese of Hawai'i in respects to giving. Several individuals have been generous and have given significant bequests to their churches and to the Diocese. I think the message of abundance has been heard and is alive and well in Hawai'i.

HISTORIOGRAPHER'S REPORT

I. Status of Archival Holdings

The archival collections of the Church continue to be stored at Crown Pacific, a commercial storage facility, at Mililani, O`ahu. This facility exceeds ASNI standards. It is equipped with smoke detection devices, fire suppression systems, alarm contacts, and a security system which detects sound and motion. Collections are held in 24-hour climate controlled storage. Three air conditioned systems maintain temperatures between 65 and 72 degrees; and three dehumidifier units achieve a relative humidity range of 45% to 50%.

With no archival facility of its own, the Church must rely on a commercial storage facility to provide for the environmental and security needs of its collections. The present challenge is how to develop and manage these collections in order that they are accessible and fulfill the research needs of the church administration and membership.

Peter Van Home, in compiling a questionnaire/survey which, as instructed in Resolution #7, was distributed to the clergy of the Diocese and lay leaders at the diocesan level and in local congregations.

Mr. William Bowden tabulated the more than 140 replies received. The sub-committee then reviewed the information gathered by the survey and the Bishop's self-study and are pleased to report that those surveyed in the Diocese, both clergy and laity, evaluated the Bishop's effectiveness in performing the duties of his office as outstanding. Therefore, the Standing Committee has recommended to the Diocesan Council and the Compensation Review Committee that, to reflect his high level of performance, the Bishop's salary be substantially increased beginning in 2001.

The Standing Committee owes a debt to the Rev. Peter Van Home for his hours of labor and his professional expertise in creating a new process for the mutual ministry review and for shepherding it through to a

CAMP MOKULE`IA REPORT

CAMP MOKULEIA - BEGINNING THE NEW MILLENNIUM

During the first eight months of this new millennium, your Camp Mokule`ia is moving forward with expanded usage from the Episcopal Church's and related groups, other groups from the non-profit community, schools and even some corporate and individual participation. We are currently expanding and promoting summer camp for 2001 with an added week of programming. This fall is already seeing increased bookings for groups of young people in outdoor education, conferences, and retreats. Church groups, family groups, and other non-profit groups continue to expand their participation with increased reservations for the balance of this year and into 2001. The Elderhostel programs continue to be our strongest adult program directed by the camp staff. We are working to expand our adult program offerings with short courses in the arts, astronomy, scuba, creative writing, photography, current events, church activities, and bible study. For the first eight months of this year income is running about 30% ahead of 1999, and predictions for 2001 show increased demand for services that will translate to continued fiscal growth.

With the financial and volunteer help of several very special individuals, churches, groups, corporations, and foundations we have been able to address several projects of repair and replacement that have been on the back burner due to a lack of funding. Cabins have been re-painted and repaired to eliminate safety hazards and the roofing problems have been addressed to insure dry housing. The kitchen refrigeration units have been upgraded to continue service for the future and other kitchen and dining room repairs have been made to improve service. The lodge has been cleaned and repainting is starting to protect this major investment, and the biggest improvement has been the upgraded towel and linen service to the joy of our guests. With the help of a local Boy Scout, working on his Eagle project with members of his troop, we have built a horse corral for our growing horseback program, we also need to thank two families who have donated our first two horses for the program. On the immediate horizon are additional cabin repairs, lodge painting, seawall repair, trash removal, swimming pool fence, and other needed repair and replacement.

Much of the above has been possible with the increased fundraising that has occurred because we have been asking others to consider making an investment in the future of Camp Mokule`ia. To thank these individuals, and the thousands of others we plan to have investing in this "very special place," we have started the "Camp Mokule`ia Menehune Society." With special lapel pins for recognizing contributions of time, energy, and resources each year the membership in the "Menehune Society" will grow each year. We have also started a newsletter, "Ha`ilono 0 Mokule`ia" (To tell the news of Mokule`ia) that will recognize and thank those who support Camp, and will also present the news of future programs and activities with special stories of individuals and groups who are a part of Camp Mokule`ia.

All of our success is due to a dedicated staff of service and program people who make every guest feel very special and want to return as soon as possible. While Camp Mokule`ia is currently one of the best kept secrets of the islands, the staff is working to expose that secret to the community and many of us will need to increase our planning to find space in the future. We also owe a debt of gratitude to the Camp Mokule`ia Board of Directors led by its' President Ella Browning and the Chairman Bishop Richard Chang. We need to thank the other members of the Board who continue to work on behalf of Camp Mokule`ia and they are; Tim Lucas, David Kowalski, Bill Biegenwald, Dr. Michael Chun, Rick Eveleth, Bruce Fink, Relda Loomis, Jim Putnam, and Barry Wallace. As your Executive Director, I Philip Geissal, thank you for the privilege of serving with and for the Board, the Camp Staff and the guests of Camp Mokule`ia.

DIOCESAN COMPENSATION AND REVIEW COMMITTEE REPORT

The Committee took the following action in 2000:

Recommended

- 1. The Compensation Schedule for 2001 be changed to include a 4% increase in minimum salary ranges for clergy. (This action is based on a comparison of Hawaii compensation with national median compensation complied by the Church Pension Fund and represents an effort to bring us up from near the bottom of the list toward a goal of being near the mid-range.)
- 2. That the Baseline Costs of the basic plan of available HMOs in the state be changed to reflect the year's increase as follows:

Single	\$ 2,750
Family of two	\$ 5,500
Family	\$ 8,250

3. The minimum compensation for supply clergy shall be increased as follows:

One service	\$125
Two services	\$175
Each additional service	\$ 75

4. That the budgeted amount for Diocesan staff salary be increased by a block amount of \$13,000 and that the Bishop's salary be increased by 4%.

In addition

1. We monitored congregation compliance with the Compensation Canon and requested several churches to come into compliance.

CONGREGATIONAL DEVELOPMENT DEPARTMENT REPORT

I. WHAT IS OUR MISSION STATEMENT?

"Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything that! have commanded you," Jesus said in Matthew 28:19

The Congregational Development Department exists to challenge. encourage and support every congregation in our diocese to be what God calls us to be as we step out in faith in our mission and ministry together as we fulfill the Great Commission.

- a. There is a tremendous need for all of us, together, to continue the work of "unpacking' the hows of shared ministry," in the words of Jeanette Myers, priest on the Big Island, "Congregational Development, and the conversations which it generates, we believe to be an essential aspect of church life and ministry in our day. So many of our congregations face crises or one kind or another. We need each other, We need conversation. We need exposure to the perspectives and strategies of those who are dedicating their lives to understanding this huge transition which is happening in the Church and effective ways of negotiating this transition. We want not to lose sight of the fact that in the Episcopal Church, the diocese is the basic unit, not the congregation. We all are part of something larger than each individual faith community (parish/mission). We don't want to keep to ourselves, but to share on a variety of levels in the wisdom and experience of the larger church."
- b. The Bishop spent a lot of time with the Congregational Development Department this year, bringing us news each month of all the congregations, not only those funded through the diocesan budget. The diocese has continued many search processes, and faced new ones, which means interim placements, a lot of waiting and praying, and a lot of CHANGE. So it was important to find a way to address these issues, and to follow up on the good work begun by Alice Mann in 1999 in our diocese. Therefore we invited Susy Miller to come and focus on change and on inviting and welcoming new people into our parishes. We have delighted in our beginning work with The Rev. Canon Robert Fitzpatrick in his role as Canon Missioner.
- c. In our role of challenging, encouraging and supporting every congregation, we have worked together with other diocesan entities and staff so every community can truly become HEALTHY in order to fulfill the Great Commission. This work MUST continue.

II. WHAT ARE OUR GOALS FOR MINISTRY?

- 1. To provide support to each congregation
- a. Our members attended our regional gatherings for the Pre-Convention Meetings and LISTENED to the members of our congregations as a way to begin to "think outside the box" as challenged by our Bishop at the last Convention. We poured over the minutes of meetings we did not attend and learned that our focus needs to be on the ministry, NOT the money. As long as our meetings are finance driven, there is no energy to do the actual work of ministry. We need balance.
- b. Using the subsidy grant requests which are reviewed as submitted, questions were asked of each congregation for clarification and to explore ministry challenges. Each congregation faces challenges with administration. Most congregations do not have a parish secretary. Our Bishop's committees, wardens, treasurers and clerks are all volunteers. Often the priest files diocesan and national church reports and tries do it all alone. Others in the congregation may not see the need or how their gifts could be directed to support this effort. We need to find a way, as a diocese, to support the smaller congregations and free them up to do ministry, and not just meetings about ministry. It's a challenge for next year, and it goes far beyond the technical requests for support, which usually focus solely on the financial subsidy. We have to find ways to truly support and equip one another to do the work of ministry.

- 2. To continue liaison relationships with all aided congregations of the diocese
- a. Each congregation receiving subsidy was assigned to a liaison (a real live person) from the elected members of our Department to field questions, help with solutions and provide support. Some congregations took advantage of these relationships. Others did not.
- b. The clerks from each congregation were invited into the loop for better communication with the Bishop's committees for the first time this year. We asked for quarterly financial statements and minutes of Bishop's committee meetings so the liaison relationship had substance and so we could make quarterly reports to Council on the status of the congregations. This will reduce paperwork at the parish level, and hopefully increase communication, and accountability to Convention for the funds received.
- 3. To continue to create, develop, and implement educational opportunities for congregational development throughout the diocese, with other diocesan departments and committees, so that we may have stimulating interaction between congregations
- a. Co-sponsored Second Annual Stewardship Luncheon with Stewardship Committee We invited two representatives from each congregation in the diocese to participate, rather than holding our normal daylong meeting focused on budgets for the subsidized congregations alone. Lynette and Scotty Schaefer were keynote speakers and about 50 attended.
- b. Alice Ann Rice went to all congregations who invited her to share with us an exciting vision of stewardship.
- c. We sponsored nine registrations to be used by members of parishes and missions for the Hawaiian Islands Ministries' Conference Honolulu 2000 March 2-4, 2000, Hawai'i Convention Center
- d. Suzy Miller consultation August 19-23, 2000 co-sponsored with Evangelism "Welcoming Guests & Incorporating New Members" and "From Dream to Reality"; with follow-up gathering for those who have attended SU/SO with Suzy privately.
- e. We have provided consultations rather than visitations (Lot Lau has offered Senior Warden emeritus help to congregations. Sandy Leialoha has also offered her experience as a parish Treasurer); previously we visited every congregation subsidized in teams of three with diocesan staff as advocates.
- 4. <u>To explore, with the Commission on Ministry, new ways to support and mentor new clergy entering local congregations, including recent seminary graduates;</u>
- a. Working with the Bishop, we supported a graduating seminarian, and established a new part time position, from Program Planning funds.
- b. We established a mentoring network for this newly ordained person, with accountability to the Bishop.
- c. No mechanism for working with the Commission on Ministry was established
- 5. To explore new ways to share the gospel in North Kona. as a part of the Task Force established for that purpose.
- a. Although at the last Convention a resolution presented by the Hawaii Island Deanery was passed to set up a Task Force to study the planting of a new congregation in Kona, they haven't yet formed. The Rev. Carol Arney reported in July that they were waiting for the new Canon Missioner to get on board. He arrived and visited all the islands, participating in Susy Miller's consultation, in August. The Rev. John Millen represented the Department this summer in a meeting in Kona to get the conversation started and to review the demographics, the history of this vision, and to see Kona itself.

II. HOW DO WE SUPPORT THE MEMBERS AND CONGREGATIONS IN MINISTRY?

The challenge for 2001 and beyond is to make the structure match the need and provide the means for every member of our Church to say "The Episcopal Church in Hawai'i provides me with things I cannot find anywhere else in the world: Worship, which helps me focus on God; Fellowship which helps me face life's problems; Discipleship which helps to fortify my faith; Ministry opportunities which help me find my talents and use them; Evangelism which helps fulfill our mission; and the opportunity to be a good Steward of all that God has given me." We need to support such ministries in the diocese as the Priorities we identified earlier this year affirm. Support youth ministry. Support programs designed to reach out to students in our colleges and universities. Support the ministries that serve We would like to see every church support the diocesan budget, making possible a wealth of funds, some of which will be returned even to the larger and stronger churches, as they need support too in order to offer various ministries.

In a world, a culture, a church in which are undergoing a rapid transition into the post Christian era, we feel that there has never been a greater need for the Gospel to be shared and for the Church to make her presence felt in our communities and in our world. Increasingly, people throughout the world, when queried, "Who is Jesus Christ?" will tell you, "I don't know," or, "I've never heard of him," or perhaps, "Wasn't he some guy who lived a long time ago and did miracles and stuff..." How can they believe in Him of whom they have not heard? And how can they hear unless someone be sent. And not just ordained "someones." The church of our day is serving a population many of whom have never even heard the Gospel, let alone touched a Prayer Book. The needs and understandings of the people in our pews and in our pulpits are changing as we make the monumental shift from "ministry from the top down" to a shared ministry of all believers. We are at a crossroads, culturally, theologically, ecclesiologically, and soon. Many of us who have been ordained are experiencing a Church that is in such transition that it is not the Church we were prepared by our seminary training to serve. All of us in the pew are experiencing a rapidly changing church as well. All of us, lay and clergy, need continuing education and communication, among ourselves so that we might proclaim the Gospel in an effective way in our world.

FINANCE AND REAL ESTATE DEPARTMENT REPORT

- 1. Support development of a new budget process and work to integrate budget with overall diocesan strategic planning. Goals should drive the resource allocation rather than the process.
 - a. In support of this goal, the Finance and Real Estate Department proposed and implemented a new budget process, including a survey of congregations about their budget priorities, preconvention budget hearings which allowed more input into the formation of budget priorities and more numerous reviews by Council of revised budgets.
 - b. In retrospect, it appears that the process was too burdensome and complex, however, a number of priorities emerged which guided the formation of the budget.
- 2. Require a quarterly accounting form departments and programs not just status of funds but including activities supported and enabled. This information should be available for general diocesan dissemination as appropriate.
 - a. This was replaced by a schedule of reports by Council.
- 3. Continue with the implementation of audit assistance to all missions with a goal of 100% of missions meeting the review requirement this year. We have completed the audit (agreed upon procedures work) for most of the missions. The rest will soon be completed.
- 4. Continue to review the diocesan investment strategy and portfolio allocations and performance to insure continued income and protection of principal.
 - a. For those who would advocate removing a larger percentage of return from the portfolio, this year's results have been a cautionary tale. The extremely volatile performance of almost every sector of the economy and the much lower returns combined with a larger rate of withdrawal would have reduced the overall portfolio by a significant amount.
 - b. The Department has continued to review the returns provided by the portfolio and has recommended that we maintain our current asset allocations.
- 5. Provide a strategy and implementation of insurance deductibles on behalf of all diocesan congregations caused by the policy change from the CIC. The goal is to provide adequate protection for all facilities and minimize costs.

Earlier this year, our insurance carrier informed the members of the Finance and Real Estate Department that their policy of insuring our properties against loss by hurricane with a \$1000 deductible would be discontinued. The new deductible would be 5% of the total loss per occurrence. The total amount of exposure to loss under the new policy would be much larger than before. In an effort to reduce this risk, FRED instructed Aon Risk to seek bids from other carriers and to seek additional policies to "buy-down" the deductible amount to 2%. However, the resulting additional premium was unaffordable, representing a total increase in premium amount to the congregations and diocese of 17%.

The members of Finance and Real Estate, after much research and deliberation, proposed that the Diocese embark on a policy of becoming self-insured for the additional risk. Diocesan Council has restricted the Lindberg Revolving Fund as a reserve against these losses until other funding is secured for the prudent reserve.

The increase in deductible for our hurricane policy did result in a savings of \$40000 per year, which the Council voted to continue to collect and allocate to the prudent reserve, which is being created. The Finance and Real Estate is in the process of determining a recommendation to Council as to the appropriate total amount of the prudent reserve.

- 6. Complete the paydown of the First Hawaiian Bank loan EHH and manage general diocesan debt incurred on behalf of parishes and missions with a goal of reducing debt to congregations and thereby enabling parochial programs.
 - a. The First Hawaiian Bank covering EHH will be completed by Convention.
 - b. The Bishop will review the status of pending lawsuits in connection with EHH.
 - c. The diocese has a continuing obligation to repay monies borrowed from major gifts that were used in the repayment of the EHH obligation.
- 7. Genuinely address the concerns of those advocating a reduction in the Diocesan assessment by providing revenue projections based on a 23% assessment and related impacts on budget expenditures.
 - a. This was provided as a part of the budget process.

Additionally, our 1999 Diocesan Audit was excellent. There were no exceptions, no management letter.

NURTURE AND EDUCATION DEPARTMENT REPORT

Mission Statement: With God's help, the Nurture and Education Department pledges to provide ongoing support, encouragement, and resources to groups and committees engaged in ministries of nurture and education in the Diocese of Hawai'i so that all persons in our Diocese are proactively supported, no matter where they are on their spiritual journey, as they attempt to live into their baptismal covenant.

Goals:

- 1. Establish closer relationships with the ministries that fall in our jurisdiction and ensure that the various ministries have developed their own goals, objectives and mission statements.
- 2. Determine the needs of the ministries and help them secure the necessary training and resources to enhance their missions.
- 3. Provide for a higher level of accountability of the ministries as well as the Department to the Diocese.
- 4. Understand the needs of the congregations and individuals with respect to the ministries of Nurture and Education.
- 5. Encourage ministries to educate congregations and individuals about the ongoing scope of their work.

Accomplishments and Evaluation:

Defined the role of Departmental liaisons and assigned liaisons to each committee and ministry in our jurisdiction. Liaisons are a valuable method of keeping the lines of communication open between the department and the committees. We recognize the need to improve the liaison relationships.

Used the Hawaiian Church Chronicle as a vehicle of communication to publish at least one story in each issue about a ministry of Nurture and Education. Made use of the Diocesan Web Site as another source of communication and information. Web Site will continue to emerge as an important vehicle of communication as more people come on-line.

Conducted quarterly budget reviews of all line items in our program block. Instituted quarterly reports from committees to track expenses and activities. This is a new method to improve accountability. There is room for improvement.

Department members increased the Department's visibility by attending their respective deanery and preconvention budget meetings with the intent of helping to determine the needs and concerns of the congregations. We attended as many area meetings as we could. We published answers to the issues of Nurture and Education that were raised at all budget meetings, and encouraged other departments to do likewise.

Funding:

The following committees and ministries received Diocesan funding through the Nurture and Education program block in 2000: Christian Formation, Evangelism, Stewardship, Planned Giving, Hawai`i Episcopal Youth (HEY), Episcopal Ministry on Aging (EMOA), Campus Ministry, Episcopal Video Network, West Hawai`i Youth Ministry, Young Adult Ministry. In addition, funds were provided for new ministries including the Diocesan Men's Retreat and the Hawai`i Spiritual Directors Formation Program.

DIOCESAN TASK FORCE ON HIV/AIDS REPORT

The mission of the Diocesan Task Force on HIV/AIDS is to be a resource to the diocese and wider community by providing education, advocacy and a spiritual response for those living with or impacted by HIV/AIDS.

In 2000 the Committee continued to host healing liturgies bi-monthly during the months of Sept.-May. Attendance varied from 15-20 persons, who worshiped together then shared a meal and conversation.

Several committee members attended the National Episcopal AIDS Coalition conference in San Francisco. We learned that our emphasis on tending to the Spiritual and Emotional needs of persons living with HIV/AIDS is on the cutting edge of a response to HIV/AIDS today.

We served on the World AIDS Day Council, and helped to plan activities for that event in 1999. We continue to serve on that committee, and plan to host an ecumenical World AIDS Day service at the Cathedral on December 1 of 2000.

We were invited to the Big Island to share what's entailed in beginning a healing service and meal ministry.

On December 2 of this year we are sponsoring a Workshop on HIV/AIDS on behalf of the Episcopal Church in Hawaii. The workshop will take place at the Life Foundation, and will be facilitated by AIDS Educator, Richard Barton. We will advertise this event during convention, and hope that every congregation in the diocese will send at least one representative to the workshop.

During the course of the year we communicated our activities through a display at Diocesan Convention, clericus meetings, Church Chronicle (including a report on the NEAC Conference and another article soliciting specific responses from the congregations and individuals in the diocese). We mailed World AIDS Day information regarding scheduled activities throughout the State, red ribbons and prayer cards, to all the churches of the diocese. We also mailed a letter to congregations, clergy, known prayer and healing groups – such as the Order of St. Luke, and ECW presidents asking that they support our ministry, and all persons living with HIV/AIDS through prayer. We also advertise our events in the GLCC Newsletter and Advertiser, through the Cathedral's weekly ad.

ANTI-RACISM COMMITTEE REPORT

"The process of anti-racism must include the disestablishment of racism in all its manifestations. It is a lifelong process which must incorporate ongoing reflection, repentance, reconciliation and transformation." (National Dialogue on Anti-Racism Workbook)

The Anti-racism Committee maintains three goals: 1) recognizing racism, 2) creating awareness of racism, and 3) assisting the lay and clergy within the diocese in creating dialogue on racism. We continued to educate ourselves and to work toward regular communication and education throughout the diocese.

To achieve our goals of communication the committee held regular meetings November, February, May, August, October and provided information to the diocese through the Chronicle and the Bishop's monthly letter. Appreciating Diversity, Prejudice Reduction, and The Social Constructivist were presented at Emmanuel, Kailua, and St. Matthew's, Waimanalo with 13 participants. At the invitation of Christ Church, Kauai, 15 people participated in a weekly Lenten series using the dialogue format. At Good Shepherd, Maui, in May, the dialogues were met with small response. Zeny Cabading presented a session on awareness at the Lay Ministry Workshop, recounting her experience at a training session last year. The diocesan staff began the first of the dialogues in September and will continue in 2001. An introduction to the dialogue process and activities to promote awareness in our diocese are planned in a presentation to the clergy prior to Convention.

In our 3rd year, committee members George Lee and Sunia Utu joined veterans Zeny Cabading, Jane Ibara, and Cecilia Fordham. The committee is encouraged by the interest shown this year. We need to do more. We recognize that we need I) more committee members and 2) more trainers. Those are among the specific objectives for 2001.

One by one, we will widen the circle of inclusiveness.

DIOCESAN CHRISTIAN FORMATION COMMITTEE REPORT

Mission Statement: The Committee, in conjunction with other diocesan groups, will offer opportunities for the equipping of local congregational leaders.

Goals and Objectives:

I To facilitate a network of people of all ages willing to share their stories.

a. Identify leaders (including name, email address and phone); leaders of church school, youth group (adult & teen), lay adult education

This process has begun. Committee will follow up on a request for information reported in parochial reports for the year 2000. We are particularly interested in having email addresses.

b. Committee members will be assigned to facilitate an annual meeting of leaders in each deanery/region and will intentionally follow up by offering mentoring.

We do not yet have the number of people on the committee to be effective in this.

c. The Committee requests the Bishop to appoint at least one deanery/regional representative to this committee.

The Bishop has indicated a willingness to do so. We will make suggestions on the form that he recently distributed requesting new member suggestions.

II To provide resources for congregations and other diocesan groups.

a. Create a link to Diocesan web page which will list resources.

We have begun to identify videotape resources from the Episcopal Radio and TV Network that are available for use. We will link to the Diocesan Web page in 2001.

b. Identify current formation leaders to share their story in the Chronicle.

While we haven't shared stories, we have had regular articles in the Chronicle relating to education events and training as well as photos.

c. Advocate for children's ministry by distributing the Children's Charter.

We have placed an order for "Awake My Soul", which includes the Children's Charter and liturgical resources for children and adults. This will be sent to each congregation.

III To identify, publicize, and provide leadership training events

a. Partner with other groups in sponsoring education and formation.

We have begun planning with several other committees for "Spirituality: Bridging the Gap", a major conference on the spirituality of the generations on March 31, 2001. This conference will take the place of Cathedral Day for 2001.

- b. Cathedral Day 2000 will offer hands-on activities which will develop and showcase children's gifts. Cathedral Day was a great success this year, with increased numbers (143), congregations participating (20), and enthusiasm. Guest speaker Ernesto Medina and other speakers were well received. Hands-on workshops were reported to be the most popular of the event.
 - c. Send and fund committee members to national/international events so that they can serve the diocese as resource people.

We are providing scholarships to the National ALPHA conference which will be held in Hawaii next year.

IV To communicate and work with ministry groups beyond the Diocese of HI.

a. Send two people to Provincial and National education meetings.

The next event is in November. At least one person will attend.

b. Meet and work with nonepiscopal groups.

We have promoted a teacher training event through Hawaii Island Ministries.

COMPANION DIOCESE RELATIONSHIP COMMITTEE REPORT

The 31st Annual Meeting of the Diocese of Hawaii and the Annual Meeting of the Diocese of Okinawa in the fall of 1999 approved a three-year Companion Diocese Relationship with each other commencing January 1, 2000. Essential to this relationship is the weekly prayers in each church for each other.

Bishop Shoji Tani who delivered a sermon at the opening Eucharist of our 31st Convention, and his delegation from Okinawa were guests of our diocese. Thank you to the many host families, churches and schools who welcomed the visitors throughout their visit.

This past year, the committee has met regularly to discuss ideas for programs that may encourage the relationship. One project is to collate simple luncheon recipes from our churches that we can share with the Okinawa churches since they frequently have lunches after their services. We hope that this will enhance the connection between their congregations and ours. Myrtle Kaneshiro heads this project and will prepare the cookbook for presentation to the Diocese of Okinawa upon their 50th anniversary next year.

To increase the awareness of our diocesan relationship and to expose the young people to the Okinawan culture, the committee sponsored the Miyashiro Soho Kai who performed koto musical numbers and dances at Cathedral Day on May 6. Snapshots of this event were in the Hawaiian Chronicle.

Also in the Chronicle were pictures from the Okinawa delegation visit, an article from a former dean of the Cathedral in Okinawa and an article of the battle of Okinawa during World War II.

Preparation is being made for a youth group to visit Okinawa next summer and work on a mission project with the youth of the churches there. This will be a joint project with the Hawaii Episcopal Youth, and the Okinawa Diocese is enthused and hopes that this will be a rallying project for their young people. Meaningful contributions in Okinawa, spiritual growth, cultural understanding and friendships are hoped for this project.

A resolution is being introduced at the 32nd Annual Meeting of this diocese to congratulate the Okinawa Diocese upon their 50th anniversary in the year 2001.

Bishop and Mrs. Chang will be guests of Bishop Tani at the annual convention of the Diocese of Okinawa in November 2000.

DIOCESAN INSTITUTE REPORT

Our goals are to sponsor programs that provide continuing education for all of the baptized, as the educational arm of the Commission on Ministry, according to Title III Canon 2. Specifically, we have continued the Church Leadership Workshop and Sharing the Ministries Celebration, supported the liturgical functions of the Church by continuing Lay Eucharistic Minister training and Lay Reader training, provided the curriculum for Diocesan Institute classes, coordinated an event such as bringing a nationally known speaker to the diocese, explored ways of training spiritual directors, and explored whether or not to revise our deacon formation program. Part of our effort to accomplish these goals included a meeting with the Nurture and Education Committee in January, clarifying the fact that the Diocesan Institute is oriented to specific events and programs.

Our budget supports the EFM assessment and mentor training. While we continue programs of proven success, we remain flexible in dropping or postponing classes that draw little response. Diocesan Institute classes therefore were dropped/postponed in recent semesters due to lack of enrollment. The Sharing the Ministries Celebration in combination with Cathedral Day, in May, drew 150 attendees. A Lay Eucharistic Minister training, and retraining, to update and renew those people who have participated in this ministry for some time, is planned for October 14.

Training for spiritual directors was our priority at the beginning of this year. We saw this goal met through the efforts of a separate committee, which now has an ongoing program in place through the Sisters of Mercy of Burlingame. Interns participate from all of our islands except Molokai and the Big Island. 21 people have now begun their training.

We continue to explore the possibility of updating our deacon formation to comply with national standards, a subject that is currently being explored in a number of dioceses. Canon law already provides a basic framework of subjects requiring competency; we are exploring the work done in other places to determine how we may best bring candidates to this standard.

As a subgroup of the Commission on Ministry, we report to that body each month.

This year was not too different in that many of the churches did celebrate Age in Action Sunday by presenting lei's to all those 70+ years. The Rev. Hollis Wright of St. James, Kamuela delivered a homily on the gifts of wisdom in aging. The Rev. Gerhard Laun of St. Elizabeth's hosted a luncheon honoring their seniors. Great thanksgiving during the prayers for the seniors in our midst at all churches and then, there is the story of Age in true action at St. Mark's in Kapahulu. The following is shared with the permission of *The* Rev. Greg Johnson

Dear Pat.

Have a story for you regarding something that happened at the 0700 Mass at St. Mark's on "Age in Action" Sunday.

We had 22 parishioners attending our early worship service who were at least 70 years of age; one of whom had been weakened by an illness for which he had been taking medications that had some negative side-effects.

His wife told him he was too sick to come to church, but he decided to come anyway. He's a former Marine, who fought in battles like Iwo Jima, and wasn't going to give in to something he thought was relatively insignificant - at least compared to receiving the Holy Eucharist.

As it turned out, our faithful veteran passed out momentarily during the service when he tried to get back up on his feet after kneeling at the altar rail for a blessing. The beauty of this story is that there were 21 other seniors who were at the altar rail with him, some of whom caught him in their arms, so that he didn't break any bones or damage himself in any other way as a result of this sudden collapse. They stayed with him, surrounding him with their love and concern. It was both frightening and inspiring to witness.

When he regained consciousness, he still looked white as a sheet; but he also had an angelic look on his face: like he had been to heaven and back, finding himself in the arms of so many caring people.

He had come to church to receive Holy Communion and left, having received even more than he had anticipated. He was truly blessed; and so were we to have shared this unforgettable example of "age in action!"

ECUMENICAL RELATIONS REPORT

The most significant ecumenical progress of 1999 in the Episcopal Church was the approval of the "Common Mission Statement" at our Triennial Convention this summer. This agreement brings us into a sister church relationship with the Evangelical Lutheran Church in America. The ELCA already gave its approval to the document in 1998. The date for implementing the agreement is January 2001, and a joint commission from both Churches has been at work to develop the proper guidelines for smooth implementation.

As a diocese we will need to respond to the "Common Mission Statement" agreement by asking all parish clergy to study the document and educate their respective congregations about its practical application, to build ties with local ELCA Congregations, and to implement the agreement with ELCA congregations.

The Consultation of Church Union (COCU) has entered into a new relationship now called Churches Uniting in Christ. Seven of the nine member churches (African Methodist Episcopal, African Methodist Episcopal Zion, Disciples of Christ, Christian Methodist Episcopal of Christ, and United Methodist Church) approved two major ecumenical documents; namely COCU Consensus and Churches in Covenant Communion. The Presbyterians withheld full approval of the proposal while the Episcopal Church declared some major reservations and stated the Episcopal Church was "not ready to enter into covenant communion".

The recent document "Unus Christus" from Rome has to a significant degree damaged both the Christian ecumenical dialogue and interreligious dialogue among non-Christian communities. The core teaching of "Unus Christus" holds that the fullness of Christianity exists only in the Roman Catholic Church and that eventually all salvation has its roots in Roman Catholicism. Needless to say, many Roman Catholic scholars and faithful disagree with this position.

HAWAI'I EPISCOPAL PACIFIC ASIAMERICA MINISTRY (HEPAM) REPORT

HEPAM exists to strengthen and deepen the existing ministries in the Diocese and to enable and support new ministries involving Asiamerican Pacific Islanders. The committee maintains a close relationship with the National Church's *Episcopal Asiamerica Ministry* office, and through that office, supports maintaining relationships with congregations in Asia to share resources and support for those ministries.

In an attempt to strengthen the committee's relationship with itself, and to more clearly evaluate its mission, other Diocesan Committees or groups have been invited to share their vision and mission with us, discussions have taken places around ways in which HEPAM and these committees interface. Ms Cecelia Fordham, Chair of the Committee on Anti-Racism and the Rev. Pamela Junge, Chaplain at UH, Manoa, have been guests at our meetings.

With Bishop Chang's endorsement and support, the Committee sponsored the Pentecost Eve Service at St. Andrew's Cathedral, which this year included the Reception of the Rev. Randolph Albano and the Rev. Tancredo Pastores into the Episcopal Church from the Philippine Independent Church. The committee voted unanimously to donate the offering from that service for the work of the Committee of Native Hawaiian Ministry.

Ten members of the committee attended the National Episcopal Asiamerican Ministries consultation in Denver, Col., June 30-July 5. "Delegates" from across the US and the Philippians gathered to pray, share concerns and to speak to issues such as racism, community development, concerns about youth, dwindling resources and multi-cultural issues facing Asiamerican Episcopalians and their congregations.

My thanks to Bishop Chang for his support of this Ministry.

- 6. To develop lay leadership training.
- 7. To encourage and nurture Japanese American candidates for Holy Order.
- 8. To create awareness of and prevent racism.
- B. Ended our financial obligation to the Rev. Noriaki and Mrs. Ajuko Ueda.
- C. Hosted a dinner at the Mission House and invited all the churches involved in the Japanese marriage blessing. As a result of this gathering, we have published a brochure, which will be given to newlywed couples from Japan. The brochure is called, "Blessed By God's Love." The churches were also given a beautiful white satin guest book. The newly wed couple would sign their name and address, date of their blessing. Each church will send us the couple's name/address/date, and we shall send an anniversary or Christmas greeting.
- D. We wanted to be in touch with HEPAM so the Rev. Ernest Uno agreed to attend their meeting as friends of JAM.
- E. Our most recent project is called, "Talk Story." "Talk Story" is gathering testimonies so we may leave a history of Japanese American Episcopalians in Hawaii for the next generation. It will be taped on video and we plan to put it in the Diocesan archives.

COMMISSION ON NATIVE HAWAIIAN MINISTRY REPORT

Aloha ma ka inoa ko kakou Ho'ola a Kalahala, ka Haku 'o Iesu Kristo!

The Commission

The Commission is a nationally recognized ministry serving Province VIII and the Diocese of Hawai'i, for this year has been upon the request of Bishop Chang, to all commissions and committees, to review and reexamine our individual missions. With the change of chairmanship, we believe that this request has been fortuitous by providing us the opportunity develop a three year strategic plan. All meetings of the Commission have been dedicated to this initiative and a special retreat was held on the island of Kaua'i to provide the Commission with the environment and solitude to do so.

A revised mission statement was developed at the retreat with proposed goals and objections for implementation. It was proposed that these proposed goals and objects be first brought to the discernment of our Hawaiian constituency for review before being officially adopted. Also, a chronology of the Commission's history was submitted by the former chair, the Rev. Charles Hopkins and amended by the current chair, Malcolm Chun. This document is an important reference and reminder of where we have started from, how we have progressed and suggests the direction we are headed for.

This year also marked the admittance of the Commission has a recognized member of the Episcopal Commission on Indigenous Ministry, formerly known as Indian Ministry. It has taken the Commission several years to obtain this recognition and participation with other Native Americans of our Church. This Commission has three primary functions: to distribute block grants, to plan the annual Winter Talk gathering of Native Americans, and to participate in the Anglican Indigenous Network.

The Commission continues to be a participating member of the Anglican Indigenous Network (MN), a network comprised of native peoples of the Anglican communion in Australia, Canada, the United States, Aotearoa (New Zealand) and Hawai`i. The Network has received formal recognition from the Anglican Consultative Council (ACC), which has indicated it support to provide much need funding. The Network has begun to provide a voice, coordination of programs, especially theological education, and support for the ministry of native peoples of its member areas. Hawaii hosted the last gathering of the Network, on the island of Kaua`i, with tremendous support from this Diocese and the national Church. The next gathering is schedule for September 2001 in Cairns, Australia.

The completion of the updating of the Hawaiian translation of the four Gospels is nearly done. The anticipated new publication will included the diacritical or pronunciation markers and typographical corrections as well as an enlarged print. A smaller printed edition that would encompass the entire New Testament is now being considered as a future project. This revision may help non-native readers to more accurately read the text.

We maintain a small, bedroom office, located at the Mission House of St. Mark's Church in Kapahulu shared with our Study Board Program and Ks Papa Anaina Hawai`i o Kristo, our community of faith.

Native Ministry Study Board/Program

The Program has concentrated its efforts this year to support our postulant student. His continuous learning track enables him to attend a seminar forum at CDSP this past January and he continues his directive reading program. Having held a gathering of examiners last year and affirming their conclusions the board sought the consideration of the Commission to advance the status from postulant to candidate. This was approved and

the Commission has requested this of Bishop Chang. An official response is still pending.

The board has also under gone a leadership change with the departure of Professor Pua Hopkins. She has been replaced by Dr. L.A. Ha`aheo Guansan.

The Study Board also is represented on the board of the Institute of Indigenous Theological Training, a nationally Church funded theological training program for Native Americans. This year the Institute published the first volume of The First Peoples Theology Journal. Included were articles reflecting the diversity of its editorial board: Native America, Hawaii and Aotearoa (New Zealand). Copies of this publication are being sent to our constituency and other copies have been made available for distribution through the Diocese office. Copies have also been shared with the Native Hawaiian ministry of the United Church of Christ.

Province VIII

The Commission continues to assist in the development and support of a Native Hawaiian community in the Bay area of northern California. This community is centered at St. Philip's Church in San Jose. With funding provided under programs of Province VIII, we have been able to hold quarterly Hawaiian services and cultural workshops for this community. We have provided them with Hawaiian service books, Hawaiian Bibles and other related publications and materials. Two workshops were offered this year: one on traditional healing practices and the other on the Hawaiian articles contained in the *First Peoples Theology Journal*.

Ka Papa Anaina Hawai`i o Kristo

Our Community of Faith also had a change of leadership with the election of a new chapter now headed by the Rev. Charles Hopkins. With this change the finances of the community have been stabilized and the chapter is seeking to re-examine its mission, to increase its membership and to re-establish its activities under its rule of life.

Funding

Contrary to an earlier report in the budgetary request, The Commission receives its only funding under the Diocese of Hawaii. The Ministry Study Program changed it policy of charging course fees several years ago. All funds from Province VIII are used by the Native Hawaiian community in the Bay area. With the proposed budget cut of our 2001 request we will find it difficult to meet our obligation to attend as one of the members of Anglican Indigenous Network gathering in September, 2001 hosted by the Aboriginal members in Australia.

STEWARDSHIP COMMITTEE REPORT

The Stewardship Committee exists to serve as a resource to empower congregations and individuals within the diocese to strengthen their relationship with Jesus Christ, allow them to become aware of their role as God's stewards in this world, and empower them for congregational leadership.

The Stewardship Committee believes that God gives us a choice in how we use all of our resources.

- We live out of abundance, not scarcity
- Stewardship is the wise use of all that we possess time, talent and treasure
- The use of money has spiritual and material implications
- It is ineffective to simply give people more information about stewardship and expect that they will change their giving patterns
- Effective stewardship programs produce healthier churches, stronger leaders and a clearer mission

The Stewardship Committee held four major events in 2000.

- In January we sponsored a diocesan-wide poster contest based on the theme: Giving Discerning a New Way of Life. Every congregation and the Episcopal schools were invited participate. Eighty posters were submitted by 77 artists. All of the posters were sent to The Episcopal Network for Stewardship (TENS) to be displayed at General Convention.
- In February, a luncheon was held to **honor congregational leaders engaged in the ministry of stewardship**. Bishop Chang and The Rev. Lynette and Scotty Schaefer were speakers. The poster contest entries were on display at the luncheon and those in attendance selected local winners in each of seven categories. It is the tradition of the stewardship committee to give a symbolic memento to persons in attendance. The 2000 stewardship memento was a votive candleholder bearing an Ulu design, created by a member of Grace Church. The Congregation Development Department cosponsored the luncheon. **Fifty-three guests** attended the luncheon.
- In May and June the **annual RoadShow** visited each island. The focus of the RoadShow was to explore the use of money, its spiritual and material implications. Alice Anne Rice was the RoadShow facilitator. Over the course of a six-week period nearly **80 people attended** sessions in their own communities.
- In September a morning workshop (**Stewardship Tune-Up**) presented commitment campaign concepts. Calvary's music ministry set the tone for an uplifting morning. Bishop Chang welcomed the participants, who were then offered an overview of the elements of a commitment campaign, breakout groups and a stewardship video featuring The Rt. Rev William Burrill. In addition to members of the stewardship committee, Bill Lucas, The Rev. Morley Frech and The Rev. Peter Van Horne served as presenters. **Forty-seven people attended** the workshop. A booklet of stewardship sermons from our diocese was assembled and distributed at the workshop.

The Stewardship Committee is available to support congregations throughout the year. We sponsor TENS membership for each congregation; circulate a diocesan newsletter on an occasional basis, consult with congregations, and share our resources with any who ask. Stewardship oriented videos may be borrowed from the committee.

We are very pleased that our Brothers and Sisters in Christ from ELCA joined us for both the RoadShow and the Tune-Up.

The Stewardship Committee meets monthly throughout the year on the fourth Wednesday at noon. I extend my personal thanks to the committee members: The Rev. Randy Albano (St. Paul's), Ed Coughran (Calvary), Lot Lau (St. John's by the Sea), Charlene Pinao (Calvary), Nancy Ries (St. George's), Chan Rowe (Emmanuel), Beverly Van Horne (Emmanuel), and to Peter Pereira and Frank Embree, diocesan staff.
